- 1. Attended Special Town Council meeting (August 7).
- 2. Met with Town Manager on Town matters (8/8 w/Mayor; 8/14 w/Mayor; 8/15-Agenda setting mtg with Mayor; 8/22; 9/5- Agenda setting for October Council mtg with Mayor).
- 3. Attended Marin Local Agency Formation Commission (Marin LAFCO) meeting (Aug 10) The Commission approved: LAFCO Updated Fee Schedule; Executive Officer Employment Agreement for 3-year period. The Commission elected a new Chair Barbara Coler and Vice Chair Dennis Rodoni. Discussion of start time (changed to 6:30 PM) & change to Hybrid meetings (rather than all in-person meetings). Subsequent meeting as Chair, met with Executive Officer Fried re: upcoming meetings and workshop (Aug 21).
- 4. Attended Marin Wildfire Prevention Authority (MWPA) Board meeting (Aug 17) The Board approved: Election of Board President Julie McMillan & VP Rachel Kertz; Mill Valley to retain voting share at this time even though they have now consolidated fire with Southern Marin Fire (the Board agreed that a subcommittee would be formed over the next year to work on JPA amendments inc. voting share w/consolidations and other matters); issuance of an RFQ for Vegetation Mgt. Services so MWPA can enter into Master Services Agreement(s) and issue Task Orders for CORE work (save resources for member agencies; EO evaluation & compensation 2.5% merit + 3.5% COLA; 3.5% COLA for staff. Some updates: Chipper Day pickups started mid-May, so far 2,039 pickups w/ 6,347 cubic yards; Home Hardening and Veg Mgt Grant programs has \$800K total available 84 applications processed so far, great increase from last year; new FireWise liaison is John Poulson working for FireSafe Marin.
- 5. Attended MCE Clean Energy Board meeting (Aug 17) The Board approved: pause in the Deep Green pilot for default signups for new communities (due to unanticipated high costs of renewable energy and CAISO's curtailments of primarily wind & solar TB revisited in 2024 as short term energy market if

stabilizes) and also staff exploration of a new GHG free service offering) – customers can still opt up to Deep Green; Amendments to Operating Rules/Regs (note: Marin County, Tiburon & Fairfax were the original signatories in Dec 2008, w/in 180 days Belvedere, Mill Valley, San Rafael, Sausalito & San Anselmo signed on); Awarding the Climate Leadership Award to Assemblymember Damon Connolly; Reso accepting a DOE Renewable Energy Efficiency \$500K earmark to MCE (MCE providing \$500K match); deferring \$15M to the Operating Reserve Fund. CEO report highlights: CPUC awarded MCE \$158M for its Energy Efficiency programs for 2024-2031; Board Retreat is Sept 29 in San Rafael with tour of Solar One in Richmond after.

- 7. Attended Housing Subcommittee meetings with Mayor, Staff and Dyett & Bhatia (Aug 24 & Aug 30) discussed HCD's comments on Fairfax Housing Element & next steps for HE.
- 8. Met with Commission on Aging Fairfax Rep Amelie (Aug 24) Discuss Age Friendly Scorecard and older adult related issues.
- 9. Attended Town Council Closed Session meeting (Aug 29).
- 10. Marin County Mayors & Councilmembers (MCCMC) Legislative Committee () –Meeting was not held in August. MCCMC LEGISLATIVE COMMITTEE SCOPE OF ADVOCACY: Fiscal Protection: protect city revenues from state Local Control: support legislation that enhances local control of resources to provide services while supporting regional co-operation. Oppose unfunded mandates and preemption of local authority and control of land use Transportation Investment: promote stable transportation finance structure for state and local government. Multimodal, enhancing livable communities Housing/Land use: protect local government land use authority. Oppose punitive housing legislation, and legislation that restricts or reduces local discretion on land use decisions. Other legislation can be recommended to MCCMC at a regular meeting.

The measure is intended to create funding for building and preserving affordable housing. All housing created with these funds would be put towards deed-restricted affordable housing (in other words, housing that must legally meet affordability requirements for 55 years.)

August 27 — Attended EV and E-bike Show sponsored by Ride and Drive Clean. Ride and Drive Clean is a collaboration of nonprofit organizations, agencies, cities, schools, and businesses with a goal of greatly reducing carbon emissions by advancing the adoption of electric vehicles.
