- 3. Marin County Mayors & Councilmembers (MCCMC) Legislative Committee (Sep 18) The Committee met with Assemblymember Damon Connolly in addition to its regular meeting. Assemblymember Connolly stated he has 7 bills that are on their way to the Governor's desk (e.g., ban on flavored tobacco). He encouraged electees to reach out to him on legislative needs, budget asks, ideas for hearings and potentially changing regulations. Our CalCities lobbyist reported that there are 10 ballot items that are qualified for the November 2024 ballot thus far (it will be a long ballot) and 2 related to mental health for the March 2024 ballot. The legislature convened last Thursday close to midnight, will reconvene January 2024 - 900 bills were sent to the Governor, his deadline for signing or vetoing is October 14 – he has ~85% signing rate. Key housing bills sent were Weiner bills (SB 423 - extends SB 35 sunset and expands it to coastal areas; SB 4 - housing on church grounds). AB 1637 was sent to the Governor (requires all government to convert to ".gov" as their URLs; Dept. of Finance has an opposing position (as does MCCMC). Nancy Hall Bennett reported that Janelle Kellman of Sausalito will be named VP of the Calcities North Bay Division at their conference this week. MCCMC LEGISLATIVE COMMITTEE SCOPE OF ADVOCACY: Fiscal Protection: protect city revenues from state Local Control: support legislation that enhances local control of resources to provide services while supporting regional co-operation. Oppose unfunded mandates and preemption of local authority and control of land

use Transportation Investment: promote stable transportation finance structure for state and local government. Multimodal, enhancing livable communities Housing/Land use: protect local government land use authority. Oppose punitive housing legislation, and legislation that restricts or reduces local discretion on land use decisions. Other legislation can be recommended to MCCMC at a regular meeting.

Attended Marin Wildfire Prevention Authority (MWPA) Board meeting (Sep 21) The Board: approved a second amendment to the agreement with Fire Aside for development and ongoing maintenance of Defensible Space Inspection and Evaluation Software (DSI) for a new SaaS software program for the grant program (cost is \$14,000/year same as the prior program which is not meeting MWPA current needs); acknowledged the Environmental Compliance and Project Approval for Core Proposal "Treatment Method Augmentation for the San Rafael Zone Open Space Management and Evacuation Route Projects;" received a presentation on the Marin Regional Forest Health Strategy report from Danny Franco, National Parks Conservancy (the report was developed by a partnership of One Tam, MWPA and the Federated Indians of the Graton Rancheria). Updates: The 2023 season for the Chipper Day Program began in mid-May (ending mid-Nov) and has completed 2,841 pickups with 9,105 cubic yards of material removed thus far; Greater Ross Valley Shaded Fuel Break (inc. Fairfax) total will be 1,810 / 38 miles approximately 19-20 miles total (approx. 450 acres) completed to date; Resident Grants Program - to date, for every dollar spent by MWPA, it is estimated that ~\$8 is spent by residents (funding will run out by Oct/Nov, at which time the grants group will develop prioritizations for grant expenditure for the next season (e.g., replace vents to prevent embers going in the home over replacing windows). FireSafe Wildfire Watch "The Tragedy in Maui is a Warning for Marin" - see it here https://www.youtube.com/watch?v=51_fomP8Wq8. Points out the differences BTW Maui and Marin re: wildfire. Main takeaways are: 1) Marin has excellent coordinated and redundant alert and warning systems. 2) California State and Marin County have invested a lot to build an arsenal of resources that is ready to respond rapidly to wildfire. 3) We have an idea of WHEN major wildfires will occur. Catastrophic wildfires occur during Red Flag events with strong winds and low humidity. 4) To survive an evacuation, you must plan and prepare in advance so that you can receive alerts and leave quickly. All 3 participants agreed that you are safer evacuating in your car than on foot or bike. 5) Design and material affect how buildings burn.

This reward is related to cardiac arrest survival rates. The integration of hospital systems and pre-hospital care (EMS) has resulted in a vastly greater survival rate than what agencies were experiencing 20 years ago. b) Adopted updated agreements with Central Marin Fire Authority (CMFA), City of Larkspur, Marin County Fire Department (MCFD) and Ross Valley Fire Department (RVFD) and directed staff to execute agreement(s) with CMFA, City of Larkspur, MCFD, and RVFD—including. c) Discussed Tax revenue impacts related to California Community Housing Agency acquisition of 700 Lincoln Village Circle in Larkspur, also known as "Serenity at Larkspur". California Community Housing Agency (CalCHA) entered into a Joint Powers Authority with City of Larkspur. This JPA with the city allowed for a change in the tax structure, ultimately removing approximately \$40K in revenue for the RVPA. This is an unusual way of creating housing affordability. In this program, government agencies known as joint powers authorities, or JPAs, partner with private companies to purchase apartment buildings and lower the rent. The agencies say this works because, as the government, they don't need to pay property tax, allowing them to pass along that savings to tenants. However, some members of the Fairfax community read an article in the IJ about some possible unintended consequences of this type of acquisition that might require tenants in the affordable units to pay some of the lost tax revenue. *Fairfax does not have any housing of this type. *
