Hello Fairfax Councilmembers,

I am writing, solely on my on behalf as an individual resident of the Town, to urge this Council to do everything it can to implement and provide for the enforcement of the Rent Control and Just Cause ordinances as soon as possible. With regards to the substance of tonight's matter for consideration, it is long overdue for the town to create and implement a robust and comprehensive registry. To that end, I think the Town should both require registration by each landlord prior to their ability to petition for increase under the ordinance and proactively require registration of anyone renting out a home in the Town, and seek to register all such rentals.

The Town should avoid any option that limits registration to only those petitioning the Town. It is in the interest of the Town to have all such rentals registered. During discussion of these ordinances in the Town, we've heard reference to all of the unregistered essentially under-the-table rentals. I believe former Mayor Frank Egger once noted that the believed there to be 300 to 400 such rentals. The complaint was that those unregistered rentals would see yet one more regulation and decide that was the final straw under which the could no longer rent out housing (as opposed to all of the other laws and regulations governing renting out housing that already exist and they are presumably ignoring). But it brings up a serious concern, if those rental properties aren't registered with the town, those landlords are in essence stealing from the town and all of its residents. They are earning business income (the rent paid by the tenant), and not paying taxes to the town for operating such business in the Town. The Town and it's taxpayers are then subsidizing the costs of that landlord, their tenant gets all the benefit of use of Town infrastructure and other aspects of living here (rightfully so), it is a part of the value of such rental housing: you pay for location. The Landlord is then free-riding on the town, part of the value in rent they are being paid is attributable to the Town and what it spends Town funds on, that is one reason they should rightfully owe tax on that income. Other businesses operating in the town must pay license fees. There is no reasonable justification for exempting someone in the business of renting out even one housing unit should not also be subject to standard business license fees.

Again, please help to ensure all such rental housing is registered with the town. An appropriate fee to cover the cost of such registration system is absolutely the bare minimum of what is reasonable.
