SUBJECT:	Interview and consider appointment of applicants to the Open Space Committee and the Parks and Recreation Commission

RECOMMENDATIONS

- 1. Interview applicant John Reed for the Open Space Committee to fill a vacancy term to March 1, 2028, and make appointments as appropriate.
- 2. Interview applicants Chris Arnold and Susan Efros for the Parks and Recreation Commission, each for a three-year term, and make appointments as appropriate.

DISCUSSION

Open Space Committee

Currently, the Open Space Committee has a vacant position for a 4-year term. John Reed, a Fairfax resident, has applied for this position. John has attended at least one Committee meeting and has prior experience serving on other Town bodies, such as the Volunteer Committee and the Town Council.

The Fairfax Open Space Committee ("FOSC") is an advisory body to the Town Council. The Council <u>first</u> <u>established this committee in 2004</u>, dedicated to preserving open space in and around Fairfax with a membership of seven citizens.

FOSC assesses open space acquisition opportunities, raise funds and support within the community for such proposals. This Committee also serves as an advisory body in the consideration of long-term planning for the Town, and to review certain planning and development matters.

Parks and Recreation Commission

Presently, the Parks and Recreation Commission (PARC) has an open position with a term expiring on October 31, 2025. The applications being considered by the Council tonight for PARC membership are from two Fairfax residents, Chris Arnold and Susan Efros.

The PARC was established in 1988 as a Town Council-appointed Commission. The Commission consists of five members. PARC oversees the public parks and recommends and organizes events and activities for Fairfax residents.
