Project Description

Fairfax Town council formed a Racial Equity and Social Justice committee (RESJ) to examine issues of racial equity, social justice, systemic racial bias, and diversity in the town. As stated in the town council RESJ resolution, the facilitator will support the development of goals, objectives, and a work plan for the committee. In order to accomplish the items of the resolution, it will also be necessary for to build team capacity through the development of equity centered practices. The facilitator will use a model of *gradual release* which build the team capacity to hold the work of the committee. The *gradual release model* allows for the gradual release of committee work to move from the facilitator to committee members thereby reducing the facilitator hours over time.
