Mayor Goddard thanked all of the speakers. She opened the Town Council discussion of the formation of a Town Racial Equity and Social Justice (RESJ) Committee, and the

concept of the Racial Equity and Social Justice Committee forming a subcommittee to discuss Police Practices and Public Safety Budget/Service Alternatives.

Staff was directed to move forward immediately with the regular application and interview process, so as not to lose any time. Applications would be available as soon as possible in both Spanish and English, with the deadline to submit them at 5:00 pm on August 5th. A Special Council meeting to conduct interviews would be scheduled at 5 or 5:30pm on August 12th. Depending on the number of applications received, appointments to the Committee would occur on either August 12th or at the September 2nd regular meeting.

M/S, Coler/Reed, Motion to form Racial Equity and Social Justice (RESJ) Committee and to authorize the Committee to form a subcommittee to explore police practices, police budget and service alternatives; to appoint Vice Mayor Ackerman and Councilmember Hellman to the RESJ Committee; to be eligible applicants must be either a resident of the 94930 zip code area, or an owner or employee of a business with a commercial location (storefront) in Town; the regular interview process will be used on August 12th with applications due on August 5th; the Town will retain a professional facilitator and commit staff resources; updates will be provided to the Council by the two councilmembers on the Committee; and the Council will hold a joint meeting with the RESJ at a time to be determined.
