The purpose of this bond ordinance is to amend Bond Ordinance No. 2023-07 which was adopted to finance the costs associated with the improvements made for the renovation of the municipal building, including the police headquarters under the requirements dictated by the Department of Corrections. It remains within the expected budget for the total renovation.

This capital ordinance funds the improvements of our roads and the purchase of equipment and vehicles for municipal purposes based on our capital schedule.

Committee Member Reports:

Committeewoman Seiple reported that she was compiling a newsletter and requested that articles be submitted by the end of the month.

Committeewoman Tarby reported that Community Day was a "great success", described the event, and acknowledged Committeeman Repmann's efforts to coordinate the event in prior years. She further reported that the annual "Trunk or Treat" event would take place the last Friday in October at the Clinton Elks on Sidney Road.

Committeeman Repmann reported that a Department of Public Works (DPW) employee was taking classes to obtain certification as a Certified Public Works Manager (CPWM). He explained that this effort assists in the Township's succession plan for the Department of Public Works (DPW).

Comments from the Public:

Roy Emerson, 15 Landsdown Road, commented that Township Veterans had joined a team that would be rowing a boat across the Atlantic to promote veteran suicide awareness and requested that an article be placed in the Township newsletter.

Ingrid Taff, 41 Upper Kingtown Road, commented that she had attended the Land Use Board (LUB) meeting held on the online Zoom meeting application the prior evening, and indicated that the Township needed to provide hybrid or online Zoom meeting access in the New Municipal Building.

Elizabeth Basile, 16 Upper Kingtown Road, commented on topics mentioned at the prior evening's Land Use Board (LUB) meeting, specifically possible efforts beging made by Kingwood Township to open their municipality to cannabis businesses and a Franklin Township Referendum question for the next year regarding allowing cannabis businesses in the Township. She further questioned the Township Attorney regarding the involvement of applicants in the drafting of an ordinance. Mayor Homulak thanked Ms. Basile for her comments.
