FRANKLIN TOWNSHIP COMMITTEE/BOARD OF HEALTH WORK SESSION/REGULAR MEETING THURSDAY, OCTOBER 24, 2024

The meeting was called to order by Mayor Homulak at 7:00 pm. Mayor Homulak read the Open Public Meetings Act (OPMA) Statement and led the flag salute.

The purpose of this bond ordinance is to amend Bond Ordinance No. 2023-07 which was adopted to finance the costs associated with the improvements made for the renovation of the municipal building, including the police headquarters under the requirements dictated by the Department of Corrections. It remains within the expected budget for the total renovation.

Mayor Homulak briefly explained that the resolution further documents action taken by the Township Committee after the conclusion of the Executive Session at the prior meeting regarding acquiring an appraisal of the QVEMS property.

New Business:

1. Quakertown Fire Company Request – False Alarm Ordinance.

Deputy Mayor Donaruma explained that Quakertown Fire Company had responded to numerous false alarms in the past few years and was requesting an update to the Township's ordinance to address repeat offenders. Upon questioning by Committeeman Repmann, it was explained that the Fire District would be the enforcement authority but that the ordinance was required to be adopted into the Township Code Book. Upon discussion regarding drafting the ordinance, the Township Clerk reminded the Township Committee of the annual meeting schedule and introduction and adoption deadlines for municipal ordinances.

2. New Municipal Building - Tree Planting.

Committeewoman Tarby indicated that she had investigated the possibility of planting a tree at the New Municipal Building that could be decorated during holidays. She further indicated that she had located a vendor who would provide the tree for \$500. She explained that she had spoken with the Township Engineer regarding where to place the tree at the New Municipal Building, the species of tree appropriate for the property, and how to make sure the tree does not interfere with the new septic system. Committeewoman Seiple clarified that the cost of the tree would be a one-time cost of \$500. The Township Attorney and Mayor Homulak expressed legal concerns, explaining that the Township could not discriminate between holiday celebrations. Committeewoman Tarby explained that the tree would be utilized for tree lighting and further indicated that she had not yet priced out costs for decorations.

Committee Member Reports:

Committeewoman Tarby reported that the Township's "Trunk or Treat" event would be taking place the following day. Committeewoman Seiple explained that once participants had arrived, they had to remain until all the children had acquired their treats.

Committeeman Repmann provided a brief update on the status of the improvements being made to the New Municipal Building property, indicating that the outside improvements were nearing completion and that the Construction Department's concerns regarding the inside improvements were being addressed. He invited other Township Committee members to attend the December or January 78/22 Coalition Meeting with him so that he may provide introductions and hand off the responsibilities to the next Committee member.

Committeewoman Tarby provided a brief update on the County Recreation Grant, indicating that the County was "working on it".

Deputy Mayor Donaruma apologized for missing two meetings due to work obligations. He explained that while the first absence was anticipated, the second was unexpected. He provided a brief update on the efforts to address the Capoolong Creek Trail, indicating that the Environmental Commission had approved the inclusion of a trail group and that the next step was to work on insurance and the resolution.

Comments from the Public:

Frank Tota, 16 Upper Kingtown Road, commented on the prior meeting's referendum discussion and expressed his approval of the Township Committee's efforts at transparency. He further commented on the Franklin Township School referendum and expressed his disapproval of their efforts to inform the public.

Elizabeth Basile, 16 Upper Kingtown Road, questioned the type of tree that would be planted at the New Municipal Building. Committeewoman Tarby explained that the tree would be an evergreen tree but that the species had not yet been selected.
