 our tax payers money.

- 3. Discussion on Rogers Pond: Diane Burgess provided an update on Rogers Pond. At this point we have recommendations from companies, and are working with wetlands mitigation. Whatever we choose we will not spend township money to fix the area. We may use some funds for benches, picnic tables or signage. They are reaching out to some organizations such as the boy scouts to see if someone wanted to spearhead. Diane said that they will continue to apply for grants to get rid of the damn and clean up the area because to repair the dam is too expensive. Phil Koury asked if residents utilize the area. Diane said that there are residents that use the property. It was also used in the past for a variety of activities.

Committee Member Reports

- 1. Sebastian Donaruma reported that he will discuss police contract in executive session.
- 2. Diane Burgess reported:
 - DPW is working on taking down the snow fence
 - May is older american's month, we should recognize the seniors with a resolution in May. Catherine will take care of that.
 - Seniors are working on updating the veterans list and directory
 - We will be hosting the well testing again this year.
- 3. Phil Koury reported that at the land use board meeting they spoke about the Master plan.
 - Solar: Land Use board wants feedback from committee on their feelings toward roof
 mount vs. ground mount solar. Committee discussed concerns about roof mounts
 systems and fires in the homes. It is believed that the systems have a quick disconnect
 that is required to be on the systems when they are installed. The new systems are also
 lighter than the older systems so they can be removed easily in an emergency.
 - Marijuana and Hemp: Phil called around to see what other towns thoughts were. Phil
 stated that he told the land use board that the township committee is not taking a
 position on either and is waiting until the state makes its determinations.
- 4. Mike Homulak: Public Safety, he is working on some incentive programs to promote volunteering.

Officer Kevin Bollaro was present and informed the committee that the Fishing Derby would be held on April 13 this year. Catherine will put together a flyer for the event.
