ORDINANCE 2017-07 FRANKLIN TOWNSHIP HUNTERDON COUNTY, NEW JERSEY

ORDINANCE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF HUNTERDON, STATE OF NEW JERSEY TO AMEND, REVISE AND SUPPLEMENT CHAPTER 125, "VEHICLES AND TRAFFIC," OF THE CODE OF THE TOWNSHIP OF FRANKLIN TO CREATE ARTICLE X "COMMERCIAL VEHICLES,".

WHEREAS, the Committee of the Township of Franklin, County of Hunterdon, State of New Jersey, has determined that Chapter 125, "Vehicles and Traffic," of the Code of the Township of Franklin must be amended, revised, and supplemented to prohibit the parking of commercial trucks in residential zones.

NOW, THEREFORE, BE IT ORDAINED by the Committee of the Township of Franklin, County of Hunterdon, State of New Jersey that Chapter 125 "Vehicles and Traffic," of the Code of the Township of Franklin shall be amended, revised and supplemented as follows:

Section 1:

Article X. Commercial Trucks shall be created and shall include Sections §125-28 and §125-29. No other revisions are being made to this Chapter.

Section 2:

§ 125-28. Parking of certain trucks, vehicles and trailers prohibited.

No person shall park a commercial truck, tractor, trailer, semi-trailer or omnibus having a registered gross weights in excess of four tons upon any street within a residential zone except for the purpose of the pickup and delivery of materials. "Residential zone" shall include the Agricultural Residential (AR-7.0) and Rural Residential (RR-5.0) zones.

§ 125-29. Violations

Any person who violates any provision of this article shall, upon conviction thereof, be subject to the penalties set forth in Chapter 1, Article I, General Penalty. Each day that said violation continues shall be deemed a separate and distinct violation.

Section 3:

<u>Severability</u>. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder off this Ordinance shall not be affected thereby.

Section 4:

<u>Repealer.</u> Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 5:

<u>Effective Date.</u> This Ordinance shall take effect upon final passage and publication as provided by law.
