ORDINANCE NO. 2019-3

AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT CHAPTER 75 "POLICE DEPARTMENT," ARTICLE II "ESTABLISHMENT AND ORGANIZATION," SECTION 5 "AUTHORITY; ORGANIZATION," SUBSECTION A "ORGANIZATION," OF THE TOWNSHIP OF FRANKLIN, HUNTERDON COUNTY, NEW JERSEY TO CREATE A CAPTAIN POSITION.

WHEREAS, the Township Committee of the Township of Franklin wishes to create the position of Captain in the Organization of the Police Department; and

NOW, THEREFORE, BE IT ORDAINED by the Governing Body of the Township of Franklin, County of Hunterdon, State of New Jersey that Chapter 75, "Police Department," Article II "Establishment and Organization," Section 5 "Authority; Organization," Subsection A "Organization" of the Code of Franklin Township shall be amended as follows:

Section 1.

§75-5(A) shall be deleted in its entirety and replaced as follows:

A. Organization.

- (1) The Police Department shall consist of the following officers and men, whose offices and positions are hereby created and continued:
 - (a) Captain (1)
 - (b) Lieutenant (1)
 - (c) Sergeant (1)
 - (d) Patrolman (6)
- (2) Nothing herein shall require the Township to fill any or all designated positions.

Section 2:

All other sections shall remain unchanged.

Section 3:

<u>Severability</u>. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder off this Ordinance shall not be affected thereby.

Section 4. Repealer.

Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 5. Effective Date.

Adopted 3/28/19

This Ordinance shall take effect upon final passage and publication.
