**RESOLUTION 2017 – 43**

Approving Renewal of Class C Liquor License 1010 33 001 003

**WHEREAS**, the Clinton Lodge #2434 Benevolent and Protective Order of Elks has applied to the Franklin Township Committee as the issuing authority for the renewal of its Class C Liquor License held by it since on or about October 3, 1980, on premises in the Township of Franklin located on Sidney Road and Lower Landsdown Road known as Tax Lot 1, Block 14; and

**WHEREAS**, the Township Committee of the Township of Franklin, County of Hunterdon, State of New Jersey has considered the application at a public meeting on June 22, 2017 at the Township Municipal Building, Sidney Road, pursuant to Notice duly given.


**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Franklin, County of Hunterdon, State of New Jersey, at a meeting assembled, that pursuant to the foregoing the renewal of said Class C Liquor License to Clinton Lodge #2434 Benevolent and Protective Order of Elks for the described premises is hereby approved subject to the following conditions:

1. That when public events are permitted by the applicant on its grounds on said premises located outside its bar and tavern building, that they be allowed only between the hours of 12:00 Noon and 8:30 P.M., Sunday through Thursday, and the hours of 12:00 Noon and 9:00 P.M., Friday and Saturday, with the exception of the morning Flag Day Ceremony.
2. That during such outside public events at which alcoholic beverages are dispensed and/or consumed, the applicant shall give the Lieutenant of the Township of Franklin Police Department at least two (2) weeks prior notice of the event, as well as all details involving the compliance with the conditions of this Resolution.


3. That all such outside public events located on the applicant's premises at which alcoholic beverages are dispensed and/or consumed, the applicant and licensee shall provide to the Township of Franklin's Lieutenant a list of individuals which comprise the following number of police officers and on-site supervisors during the scheduled hours of attendance based on anticipated attendance, which must be approved by the Lieutenant.
