**RESOLUTION RECOGNIZING SEPTEMBER AS  
CLEAN COMMUNITIES MONTH AND DESIGNATING SEPTEMBER 28, 2019  
AS FRANKLIN TOWNSHIP CLEAN COMMUNITY DAY.**

**WHEREAS**, the New Jersey Clean Communities is a statewide comprehensive litter abatement program providing municipal funding to support local efforts to clean public lands and promote public education to reduce litter; and

**WHEREAS**, the Clean Communities program requires municipalities receiving funding to implement litter abatement programs that incorporate the elements of cleanup, enforcement and education; and

**WHEREAS**, the Township Committee has determined that it is in the best interests of the general welfare of the Township to promote the participation of residents of the community in that process; and

**WHEREAS**, in the past the Township has promoted the Clean Communities program through road signs, clean up events and Township employee advertisement; and

**WHEREAS**, the Township Committee wishes to do more to publicly recognize the Clean Communities program and bring the community together to celebrate this beautiful and pristine community; and

**WHEREAS**, the Township wishes to name the month of September Clean Communities Month and encourage all residents to do their part in their homes and in the community to reduce litter in Franklin and educate their friends and neighbors as to ways everyone can do their part; and


**WHEREAS**, the Township of Franklin wishes to host a community event to help culminate Clean Communities Month and help further spread awareness of the Clean Communities program; and



**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Franklin, County of Hunterdon, as follows:

2. The Franklin Township Committee invites all Township residents, employees, professionals, volunteers, and their families to join together to celebrate the pristine and rural character of Franklin Township.


