BE IT ORDAINED by the Township Committee of the Township of Franklin, County of Hunterdon, State of New Jersey as follows:

Section 1. The following street has been dedicated to the Township of Franklin by the making and filing of maps is hereby accepted as a public street:

Quaker Ridge Court as shown on Tax Map Sheet listed below;

- <u>Section 2.</u> The following is a map on which the foregoing street is shown:
- (1) "Final Plat Wellington Ridge, Block 29, Lots 33 and 57, Franklin Township, Hunterdon County, New Jersey" as prepared by Van Cleef Engineering Associates; and
- <u>Section 3</u>. This Ordinance shall become effective twenty (20) days after final passage, adoption and publication according to law.

Section 4.

<u>Severability</u>. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

Section 5.

Repealer. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 6.

<u>Effective Date.</u> This Ordinance shall take effect upon final passage and publication as provided by law.
