Department Head/Subcommittee Reports

Finance, Administration, Insurance, HR/Benefits: Blew & Soloway

Discussion: 2016 salaries for non-contract personnel. Committee Member Repmann asked that this item be placed on the agenda for possible action since funds have been budgeted for an increase. The percentage needs to be determined and it will be retroactive to January 1st. If any salaries fall outside the maximum range as per the salary ordinance, amendments will need to be made. The CFO will prepare a spreadsheet with salary increases ranging from one half of one percent to two percent for the Committee to review.

Public Safety (PD, Fire, EMS, OEM, Court, Health): Darocha & Fania

Lt. Timothy Snyder reported on a very successful drill held at the Franklin Township School. Much positive feedback on this was received. Lt. Snyder and Officer Santoro also participated in a County Pistol Shoot at the range. Officer Santoro finishing third with first and second place taken by someone from the FBI squad and State Police Officer. Committee Member Fania asked about the posting of speed limit signs and Lt. Snyder responded that the DPW posts signs as per municipal ordinances.

One bid for the Dodge Durango was received and opened at this meeting.

Department of Public Works: Repmann & Fania

Committee Member Repmann reported that the 2007 Ford Mason Dump truck needs repairs to be done in the amount of about \$8,000.00. Funds in the amount of \$45,000.00 are in the DPW budget. This vehicle is used on a daily basis and Alan is recommending going forward with the repair.

Alan Dilley and the Municipal Engineer also walked the Spring Hill Road property owned by Barbara Bezpa to review the drainage issue brought to the township's attention by the Bezpas and we are awaiting the engineer's report. At the same time, Twins Court was inspected for some outstanding issues with the development.

The Committee is also in receipt of Alan's monthly report regarding DPW activities. A final 2016 household cleanup day is scheduled for October 1st.

The Committee briefly discussed a grant available for trail clean up.

George Reichert will be contacted for follow up information on 1046 Croton Road. Some cleanup of the property has been done.

 Land Use (Land Use Board, Open Space, Planning, Zoning, Construction, Environmental: Soloway & Darocha

The Committee discussed the ordinance prepared by the Municipal Attorney for the Fire District and "Fire Prevention" fees and requirements. There was some discussion about the red light installation for visual notification and it was decided that the ordinance would be introduced to remove this requirement and can possibly be revisited at another time. Committee Member Jim Fania thought it would be easier for either new construction or a new tenant to budget for the funds necessary for the red light installation while current owners/tenants may not have funds for this. Mike Homulak, President of the Quakertown Fire Company, was okay with deleting this at this time and moving forward on the other issues: Knox Box installation and fees. The red light would make it easily visible for any fire company and/or emergency unit to immediately locate the hook up for the water source for fighting a fire. Mayor Soloway offered to contact the Franklin Township School and the Hampton Inn to see whether or not they would be able to do the install voluntarily.

Comments from the public: At this time Francis Goger, Bethlehem Township member of the North Hunterdon-Voorhees High School Board of Education requested the Township Committee consider adopting a resolution in support of the referendum for a \$9.7 million dollar bond issue on the November 8 ballot. He outlined the need for this bond citing repairs to both Voorhees and North Hunterdon schools. The school will be debt free at the end of this year. Thirty percent matching funds from the State are available for this referendum. The school has taken care of other State grants to do some other repairs needed.

Mike Homulak provided a copy of the Fire District's 2015 Audit report which is on file in the Clerk's Office.

Comments from the Committee on non-agenda items and any other business: Committee Member Fania reported on the possibility of employing a new Zoning Officer. Individual will be available on Wednesday evenings for two hours: would like one-half hour for paperwork and one and one-half hours for the public. Inspections can be done on her lunch break from another municipality where she is

currently employed. Looking at a start date of October 1st and Mr. Fania will speak with George Reichert about a transition period.
