HUNTERDON COUNTY PLAN PRESENTATION

Various committees had been formed to promote the economic future of the County and the long term goals. Detailed information (attached to these minutes) was provided to the Township Committee regarding population, median ages and persons in household, change in housing demands, promoting the County brand and tourism, encourage opportunities to attract people to work and live in the area, encourage business retention and expansion and overall attracting businesses.

Public Safety (Police, Fire, EMS, OEM, Court, Health): Darocha & Fania

The Mayor called for Lt. Timothy Snyder to give his report at this time.

Lt. Timothy Snyder has already provided the Township Committee with a copy of his monthly report and presented same on police activities: arrests, motor vehicle accidents, investigations, assist other police departments, etc. He also reported on providing police patrols at the fire company on Election Day. The County had requested municipalities to have some police presence at various times during the day. One police officer is still out sick due to an injury and expected to return either February or March. This has resulted in some overtime but not much. The department has a procedure in place for various officers to retrieve messages from the new phone system recently installed.

Return to Admin/Finance Matters

Committee Member Craig Repmann reported that Alan Dilley is working on the partition between the Construction and Tax Office. Project is under budget. Jean Bahlman has requested authorization to purchase a safe for security purposes to hold cash payments for taxes. Cost would be between \$500 - \$700.

No additional meeting is scheduled for November due to the league convention and the Thanksgiving holiday. If a meeting is necessary, proper notice will be given. The Committee will meet next on December 8 and will decide on the year end meeting date.

The Committee discussed the Holiday Party for employees and volunteers. Plans are underway to have it at the Grand Colonial and several dates are being looked into. Committee Member Repmann would like to see the employees and volunteers thanked for their service at a community event and making it more inclusive. He also suggested holding it as a catered affair at the QFC and making a donation to them. This will be reconsidered next year.
