Guest Speaker Javier Guardo, Planet Civic: Mr. Guardo made a presentation to the Township Committee on this online platform for civic engagement where elected officials and township residents can collectively and constructively set the priorities for their townships. Service would be only accessible to Franklin Township residents. Mr. Guardo commented on the different modules and provided written information regarding this service and it is being made a part of these official minutes. Platform options: only Committee would be able to post proposals/comments and residents can only vote for or against; or Committee would post proposals and residents can vote and post non-anonymous comments; or Committee can post proposals and residents would be able to vote and post "citizen initiatives" and non-anonymous comments. Planet Civic would verify those residents signing up for the service. Verification is for individual resident and not all those in a household. Annual fee to the township for this platform: \$499.00,

• Public Safety (PD, Fire, EMS, OEM, Court, Health): Darocha & Blew

An ordinance amending fire safety fees will be tabled to 2018 for first reading and introduction.

Motion to authorize the Mayor and/or Deputy Mayor to sign the form to support the Hunterdon County Educational Services Commission processing expenditures for all five municipal alliance consortiums thus removing this responsibility from the individual municipalities.

Matt Papenfuhs, Deputy Chief of EMS, provided Township Committee with his July and August, 2017 reports and highlighted some of the incidents and events of the fire company. He also reported on the fire company now bottling and selling their barbeque sauce. It's available at Cervenka's and in a couple of other areas right now. Dagone Emerson is receiving the Statewide EMS responder award tomorrow night in Atlantic City. This for his actions at the scene of a fatal accident on Pittstown Road.

Department of Public Works: Repmann & Darocha

The Township Committee discussed replacing locks in the Police Department. Looking into keypad for three doors but it may prove to be too costly (\$500 - \$600 per lock). Matt Papenfuhs asked the status of his request to purchase fuel through the township's DPW location for the EMS vehicles. Deputy Mayor Darocha asked Matt to provide a report to the Committee on the cost savings and the amount of fuel they anticipate purchasing.

reorganization meeting. The Municipal Clerk also reminded the Committee of a bill received for an applicant where the escrow fees were waived.

Community, Business, School, Recreation, Seniors: Repmann & Blew

Committee Member Repmann reported on basketball starting next month. He also said he was approached by the Chairman about giving a Recreation Committee member a gift upon leaving. There was some discussion about how long-term volunteers were recognized in the past; a resolution of appreciation. There was concern about setting precedent by providing gifts to volunteers. It was suggested that criteria be established if a monetary gift is to be given to a volunteer.

Motion to provide a gift in an amount not to exceed \$50.00 to be given to a Board or Committee volunteer that leaves office after providing 10 years of service. An award would be given only upon the recommendation of the Chairman of any Board or Committee.
