MINUTES FRANKLIN TOWNSHIP COMMITTEE WORK SESSION THURSDAY, DECEMBER 14, 2017 7:30 P.M.

The Franklin Township Committee held a work session at **7:30 P.M., Thursday, December 14, 2017** at the Municipal Building. This meeting has been properly noticed in accordance with the Open Public Meetings Act.

Comments from the public on agenda items: Lora Jones, Open Space Advisory Committee, addressed a number of items on the agenda: Millnar, Foster, Grow-A-Row, Hope Hill and banking County Open Space Trust Funds. Committee Member Diane Burgess asked if there was a cost benefit analysis for the Grow-A-Row proposed purchase. She would like to see an analysis done on proposed development of the site vs. farmland preservation. Approximately 28% of the township is currently preserved and the township is about 1,600 acres shy of their 30% goal. The Master Plan is currently scheduled for review and this is an area that the Land Use Board needs to address. Lora Jones said the land values in Delaware Township are higher than Franklin's because of land preservation. Deputy Mayor commented on no growth in the township and county. The County has expressed their concern about this and looking to see about promoting agri-tourism. Committee Member Soloway commented on having met with someone with the county's economic development and strategic development committee and learned of someone looking for a farm to put in a still with a tasting room. The proposed Grow-A-Row site on Pittstown Road would be a perfect location for such an enterprise. Lora will send all Committee Members a copy of the PIG report being sent in tomorrow to the County.

Emerald Ash Borer: Committee Member Soloway attended a County meeting on this topic. It is anticipated that In 10 years the township could see devastation of its ash trees. The Municipal Attorney has reached out to the municipal insurance agent for recommendations and sample ordinances for forestry services. Cranford has one that our attorney will review. The township must have a forestry management plan in order to apply for grants. It was suggested we reach out to the County to see if we could share services for a Certified Forester. The NJDEP website also has a list of certified individuals. Mr. Spanner in the township is also a Certified Forester. The Municipal Attorney commented on the individuals making up a committee for forestry management and training required. CEUs would also be required of anyone core trained. The attorney will send a link to the Committee for the details on this matter.

The DPW has ordered salt in settlement of the Mid American claim of the Morris County Cooperative. The recycling notice is posted on the website and Committee Member Diane Burgess spoke to the Tax Collector and Tax Assessor to provide a new list of residents in order to complete the mailing of the

notice. Ms. Burgess will also request a voter registration list to review for township renters. The women's restroom toilet has been repaired.

Grow-A-Row: This property was discussed earlier and Lora Jones asked if she should move forward with preservation. Some members are uncertain because of possible interest in agri-tourism and this being a prime spot for such an enterprise. They also cited a need for ratables in the township. The Committee also commented on the change in economics and no growth in the county or township. Millenials are staying in cities and that's where the growth and development are occurring. Kindergarten class is at only 10 students enrolled and student population has generally declined at the Franklin Township School. Deputy Mayor Darocha also questioned why we would consider using public funds for the purchase by Grow-A-Row. There is no water or sewer service at the location either. There was discussion about an exception area should the parcel be preserved and the township should let the County know the size of an exception area they would like should applicant appear before the Ag Board.

Committee Member Diane Burgess displayed the **Sustainable New Jersey** plaque with another tag for the recertification and bronze award to the township.

Committee Member Susan Soloway commented on the Land Use Board planning to focus on speakers at their work session meetings in 2018 and holding more regular meetings. They will be re-examining the Master Plan and reviewing stormwater/detention basin regulations as part of the review.

Community, Business, School, Recreation, Seniors: Repmann & Blew

Committee Member Craig Repmann reported on the Recreation Committee basketball being in full session. A game is scheduled for Saturday, 10 a.m. to 2 p.m. for players in 3rd through 8th grades. Mr. Repmann is also trying to organize a food drive at Shop Rite with several groups - PTA, Boy Scouts, Police Department. Looking at conducting something in January, 2018.
