For His Service and Life-Long Dedication to the Township of Franklin November 28, 1927 to March 25, 2020

WHEREAS, August Wilhelm Knispel was born on November 28, 1927 in the Township of Franklin, to August and Caroline Hunt Knispel; and

WHEREAS, August Wilhelm Knispel and his family were active farmers in the Township of Franklin beginning in 1928 and maintained a dairy business in the Township of Franklin until 1998; and

WHEREAS, August Wilhelm Knispel served his profession, the community and his church for over 40 years; and

WHEREAS, August Wilhelm Knispel was elected to, appointed to or joined most of the available governmental and civic organizations, committees and subcommittees in the township, county and his dairy profession, and was selected as chair for most of those groups; and

WHEREAS, August Wilhelm Knispel was elected to the Franklin Township Committee from 1964 to 1997 and served as Mayor eleven times; and

WHEREAS, August Wilhelm Knispel became Franklin Township's only resident inducted into the New Jersey Elected Officials Hall of Fame; and

WHEREAS, August Wilhelm Knispel was known to be an imaginative, fair and courteous leader, focused on protecting the township's soils and water quality and on keeping the community rural and beautiful; and

WHEREAS, a monument was erected in front of the Franklin Township Municipal Building and unveiled on July 22^{nd} , 2006 to honor August Wilhelm Knispel's lifetime of service to Franklin Township; and

WHEREAS, the Committee, upon hearing of his passing on March 25, 2020, wishes to once again honor August Wilhelm Knispel's lifetime of service; and

WHEREAS, this Committee does hereby confer upon

its highest commendation and special thanks for the manner in which he had lived his life and his life-long kindness and dedication to the residents of the Township of Franklin.
