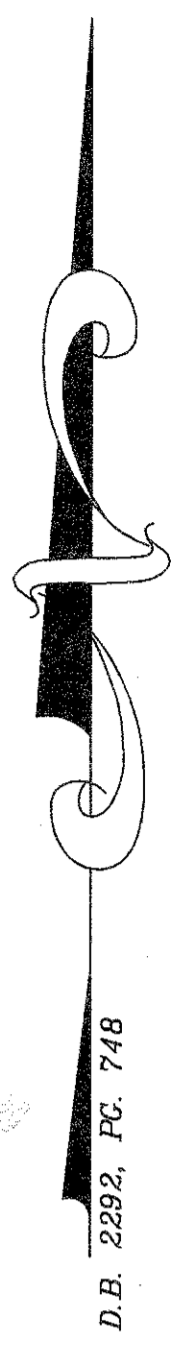
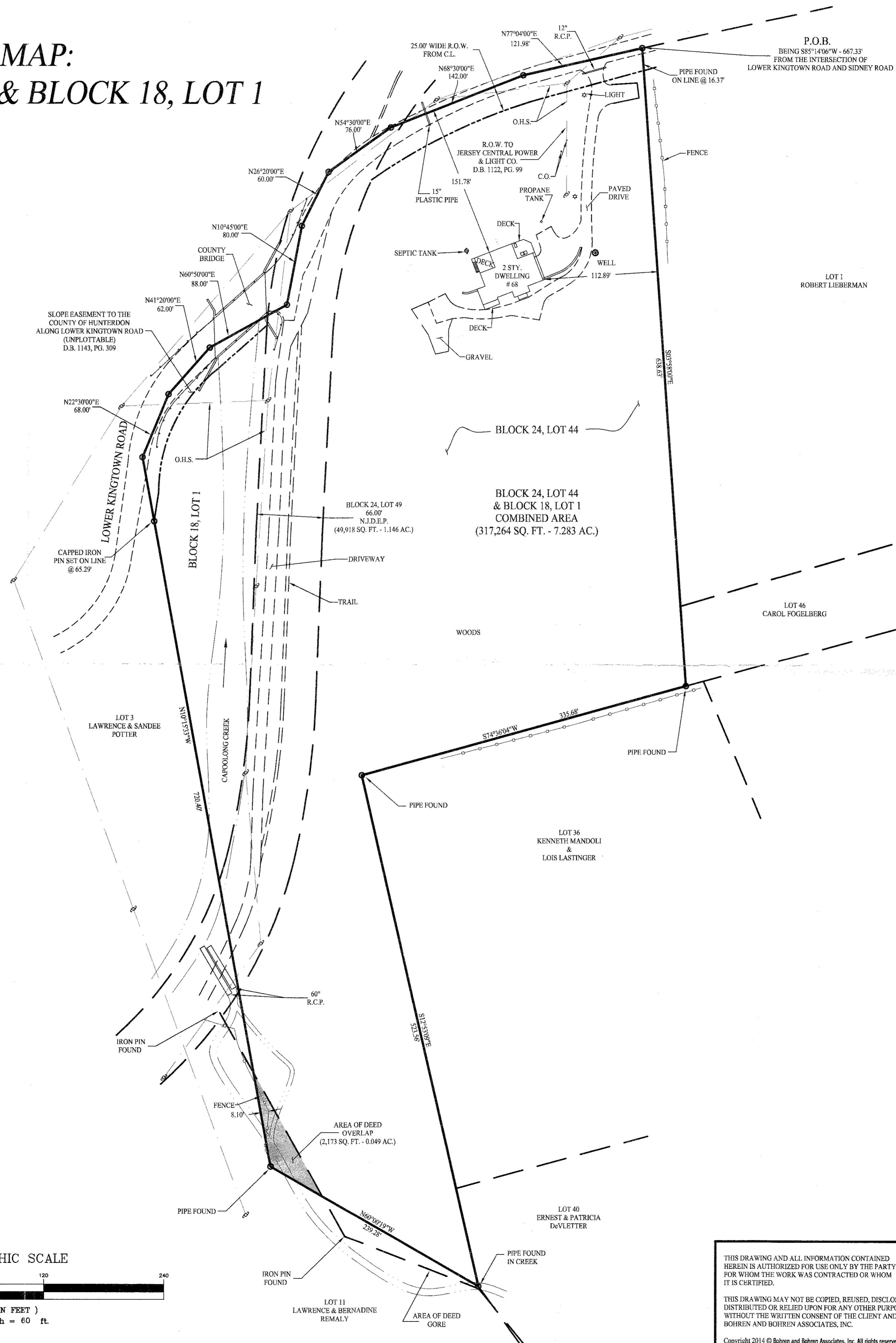
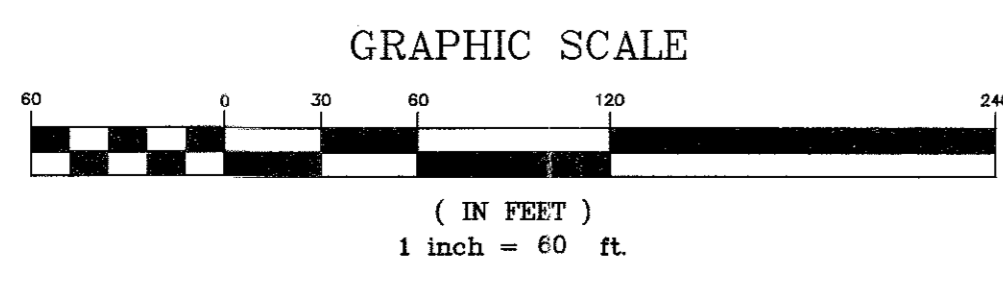


# FRANKLIN TOWNSHIP TAX MAP: SHEET 4, BLOCK 24, LOT 44 & BLOCK 18, LOT 1
