**TOWNSHIP OF FRANKLIN, HUNTERDON COUNTY
BIDS FOR ROAD MAINTENANCE AND MATERIALS**

WHEREAS, bids for road maintenance and materials were received on May 13, 2021 as part of the joint bid for Delaware, Franklin and Kingwood Townships; and

WHEREAS, only one bid was received for emulsified asphalt as follows:

WHEREAS, Franklin Township does not use emulsified asphalt and therefore they wish to reject the one bid received; and

WHEREAS, the Township did not receive bids for any of the other materials that it sought bids for; and

WHEREAS, the Township Committee of the Township of Franklin, County of Hunterdon and State of New Jersey that pursuant to Section VIII of the Bid Specifications for 2020, the Franklin Township Committee is exercising its option to extend the contracts with Stavola for an additional 12 months, for the year 2021, based on the same terms and conditions set forth in the 2020 bid specification; and

WHEREAS, DPW Supervisor Alan Dilley contacted Stavola who confirmed that they would extend the 2020 contract for up to 12 months; and

WHEREAS, Asphalt and fuel price adjustments will be made in accordance with the NJDOT standards; and

WHEREAS, attached to pricing list from Stavola with the price adjustments for 2021; and


WHEREAS, the DPW Supervisor be and is hereby directed to sign for and on its behalf the contract extension in the prescribed form for said maintenance work and material; and





Thank you for the opportunity to quote your project. The Quote Expiration Date is listed above. Prices contained in this quote will be effective through the Pricing Expire Date upon receipt of this quote signed by both parties. Asphalt will be adjusted for both AC & fuel indices. Both indices are noted on the top of this quote. The AC Index Adjustment will be calculated based on the beginning index and the index at the time of shipping. The difference between the two numbers will be multiplied by the AC content in the mix design and the unit price will be adjusted accordingly. The Fuel Index Adjustment will be calculated based on the beginning index & the index at the time of shipping. The difference will be multiplied by 2.5 gallons and the unit price will be adjusted accordingly. All stone haul rates are subject to fuel surcharges based on a starting index of \$2.50/gallon and will be adjusted 5% for each 50 cents fluctuation based on the published NJ Fuel Price Index. Any product or price discrepancy must be filed within ten business days of the invoice date. All material prices and haul rates are subject to a minimum annual increase of 5% per year. Asphalt plant operating hours are 7:00 AM to 3:30 PM, Monday thru Friday weather permitting. There will be a premium charge assessed if we are required to extend our hours beyond regular operating hours. Any bonuses pertaining to material performance will be credited to the account of the Stavola Asphalt Company. Material subject to availability.
