## **Staff Administrative Reports:**

**Police:** Captain Snyder reported on the June monthly activities of the Police Department, specifying background investigations, arrests, motor vehicle warnings, tickets, accidents, radio calls, animal complaints, property checks, and others. Captain Snyder expressed his appreciation for Committeeman Homulak's acknowledgement at the June 24<sup>th</sup> Town Committee Meeting, of Officer Caccavale's successful deployment of Narcan and briefly described the circumstances of the event. The Committee expressed their appreciation for the Police Department.

Administrative: The Township Clerk indicated that she did not have anything additional to report.

**OEM**: George Reichert reported on the JCP&L efforts to prepare for Tropical Storm Elsa.

Board of Health: None.

# **Old Business:**

1. Discussion: Township Planner's Analysis of Cannabis Implementation into the Current Zoning Ordinance.

Mayor Koury explained that he had requested that the discussion item remain on the agenda but would hold off on discussion until the next meeting.

2. Property Purchase – 43 Lower Landsdown Road (New Municipal Building) – Status Update

The Township Attorney explained that a thirty-day extension had been acquired due to scheduling delays of the water test. She further explained that the water test was part of the Township's due diligence process.

#### **New Business:**

1. Lease of Township Property – Farm and Hunting.

The Township Attorney updated the Committee on the status of the Township's Farm and Hunting Leases. She explained when new leases could be scheduled to begin and duration timeframe options. She further explained that two of the current hunting leases were scheduled to expire at the end of the year. She sought the Committee's opinion on minimum bid amounts. Upon acceptance by the Town Committee, the Township Attorney indicated she would prepare the leases for advertising approval at the next meeting.

#### **Committee Member Reports:**

Committeeman Repmann indicated that he did not have anything to report.

Deputy Mayor Diane Burgess reported that she and Committeeman Donaruma had met with Quakertown Volunteer Emergency Medical Services (QVEMS), described the meeting as productive and agreeable, and would provide additional information at the next meeting. The Township Attorney indicated that she would have more information regarding the QVEMS Lease to discuss in Executive Session at the next meeting.

Mayor Koury reported on his contact with JCP&L regarding power outage restoration and JCP&L's efforts to restore power to affected residents. He further reported on the Township's decision to optout of Cannabis businesses until more information could be obtained and explained an offer from NJLM to tour a cannabis facility on Monday, July 12<sup>th</sup> at 9:30 AM. He reported that the Land Use Board would hold their next meeting the following week on July 14<sup>th</sup>. He also reported that the Township Clerk had discovered that the Amwell Valley Motorcycle run scheduled for July had been cancelled.

Committeeman Repmann requested that power outage reporting information be placed on the Township website and as a news blast to subscribed residents.
