RESOLUTION #2022-38 TOWNSHIP OF FRANKLIN, HUNTERDON COUNTY

GREEN TEAM ADVISORY COMMITTEE

WHEREAS, the Township Committee of the Township of Franklin strives to save tax dollars, assure clean air and water, improve working and living environments to build a community that is sustainable economically and socially; a community which would thrive well into the future; and

WHEREAS, the Township Committee of the Township of Franklin wishes to build a model of government which benefits our residents now and far into the future with green community initiatives which are easy to replicate and affordable to implement; and

WHEREAS, in an attempt to focus attention on "Green" issues, the Township Committee wishes to establish a Green Team Advisory Committee (GTAC); and

WHEREAS, in an attempt to improve the condition of the Capoolong Trail which runs through the Township;

NOW THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Franklin, that we do hereby establish a Green Team Advisory Committee consisting of the members of the Franklin Township Environmental Commission and other residents who may be interested in joining; and based on the recommendation of the GTAC, we do hereby establish a Capoolong Trail Green Team Subcommittee of the GTAC consisting of Elizabeth Basile, Frank Tota, members of the Environmental Commission, and any other interested parties.

NOW, Therefore, BE IT FURTHER RESOLVED by the Township Committee of the Township of Franklin, that the Mission, Goals, and Objectives for the GTAC through December 31, 2022 are established as follows:

MISSION

The Franklin Township GTAC will continue to prepare the Township for ongoing re-certification by Sustainable New Jersey and will advise the Township Committee on ways to improve municipal operations with "Green" initiatives which are economically and environmentally sound through research and evaluation.

The Capoolong Trail Green Team (CTGC) is a subcommittee of the GTAC and will focus on making the Capoolong Trail a safe and usable resource in the community.

OBJECTIVES of GTAC

- 1. Collaborate with township employees, service providers, and other agencies to prepare and apply for Sustainable New Jersey certification and maintain certification on-going.
- 2. Encourage participation of all employees and residents to solicit ideas on green initiatives.
- 3. Research and analyze green initiatives which make practical environmental and financial sense.

4. Develop strategies for sustainable green initiatives in municipal operations.

MEMBERSHIP

The members of the Environmental Commission will be the primary members of the Green Team Advisory Committee. The Township Committee may at any time make changes to the GTAC membership, including but not limited to eliminating positions or adding additional members from the community.

ADVISORY

The Green Team Advisory Committee is an advisory committee to the Township Committee. As an advisory committee, it is not subject to eh Open Public Meeting Act requirements. Environmental Committee members shall take special care not to discuss Environmental Commission matters at GTAC or CTGC meetings as they are not open to the public or noticed.
