Administrative Matters:

Meeting called to Order by Chairman Rob Horvat and the Pledge of Allegiance was said.

- A. <u>Approval of Minutes</u>: Gretchen Myers made a motion to accept the January 18th, 2024 meeting minutes as presented. Joe Chriest seconded the motion and the motion was unanimously approved.
- B. <u>Treasurer's Report</u>: Renee Hayes presented the Treasurer's Report. Deb Merritt made a motion to accept the Treasurer's Report and approve payment of \$115.85 to GoDaddy for the Website Domain Renewal as presented. Gretchen Myers seconded the motion and the motion was unanimously approved.
- C. <u>2023 Audit Report</u>: Renee Hayes presented the 2023 Audit Report. Fritz Snyder made a motion to accept the 2023 Audit Report as presented. Gretchen Myers seconded the motion and the motion was unanimously approved.

County Fire Commission Update and Schedule Additional COG Meeting:

Rob Horvat provided a quick update on what the County Fire Commission has been working on which includes drafting a sample Ordinance that would permit tax refunds and trying to work in conjunction with all municipalities, county and school districts. He noted a few of the members of the Commission would be attending the July 18th regular COG meeting as they should have a few items to present. Ron Irwin recommended representatives come to a school board meeting to get the information out to their members. Chris Seeley noted the County is looking into grant funding opportunities and may have additional information in July. It was agreed no special meeting would be set up as it will be discussed again in July as well as the County will also be holding similar meetings.

Update on Joint Bidding for Road Projects:

There were 9 entities that went out to bid together on 2024 road paving, seal coat and reclamation projects. Bids were opened at the end of April and each entity awarded their individual projects at their meetings in May. There were cost savings in advertising fees as well as some of the paving prices were not as high as anticipated even though they were much higher than previous years.

Other Business:

Bob Ackerman questioned Solar Farm developments in the area and what other municipalities are doing to address any issues. Jill Dunlap and Deb Merritt provided some information as they have had experience with Zoning Ordinance Amendments and Stand Alone Solar Ordinances. There are a few Webinars and PowerPoints that are helpful. They will be provided to him and available for anyone else seeking additional information on solar panels.

The next meeting will be held on Thursday, July 18th, 2024, at 11:30 a.m. at the Woodcock Township Building.

Chris Seeley made a motion to adjourn the meeting at 12:16 p.m. Gretchen Myers seconded the motion and the motion was unanimously approved.
