Administrative Matters:

Meeting called to Order by Chairman Lyle Hoovler and the Pledge of Allegiance was said.

- A. <u>Approval of Minutes</u>: Fritz Snyder made a motion to accept the April 20th, 2023 meeting minutes as presented. Renee Hayes seconded the motion and the motion was unanimously approved.
- B. <u>Treasurer's Report</u>: Robert Horvat presented the Treasurer's Report. Jill Dunlap made a motion to accept the Treasurer's Report as presented. Lyle Hoovler seconded the motion and the motion was unanimously approved.
- C. <u>Ratify Payments</u>: Terry Simonette made a motion to ratify payments of \$119.64 to ProudCity for web hosting and \$21.17 to West Mead Township for GoDaddy domain renewal. Renee Hayes seconded the motion and the motion was unanimously approved.

Cemetery Presentation:

Christian Maher provided information on the work being done by the Crawford Heritage Community Foundation to help local cemeteries and their associations that are in place to care for the upkeep and general maintenance of the 318 cemeteries found in Crawford County. Municipalities could be held responsible for cemeteries located in their jurisdiction if no one is properly caring for them. Josh Sherretts explained the Crawford County Historical Society has records of all known cemeteries. All presenters indicated they are part of a joint effort to help cemetery associations as there is a great need for volunteers as well as opportunities for

anyone to get involved including providing donations for perpetual care funding. Chris Junker was recommended as a valuable resource. Lyle Hoovler discussed the work local Boys Scouts have done at cemeteries located in Sadsbury Township. Christian Maher recommended each municipality provide him with information about their local cemeteries and a contact person to be reached if necessary. He can be contacted by email at executive@crawfordheritage.org or 814-336-5206. Debbie Corll and Josh Sherretts noted the Daughters of the American Revolution (DAR) and the US Veterans Affairs (VA) may repair or replace stones for veterans. There may be funds available for charitable associations to obtain grants. Christian Maher provided background information on Crawford Gives and the upcoming assistance to numerous nonprofit organizations.

Other Business:

Jill Dunlap provided an update on the PA COG. As no invoice was received for 2023 from the PA COG, she talked with Linda Costa, who has retired as the COG Administrator. PA COG is in the process of reorganizing the group so there will be no dues payable in 2023. They will send us updated information for 2024 when available.
