TERMS & CONDITIONS

- Licenses expire annually on March 31st.
- All dogs aged six (6) months or older are required to be licensed in accordance with M.G.L. ch.140 s.137.
- Dogs are required to be licensed in the town within thirty (30) days of being acquired or turning six (6) months of age.
- There is a sixty (60) day grace period after licenses expire. A \$25 late fee goes into effect on June 1st of each year and is separate from any fines or court action taken by the Animal Control Officer. This fee does not apply to dogs that are acquired or turn six (6) months of age after June 1st, so long as said dog is licensed within thirty (30) days.
- Anyone owning 4 or more dogs <u>MUST</u> get a kennel license. An inspection of the
 property is required <u>prior</u> to obtaining said license. To schedule an inspection, contact
 the ACO using the contact methods listed below.
- Anyone owning fewer than 4 dogs may elect to obtain a kennel license instead of individual dog licenses, but this is not required.
- It is the owner's responsibility to schedule a kennel inspection by contacting the ACO at animalcontrol@goshen-ma.us
- It is the owner's responsibility to notify the town clerk anytime a dog is obtained, transferred, or passes away, so that dog listings can be updated. Failure to do so may subject the owner to licensing enforcement (warnings or citations) if the town clerk is unaware of the change in status.
- Licenses will not be issued until all license fees, late fees, and civil citations (if applicable) are paid in full.
