Hellam Fire Company

For the month of April, the Hellam Fire Company responded to 58 calls with 33 (57%) in Hellam Township. Year to date for 2023, we responded to 163 calls with 79 (48%) in Hellam Township. Last April, there were 36 calls with 15 (42%) in the Township and 180 calls year to date with 89 (49%) in the Township. There were no automatic fire alarm reports submitted this month.

Last month members attended training on the Fundamentals of Fire Dynamics, Emergency Vehicle Driver Training, Strategy and Tactics of Fire Dynamics, and Pump Operations 1. We hosted a Pump Operations 1 class at our station with all local departments invited to attend. We will be hosting Pump Operations 2 at our station in May.

The Chief Officers attended the quarterly Emergency Services meeting consisting of Police, Fire, and EMS agencies serving Hallam and Wrightsville Boroughs and Hellam Township. Our members assisted with traffic control during the annual Eastern York Lacrosse highway cleanup on Lincoln Highway.

I would like to express my appreciation for the support of the burn ban put in place for part of April. Conditions were prime for rapid spread of wildland fires. Even after the local ban was put in place, the support was gained for a Countywide ban in just a few hours. We will continue to monitor conditions and will provide a recommendation if another burn ban is needed in the future.



<u>Air Diffusers:</u> Mr. Schaeffer advised that he raised one of the air diffusers, which he found to be in good working condition, however, the pin snapped as he was trying to raise/lower the diffuser. There was a brief discussion regarding what types of other pins could be used that may be stronger. Mr. Schaeffer confirmed that there are plenty of extra pins on-hand at the WWTP that can be used in the meantime.

Mr. Schaeffer noted that he pulled one of the newer diffusers and added that he plans on starting from the edge and will work his way around until all the diffusers have been pulled and inspected.

Monthly Pump Testings: Mr. Schaeffer advised that he spoke to the Operator about ensuring that all EYCSA's pumps are exercised on a monthly basis. He verified that all the pumps were exercised during the past month and stated that per the Operator, the pump in the EQ tank does not work. Mr. Miller explained that the Operator told him that the pump works, however, it doesn't have enough power to pump the effluent up into the tank. Mr. Miller advised there is a chain hooked to that pump, however, it's pointless because the pump cannot be pulled up. There was a brief discussion and Mr. Schaeffer advised that he'd speak to the Operator again to verify what's going on.

<u>Influent Pump Station Cleaning:</u> Mr. Schaeffer confirmed that he called Kline's Services to schedule a cleaning for the Influent Pump Station, as it's very in need of it. Mr. Miller commented that it's been a while since the last cleaning and advised that Mr. Schaeffer can schedule cleanings as-needed.

- Influent Sampler: To a question from Mr. Miller, Mr. Schaeffer advised that the sampler that was deemed "broken," actually works. He explained that it has totally dried out and upon testing, it still works as it should, even though the circle indicator is still slightly pink, indicating moisture. The Board confirmed that Mr. Schaeffer can leave the spare in place, as it's working fine. The one that was deemed "broken" that actually works can now be used as a spare. Mr. Schaeffer noted that both samplers are identical to each other.
 - Mr. Schaeffer explained that influent sampler hoses need replaced, as the sample tube has a hole in it [L.A.B.S., Inc. reported the issue to ARRO]. After a brief discussion regarding the set-up and installation of the influent sampler, the Board directed Mr. Schaeffer to order some spare hoses [for the effluent and for the influent] via USA BlueBook.
- Alum Room Leak: Mr. Schaeffer stated that upon checking during a rain event, he found the area that was leaking in the alum room to be dry. Mr. Miller verified that there was a second joint leak by the UV system that he noticed that may need taped or sprayed. Mr. Schaeffer commented that he plans on checking the rain spout to see if there's any clogs that may be leading to these leak issues.
- Weeds on the WWTP Bank: Mr. Schaeffer commented that EYCSA may need to soon take action, as the weeds on the bank at the WWTP have really grown up these past few weeks. Mr. Miller noted that when the weeds are approximately 12" high, the Board will address it. There was a brief discussion regarding weed killer and if there's enough on hand for the Operator to start spraying the weeds.
- <u>Bamboo/Mowing Right-of-Ways:</u> To a question from Mr. Schaeffer, Mr. Miller advised that the bamboo should all be taken care of. Mr. Schlosser confirmed that he'd check on the bamboo, just to ensure it's no longer growing.
 - Mr. Miller mentioned that EYCSA will have to find someone to mow EYCSA's right-of-ways, since Mr. Roy Campbell passed away. Mr. Miller advised that EYCSA can map out the areas that need mowed and seek some quotes. Ms. Polonikas mentioned contacting Environmental Concepts Landscaping and Mr. Schlosser and Mr. Newcomer recommended calling Stambach & Schindler, Inc., as they had shown interest in the past. Mr. David Gockley was also mentioned as a possibility, so long as he can provide a Certificate of Insurance.
- OmniSite UV System Alarm: Mr. Schaeffer explained that after partnering with Mr. David Kline [of ARRO], that it was determined that the list of alarms that Ms. Polonikas provided to Envirep, Inc. and ARRO, were satisfactory. He noted that EYCSA doesn't need to worry about a UV system alarm at this time, as it seems unnecessary.
- March 23, 2023 Alarm: Mr. Schaeffer advised that on March 23, 2023, there was Control Panel General Alarm on the Eastern York Wastewater Treatment Plant OmniSite. It was a general alarm, but all three [big] blowers were tripped. Mr. Schaeffer is thinking there must have been a power glitch/surge somewhere, possibly from the storm that day or from a car accident that had taken place on Freysville Rd. There was a brief discussion regarding the details of the alarm/issues that were found upon Mr. Schaeffer's arrival to the WWTP, and Mr. Miller stated that EYCSA will have to await for this issue to happen again to further investigate.
- <u>Filter Pressure Gauge Issue:</u> Mr. Schaeffer explained that the pressure gauge on the pump is "rusting out." To a question from Mr. Schaeffer, Mr. Miller stated that Mr. Schaffer can try and replace the gauge, versus Envirep, Inc. Mr. Schaeffer commented that he feels Envirep, Inc. should have caught that when they last serviced the filters/pumps,

Engineer's Report:

2023 Maintenance Program: Mr. Hardman confirmed that Mr. Brent Zeiders, of Pennsylvania Sewer Authority, received EYCSA's signed proposal for the 2023 Maintenance Program [line cleaning/televising].

- 4535 Lincoln Highway Bentley Farms Wedding Event Venue (Pasch): Mr. Hardman advised that he's still awaiting confirmation from Gordon L. Brown & Associates, Inc. regarding the grinder pump lid being water tight [since it's located in a floodplain]. He noted that the ball's in their court at this point; he's just waiting to hear back from them.
- Campbell Rd Pump Station Replacement: Mr. Hardman stated that the Campbell Rd Pump Station was delivered last week [on March 22, 2023]. The concrete pad and walls were poured and the contractors are looking to set the station on April 3, 2023. There were no issues offloading the station and Mr. Hardman noted that he doesn't foresee any issues setting it. Mr. Hardman advised that the contractors have been really great to work with thus far and Mr. Miller agreed and noted that he's been visiting the site every day to check in on the progress.

Mr. Hardman went over how C. S. Davidson, Inc. generally handles these types of projects and recommended that EYCSA approve Application for Payment No. 1 [in the amount of \$31,936.95] to WYElectric, LLC. He noted that there doesn't have to be a separate motion to approve this, as the Board can approve it when approving the March payables [since no additional work was done outside of the contract].

Mr. Miller commented that a list of alarms and alarm contacts will be needed for the setup of the OmniSite Alarm System. Mr. Hardman stated that Envirep, Inc. will be onsite to install the OmniSite Alarm System the first week of April. Pre-startup will be Thursday, April 6, 2023 with the system fully starting up/going online Friday, April 7, 2023.

Mr. Schlosser advised that he removed the covers from the plug valves and filled them with grease so that we don't run into the same issues we had with the plug valves at the WWTP. There was a brief discussion regarding the bypass pumping setup, which can be used in the future, if necessary.

The Board voted and unanimously approved Ms. Polonikas cancelling the Met-Tel phone service at Campbell Rd Pump Station [once the OmniSite Alarm System has been installed and is confirmed to be working].

<u>2022 Chapter 94 Report:</u> Mr. Hardman advised that EYCSA's annual Chapter 94 Report was submitted to Pennsylvania Department of Environmental Protection [by C. S. Davidson, Inc.] the end of February.

Solicitor's Report:

- 65 N Prospect St Ongoing Litigation: Mr. Miller explained that Ms. Polonikas reached out to CGA Law Firm requesting updates on the Card Property v. EYCSA matter. He noted there's an email from Solicitor Evan Gabel included in Ms. Polonikas' Executive Secretary's Report.
- Problematic Delinquent Accounts: Ms. Polonikas provided updates on the two problematic delinquent accounts which were discussed at length in the Executive Secretary's Report. She advised that CGA Law Firm waived the \$100.00 Collection Letter fee for Mr. Marksen Harouz of 226 W Market St. A lien will be filed for Mr. Dean Caracher, Jr. of 4341 Webster Dr N. Mr. Caracher hasn't made a payment since June 2022 and is disputing the two Collection Letter fees from CGA Law Firm [from Collection Letters dated April 27, 2022 and October 25, 2022]. CGA Law Firm prepared and sent a letter explaining the breakdown of all charges to Mr. Caracher on January 24, 2023, to which Mr. Caracher has not responded to, to date.

Administration Report:

Executive Secretary PTO: The Board voted and unanimously approved Ms. Polonikas' PTO request [Thursday, April 6th through Wednesday, April 12th, 2023]. It was decided that Ms. Myers would visit the EYCSA office for an hour each day on Thursday, Monday, Tuesday, and Wednesday [to get the mail and check voicemail]. With Ms. Polonikas' time off *not* falling during a collection cycle, there is very little activity at the EYCSA office, therefore one hour a day should more than suffice. Ms. Polonikas advised that she would log on from home and check EYCSA's emails each day to ensure nothing needed immediate attention.

The Board voted and unanimously approved the March Executive Secretary's Report.

WWTP:

- <u>Crack Under Overhead Doors in Building 2 at WWTP:</u> The Board voted and unanimously approved Mr. Gromling's quote in the amount of \$490.00 [which is included in the Agenda].
- Republic Services Proposal: After a brief discussion, the Board decided they do not think it's necessary to have Republic Services empty the dumpster at the WWTP twice per month. The dumpster barely has anything in it, so it seems foolish to spend \$171.16 per month [plus fuel recovery fees] to have it emptied twice per month. The Board instructed Ms. Polonikas to request a new proposal from Republic Services with pricing for once a month pickup service.
- New Board Kit for UV System: The Board voted and unanimously did *not* approve TROJAN technologies Quotation QO0004066 in the amount of \$2,057.00 [plus shipping], as it was decided that an alarm for the UV system is not necessary. Mr. Schaeffer advised that he could replace the current hard wires with soft wires.
- <u>Influent Sampler:</u> Mr. Miller advised that a new influent sampler is no longer needed, as the one that's in use now is working fine and there's also a spare that works, as well. The Board voted and unanimously did *not* approve the purchase of a new influent sampler.

Collection System:

Flinchbaugh Engineering, Inc. Building 3, Lot 6: Mr. Miller explained that he approved high consumption relief for Flinchbaugh Engineering, Inc.'s Building 3, Lot 6, as the reading from their private meter [which measures employee breakroom/restroom usage] was higher than The York Water Company's reading for the entire building. After a brief discussion, the Board voted and unanimously ratified Mr. Miller's approval for relief, which decreased Flinchbaugh Engineering, Inc.'s billing for the 4th Quarter 2022 in the amount of \$3,135.57. The average billing of \$960.93 was used, as that's the figure/average that was used last time there were private meter issues with this same account. For some reason, this particular meter has always been an issue. Flinchbaugh Engineering, Inc. is looking into the issue/having their private meter calibrated. It's looking like the issue is the private meter, as the readings from The York Water Company have been fairly consistent, while the private meter readings continue to increase every quarter.

Developers:

<u>250 Orange St – Wes Dixon:</u> The Board voted and unanimously approved Chairman Miller and Secretary Newcomer's countersignatures on the Agreement for the Payment of Legal and Engineering Services.

The Board voted and unanimously approved capacity for the project in the amount of one EDU. Mr. Miller advised that this will be the second EDU, as the property had one prepaid EDU when Mr. Dixon purchased it. Mr. Miller went on to explain that Mr. Dixon is building a duplex, so two EDUs are needed. To a question from Mr. Newcomer, Mr. Miller noted that the property was never connected to sewer in the past, as there was never running water on the inside of the structure that was once there.

There was a brief discussion regarding the drawing that Mr. Dixon provided, as the drawing depicts floor drains in the garage, which cannot be connected to the sewer.
