I am hereby requesting excusal from the onlot system pumping/inspection requirement under the municipality's sewage management program. I am willing to attend the Board of Supervisor meeting to answer any questions the Board may have on my property. The reason for this request for an excusal or a waiver is as follows (check the most appropriate reason):


My name is Bob Andorn. I am the son of, and executor for the estate of my mother, Susan Andorn, including property located at 122 Bairs Mill Road. My mother was a resident of Hellam Township for 44 years until she became ill and moved into alternate housing arrangements. My mother was the sole resident at the house for at least the last 15 years prior to 2020.
