## RESOLUTION NO. 2023-24

A RESOLUTION OF THE BOARD OF SUPERVISORS OF HELLAM TOWNSHIP, YORK COUNTY, PENNSYLVANIA, AMENDING RESOLUTION NO. 2013-14, THE COMPENSATION TO BE PAID TO APPOINTED MEMBERS OF THE BOARD OF EASTERN YORK COUNTY SEWER AUTHORITY

WHEREAS, Section 53 Pa.C.S. Section 5610(d).) provides that members of the Board of such Municipal Authorities organized and created pursuant to said Act may receive such salaries or compensation as may be determined by the governing body or bodies of the Municipality or Municipalities creating such Authorities; and

**WHEREAS,** Hellam Township and Hallam Borough are the Municipalities having created Eastern York County Sewer Authority; and

WHEREAS, it is the intention of the Board of Supervisors of Hellam Township, as the governing body of said Municipality, to establish the compensation to be paid to members of the Board of Eastern York County Sewer Authority as provided herein.

NOW, THEREFORE, be it resolved as follows:

- 1. Each of the members of the Board of Eastern York County Sewer Authority appointed or reappointed by Hellam Township shall be entitled to receive, from the funds of said Eastern York County Sewer Authority, compensation at the rate of One Hundred Seventy-Five (\$175.00) Dollars per meeting for each regular or special meeting of the Board of said Authority actually attended by such member, not to exceed a maximum of Fifteen (15) meetings per year, in accordance with the requirements set forth in 53 Pa.C.S. Section 5610(d).
- 2. It shall be a condition of this Resolution that a similar Resolution be adopted by the Council of Hallam Borough providing for the same compensation to be paid to the members of the Board of said Authority appointed or reappointed by said Hallam Borough.
- 3. Such compensation shall be paid on a monthly or quarterly basis or such other basis as may be determined by the Board of Eastern York County Sewer Authority.
- 4. This Resolution shall become effective on January 1, 2024, and shall be applicable to such members of the Board of Eastern York County Sewer Authority as may be appointed or reappointed by Hellam Township on or after said effective date.

ADOPTED, by the Board of Supervisors of the Township of Hellam, York County, Pennsylvania, at a regular public meeting this 7<sup>th</sup> day of December 2023, at which a quorum was present.

- Research from home regarding various subject matters (surveillance system troubleshooting, banking needs, etc.)

The Board Members ask that Hallam Borough and Hellam Township consider resolutions for this increase, setting January 1, 2024 as the starting date for the new amount.
