CODE OF ORDINANCES OF THE CITY OF HOLYOKE, MASSACHUSETTS
1997

AN ORDINANCE

Be it ordained by the City Council of the City of Holyoke as follows:

SECTION 1. Article II entitled "Police Department" of Chapter 5 entitled "Law Enforcement" of the Revised Code of Ordinances of the City of Holyoke, Massachusetts, 1997, as amended, is hereby further amended:

BY ADDING THE FOLLOWING SECTION 5-56 ENTITLED CRIME ANALYST


"Sec. 50-56 – Crime Analyst.

- (1) Position and purpose. The Crime Analyst is a civilian position responsible for collecting, evaluating, analyzing, and disseminating information and intelligence data regarding criminal activity, criminal enterprises, and suspected criminal acts within the area of operation of the Holyoke Police Department in support of the Department's proactive policing activities.
- (2) Duties and Responsibilities. The Crime Analyst has the following duties:
 - a. Perform strategic analysis which includes but is not limited to, identifying and recommending proactive measures to implement long range plans for crime prevention; research to identify crime patterns; implement procedure related to computerized mapping and analysis; develop strategy to address problem areas; provide analysis to Police Department Personnel, City Administration and City Council for decision making purposes; and collect, analyze, interpret and prepare police data to evaluate police deployment, responses, and problem solving efforts.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. This ordinance shall take effect upon its passage.


BY ADDING TO: GRADE 10 of the SCHEDULE A CLASSIFICATION AND HIRING SCHEDULE, the position of:
