The City of Holyoke Office for Community Development is designated as the lead agency for the preparation and submission of the City's Annual Action Plan for Community Development Programs, funded by the U. S. Department of Housing and Urban Development (HUD) and is proposing to amend its FY 2019 Annual Action Plan. The City of Holyoke expects to submit the Substantial Amendment to HUD on or before January 15, 2020.

The City of Holyoke proposes the following:

- Removing the Scott Tower Master Plan (\$50,000) and the War Memorial Emergency Shelter (\$52,000) from its Annual Action Plan
- Adding Sidewalks (\$100,00) to the FY19 Annual Plan
- Adding Pina Park Spray Pool (\$150,000) to the FY19 Annual Plan
- Adding Jones Ferry Boathouse HVAC System (\$47,000) to the FY19 Annual Plan
- Adding Springdale Park Improvements (\$175,000) to the FY19 Annual Plan
- Adding demolition/greenspace creation at 107 Clemente Street to the FY2019 Annual Plan (change in type)

#### **PUBLIC COMMENT PERIOD:**

The thirty-day public comment period begins on December 1, 2019 and ends at midnight on December 31, 2019. The City will accept comments from the public on this Amendment during this timeframe.
