# IN THE YEAR TWO THOUSAND AND TWENTY

## TWELFTH AMENDMENT TO CHAPTER 74 OF THE REVISED CODE OF ORDINANCES OF THE CITY OF HOLYOKE, MASSACHUSETTS 1997

---

### AN ORDINANCE

---

Be it ordained by the City Council of the City of Holyoke as follows:

**SECTION 1.** Article II entitled "Recycling" of Chapter 74 entitled "Solid Waste" of the Revised Code of Ordinances of the City of Holyoke, Massachusetts, 1997, as amended, is hereby further amended by the following:

**DELETING in its entirety:**

**Section 74-40 – Access to DPW Facilities**

The department of public works shall establish a policy for access to the city's drop-off center. The policy shall provide that residents of the city who rent property shall have the same access to the facility as homeowners, and shall be charged a \$10.00 annual fee for such access.

**ADDING in its place:**

**Section 74-40 – Access to DPW Facilities**

The department of public works shall establish a policy for access to the city's bulky waste and recycling drop-off center for all City residents. Business and commercial disposal will not be accepted. The policy shall provide a schedule of fees for the disposal of bulky waste, hours of operation, and a list of materials accepted and not accepted.

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** This ordinance shall take effect upon passage.
