



**2021 ARPA FUNDING REQUEST PUBLIC COMMENTS PACKET**

This packet includes all written public comments received by the Mayor and Office of Community Development via email or mail before noon on July, 26, 2021. A total of 89 written public comments were received. Ten general comment letters provided general sentiments regarding priorities in Holyoke, areas of concern, and the process.

Thanks Terry. Below is my public comment:

I've just watched the one public hearing that took place in early July at the Senior Center. I heard several familiar voices and was happy to hear a few unfamiliar residents counter the usual "reduce our high taxes" mantra.

I've read through the list of proposed funding and have many questions about the specifics of these projects. I hope that the mentioned proposal books that will be made available to Councilors also gets made available to residents so that we can better know what exactly is being proposed. I know this is extra work and I thank those involved in doing this added work in the interest of transparency and broader public input and support.

One of the first guidelines Alicia asked the group at the public hearing to respond to was: What are we seeing as a community?, and I'd like to talk generally about how I feel the funds should be used in relation to that question:

I realize that our city has an old infrastructure that in many ways needs updating or fixing. At least one person at the meeting advocated for spending 90% of the ARPA funds on infrastructure to reduce the overall tax burden. Doing this would distribute the funds equally among all residents of Holyoke, not directly to those most impacted, and I would also argue that those infrastructure projects tend to be more 'invisible' to individual residents rather than highly 'visible', transformative neighborhood projects.

That said, I think some amount of ARPA funds should go towards infrastructure, if applicable, and in the qualified census tracts areas, if possible. However, highly visible projects that will help those most affected by the pandemic should be prioritized. Projects that will help transform neighborhoods, including housing needs as we face a severe housing shortage and escalating property prices. Relief to small businesses also ranks high on my priorities list.

I wondered about one person's comment regarding additional federal funds coming in the future, I believe he mentioned that a coordinated effort to spend the funds in a planned, effective way. I've questioned what I see as a rushed timeline for the spending of these ARPA funds, and if we are to receive more federal funding but aren't quite sure what or how that can be spent on, this further reinforces my opinion that we as a city need to be thoughtful and careful about how we spend this money, without rushing the process through arbitrary deadlines. Alicia mentioned that additional information regarding applicable uses was still (at that point, early July) coming from the government.

I'd like to see residents from the QCT areas be a larger part of the decision making process. At this point, perhaps targeted surveys or further outreach, or, an open public comment process (with outreach to specific neighborhoods) during the Council deliberation time would be good additions.

To answer the question Alicia posed at the community hearing, What are we seeing as a community?, I'm seeing that public investment in visible, tangible projects greatly impact how residents feel about their neighborhoods, which I believe effects quality of life and mental health. I'm seeing a housing crunch in the Valley at large and prices of properties in Holyoke escalate. And, of course, I'm seeing fairly low or moderately paid essential workers having had to go to work environments that are stressful this entire time.

Dear Kate, Alicia, and Terry,

I write in regards to public comment on ARPA applications and allocations. I noticed that in the public comment forum on July 8, participants (and applicants in attendance) were instructed not to address specific applications as there would be opportunity for presentations, discussion, and public comment on specific applications at a future date. As far as I can see, no such opportunity has yet occurred.

It has been difficult to find relevant information online. The City's website has had pieces of information in different places, and the search function can be buggy in yielding and organizing results.

What I have been able to see is bare bones and sometimes inconsistent. It's unfortunate that an arbitrary and artificial deadline has been imposed that leaves public comment closing before public presentations -- with opportunity for questions, clarifications, or potential modifications -- have even occurred. Even as I write this, that deadline is itself unclear -- from a post in my ward's Facebook group, the public comment period seemed to have been extended through July 26 (today), and I'm submitting in good faith based on that, but other postings still contradict that. Regulations for eligibility also still seem unclear. With so much uncertain and unknown, foreclosing on public comment seems wildly premature. It has the appearance of being designed to thwart (rather than encourage or even allow) public comment on a massive piece of public investment that could have significant impacts on Holyoke's communities and future.

I hope you will formally and publicly re-open and extend public comment, or create a new public comment period dedicated to addressing the specific applications after the public has had better opportunity to learn about them. That said, here are my impressions so far, with the significant caveat that they're based on very limited publicly available information.

Like many in Holyoke, I'd love the opportunity for municipal fiber to the home (FTTH) and to say goodbye to Comcast's lousy service, price-gouging, and monopoly for what is at this point in history an essential utility. From my experience, from conversations with other Holyokers, and from observing as I walk around my neighborhood and see people parked in cars with laptops to access wi-fi through the library and schools, it's clear that affordable high-speed internet access is a crucial need which has been greatly exacerbated by the pandemic, but I've heard conflicting things about eligibility for FTTH under ARPA.

I've also seen contradictory information from HG&E. For years, HG&E has dragged its heels on pursuing FTTH in Holyoke even as surrounding communities surpassed us. Recently, HG&E surveyed rate-payers with what appeared to be a push poll designed to discourage potential customers -- they presented numbers as if customers would have to cover the full cost of build-out without a penny from grants or other sources. In a direct opposite, when Holyoke's ARPA applications were first unveiled, HG&E's request was listed at \$15 million for the first year and \$11 million for the second (for a total of \$26 million, or about 90% of Holyoke's total \$29 million, and also about what HG&E has publicly stated they estimate a total build-out cost would be) -- as if ARPA would be covering costs in full without contribution towards build-out from customers or other sources. This appears to have later changed without explanation to \$3.8 million the first year and \$11 million the second (with a total of \$15 million) plus a separate request for a specific pilot project. And there's also a note about the possibility of scaling back if partially funded. Despite all these

varying numbers and possible combinations for potential funding, the projected monthly pricing to consumers has remained about the same. That simply doesn't add up.

If past is prologue, then HG&E is designing their application(s) or pilot(s) (or maybe both) to fail. Or maybe they're finally bowing to public pressure in good faith and just haven't gotten all the details cleaned up for public presentation yet. Or, in the event their application is funded, maybe they're the proverbial dog that caught the car. I can only say the need is real, and it was made all the more acute by the pandemic, but I'm deeply skeptical of HG&E's sincerity or capability on this, and if they can't or won't pursue this promptly and well, then Holyoke should look to create as efficiently as possible another entity that will, so I hope ARPA application reviewers and the acting mayor will thoroughly interrogate and pin down before committing to funding or not funding HG&E's asks for this substantial infrastructure investment.

In the area of housing investments, I'm pleased to see so many applicants. The need to secure quality affordable housing is very great, all the more since the pandemic. I have heard about the dearth of opportunity for home ownership in South Holyoke in particular literally for decades. Towards that goal, I'd encourage funding the HHA application to move that process along more quickly.

Cabot/Newton has needed healthy investment for a long time, and I'm glad some has started. I'm intrigued by the application for a mix of rental and owner-occupied development, but I'd like a lot more information about the project (e.g., infill?, rehab?, both?, any measures to prevent displacement not wanted by current residents there or nearby?, etc.). Wayfinders has a good reputation, but I'd like to know more about this project.

Revitalize CDC's comparatively small ask for health-related retrofits looks like it could help people remain safely at home. But for their application and that from Appleton Mills, I feel I know very little based on what is publicly available.

Moving on, my impression of One Holyoke's work in my neighborhood is a very mixed bag. They appear over-extended with some promised developments left incomplete years later, prioritization has been questionable, and in the past their projects haven't blended in well with neighborhood characteristics (though that has improved some in recent years), so I would encourage reviewers to take a hard look and get many details firmly pinned down before throwing further money towards this applicant.

On a related note (since One Holyoke manages the program), the application for NIP concerns me. It appears to raise the income limit for eligibility without changing anything else about the program. Given the difficulties with the program as it exists (requiring unrealistically steep matches and monies up front from poor people), given a long waiting list (and a shut-down during the time period when residents had personal stimulus funds as potential sources for the required matches), and given that the program in recent years risked defunding because it struggled to spend its allocations (not because of lack of need in the community but because needs were too great for the program's requirements realistically to handle), lifting the cap without changing the program in other ways makes it highly likely to provide public subsidy sooner/more to those who need it less while still excluding many who need it most. It's upside-down priorities. Stimulus should be distinguished from regular income (so people aren't excluded who would otherwise have been eligible), but I'm not sure raising the cap is the best way to address that. And I'd agree that people at the lower ends of middle class also need and deserve assistance, but that shouldn't be structured to come at the expense of people who are even more poor.

In the areas of infrastructure, I generally favor public investments in public properties, including buildings (so many of our historic public properties desperately need attention), water, sewer, parks, streets, sidewalks, and the like. It would be nice to know more detail about some of the specific asks here. I also think it's in the public interest and worthwhile to support improvements to parking (and drainage) at Holyoke Health Center and for the roof at Enlace. Both organizations have stepped up each time the community has needed them even when facing new challenges.

I'd also like to express support for how Nueva Esperanza stepped up during the pandemic. It's an organization that has suffered serious internal issues, but they stepped in to fill a specific gap and did so very effectively, bringing perishable foods to where they were needed and could be collected on foot. NE's ask is among the smallest, and I hope it will be approved (and well-monitored) as an opportunity both to meet local material needs exacerbated during the pandemic and to repair and rebuild important community relationships that are key to getting through collective difficulties such as the pandemic. NE does a lot with little, keeps their ask humble and directly related to pandemic response and sequelae, and makes good faith effort towards seeking other sources of funding for other projects or programs.

I sincerely wish I could say the same about the Holyoke Boys and Girls Club. However, within the last year they threw away at least \$200k and possibly more in order to give a connected player a sweetheart deal on real estate rather than engage with or sell to the Massachusetts Department of Conservation and Recreation for a parcel on Mt Tom which they'd previously promised to develop for outdoor recreation and which they'd instead neglected throughout their years of ownership. The parcel was never used for their non-profit mission, so I believe by law it should have been taxed -- was it? HBGC is also the recipient of the single largest CPA grant allocated in Holyoke, a grant for which they provided no match at all (no other fundraising, no use of CPA to leverage other grants, no in-kind donation of supplies or labor... absolutely nothing but showing up with hands out and getting their ask funded in full). I urge ARPA application reviewers and the acting mayor to demand better from the HBGC management and board before giving them further public monies.

I urge ARPA application reviewers and the acting mayor to reject the Gary Rome request (there are small businesses who genuinely need help, but this ask simply isn't appropriate or necessary for public funding -- if the City wishes to fund electric car chargers, then let them be City-owned please) and the police pay bonuses (given that they're already the City's highest-paid employees, it's a slap in the face to many other workers, from the Library workers who were paid below minimum wage to the City Hall employees whose salaries are far below comparable workers elsewhere and haven't had raises in years to our incredibly overworked teachers to the health care workers and store clerks who've also had to deal with the public throughout the pandemic, etc, etc). As to the latter's separate request for ShotSpotter funding, I'd want to know a lot more about what it is, how it's used, and what it has to do with pandemic relief, but my gut sure says no.

I've missed a few, but I can't decipher the rest of my notes to myself, and my eyes and neck are tired of struggling with the online documents. I sincerely appreciate what has been made available online to the public so far, but I ask again that provisions be made for public outreach and comment after the public has had an opportunity to learn more about the specific applications, and I'll also repeat again my dismay at the composition of the CAC (particularly the absence of representation from residents of funding target areas, the lack of racial/ethnic diversity, and the lack of publicity and outreach) as expressed in earlier emails.

I am writing in support of funding for sewer upgrades, sluiceway and all other needed repairs for Whiting Street Reservoir and for improvements to the Jones Ferry Connecticut River Access facility. These are both so important and timely

For Whiting Street Reservoir, the repairs are long overdue and will be important to maintain the access and usability for WSR for its important use as a backup critical resources for all of us..

The case for Jones Ferry Access is also important. As we have all learned the pandemic accelerated the notion that having safe and secure places for recreation in the city... as follows

I offer the following list of reasons for this:

1. During the pandemic, citizen use of the facility has nearly quadrupled.
2. To service the needs of the citizen's, many of whom come from the lower wards of the city and are at the poverty or below poverty economic strata, Holyoke Rows is in need of additional staff to further their programs of water safety, rowing, kayaking.
3. The present boat ramp cannot service the safety equipment or, indeed, Holyoke's Fireboat at low water levels in the River and thus needs to be extended for the safety of program users and fire protection.
4. Stairs, old pilings need to be removed and replaced.
5. Access for fishing, walking and simply viewing the River needs to be enhanced to accommodate the number of active users of the facility.
6. With improvements, there will be greater access to study the River, itself, as well as the endangered species living in it in close proximity to all of the people, commercial entities and industry that line the River.
7. Prepare the site of the Access Facility for further future expansion to benefit all users.

The use of the Facility is growing. Expansion of a waterfront park for the residents of Holyoke is one of those wonderful things that have absolutely no downside. Its existence and its further development adds a great selling point, along with Holyoke amazing water resources and green energy, to commerce or industry looking at locating in Holyoke.

The Connecticut River Conservancy has pledged its expertise and full support to the River Access Facility to doing all of the paperwork and reporting that ARPA funding will generate and thus there will be no cost to the city for this effort.

Please accept the following as public comment in response to the City of Holyoke's Round 1 ARPA funding notice.

### **Overview**

This public comment emphasizes the importance of human infrastructure on level with emphasis on key physical infrastructure investments. Indeed the success and impact of physical infrastructure development is dependent upon an adequately staffed and supported local government administration.

The American Rescue Plan Act (ARPA) presents local government with an unprecedented opportunity to shape the long-term development of their communities. Holyoke need not reinvent the wheel in determining appropriation of funding because it approaches this moment equipped by two decades of comprehensive planning efforts reduced to writing in the Holyoke Master Plan and Urban Renewal Plan. Further, the City can leverage the local work of the Massachusetts Rapid Recovery Planning Program including recent study findings on the effect of downtown business needs and longterm economic development. Last, as mentioned previously, the City should tailor a diverse spectrum of proposals to take advantage of the state's proposed plans for its multi-billion dollar appropriation of ARPA and state relief funds.

I attempt to submit this Public Comment with objectivity and understanding of the practical and provincial challenges facing local governments like Holyoke. However, the points of emphasis selected here are of course informed my experience working within the City of Holyoke from 2014-2018 and more recently working with municipalities across Massachusetts and the country on data-informed community development decision making.

If there was one observation or suggestion I hope the reader of this comment would take away its this: **A great program or initiative has no impact without adequate personnel resources to implement, oversee and develop the idea.** The practical impact of underresourced city staff can be seen in myriad underutilized or abandoned initiatives from overgrown weeds on the Canal Walk, thoughtful ordinances turned to paper tigers by the lack of city staff to implement and administer, or missed opportunities to hold buyers of city-owned properties accountable to rehabilitation requirements due to the lapse of time-limited reverter rights. **ARPA funds must be used to ensure the administrative and professional support (i.e. the necessary human infrastructure) to implement programs in a cost-effective, transparent and sustainable manner.** Accordingly, I extend my strong support of OCD's request for administrative resources

and encourage the City to conduct needs analyses and adequately staff other municipal departments to respond to the impacts of COVID on housing, economic development, and public works.

The remainder of this comment focuses on particular policy areas where ARPA funding could most efficiently be leveraged to achieve systemic improvements to the generational obstacles facing this diverse, opportunity-rich and unique community. In particular, this comment identifies recommendations in three key domains: Public Health, Housing and Community Development, and Economic Development

## **Public Health**

### Recommendation 1A: Fund a comprehensive survey of asthma rates relative to building conditions and proximity to current industrial development.

In his remarks with Rep. Richard Neal announcing the City's receipt of ARPA funding, Mayor Murphy emphasized the disproportionate impact asthma has had on the economic and social mobility of underserved communities. Holyoke should follow best practices in similar post-industrial cities and develop interventions to improve the key contributors of poor air quality and asthma prevalence. In order to define and support those initiatives, Holyoke needs to assemble baseline data on the rate and cause of asthma within the community. Holyoke can look to cities like Pittsburgh, PA that have conducted targeted community surveys to determine current and historical asthma rates and indicators. In addition to being a high-risk comorbidity for COVID-19, low-income communities face decreased housing mobility due to rapidly increasing housing costs associated with COVID-19 market factors.

### Recommendation 1B: Improve access to healthy food through food equity surveys and a small grant program for neighborhood bodegas and markets.

Downtown Holyoke has often been referred to as a "food desert." Indeed, the neighborhoods of The Flats and South Holyoke lack access to healthy food due to a combination of transportation limitations and isolation from the City's three primary grocery stores.

The City can leverage the recent work of the Chamber of Commerce and community groups to revitalize the Holyoke Farmers Market to support development of healthy food offerings at neighborhood markets and bodegas. Following communities small and large--from Hopewell, Virginia to New Orleans, LA--Holyoke should embark on a community survey to determine geographic availability of fresh produce in neighborhood markets across the downtown area and tailor financial assistance to help committed business owners overcome obstacles to expanding food options.

ARPA funding may be used to survey neighborhood markets to determine opportunities for connections and subsidization of local farmer distribution agreements and access to capital for small-scale refrigeration infrastructure for storing produce and non-shelf stable food products.

If access to advance capital for necessary equipment costs poses an obstacle for healthy food offerings, ARPA funding may be used to develop a small grant program offering businesses advance funding for key equipment (e.g., refrigeration). Given the low capital of eligible businesses, these small grants should be offered on an up-front "compliance guarantee" rather than reimbursement basis. For example, an eligible business would be able to receive \$5,000 to acquire refrigeration equipment to support produce offerings subject to a condition that the business provides documentation of a compliant purchase within 12 months or be subject to a debt for the up-front grant payment.

## **Housing and Community Development**

### Recommendation 2A: Support the impact of the City's existing Neighborhood Improvement Plan through targeted outreach to elderly homeowners and underserved communities.

The Neighborhood Improvement Plan (NIP) provides incredible value to homeowners, neighbors, and the City's financial and community interest in preserving a safe, viable housing stock. In addition to thoughtful proposals submitted on NIP and in alignment with the above emphasis on human infrastructure deficits in the City, this Comment urges the establishment of a community liaison to address existing outreach deficits in city assistance programming. The NIP program provides a key opportunity to facilitate the development of internal city resources by learning from collaboration with the existing expertise and experience of OneHolyoke on NIP outreach.

### Recommendation 2B: Fund re-use cases for demolished properties

Federal guidelines and Holyoke's history of targeted demolitions have informed a cautious look at ensuring appropriate reuse cases for demolition of blighted properties--particularly those in downtown low-income census tracts. Typically, "open space" is cited as the reuse case for demolition of dangerous buildings, however, due to funding constraints this often amounts to nothing more than a vacant lot. To the extent ARPA funding is used for building demolition, the City should ensure compliance with the text and intent of federal guidelines for reuse by developing pocket parks and in-fill development. The creation of the Center City Plaza across from City Hall presents a good example of demolition reuse that achieves compliance with federal housing regulations, the City's Urban Renewal Plan and underlying tenets of social equity.

### Recommendation 2C: Conduct a comprehensive needs assessment of human infrastructure needed to meet all responsibilities charged to the Holyoke Board of Health under state and local law.

Even before COVID-19, the Health Department was tasked with myriad responsibilities under state and local law from enforcing all residential housing codes to air quality monitoring. A recent Harvard study found that landlords identified "deferred maintenance" as the primary

economic result of COVID-19 on their properties. An increase in housing code inspections and enforcement appears inevitable due to the upcoming expiration of eviction and foreclosure moratoriums. In my experience, the Board of Health is among the most heavily taxed and underresourced departments in the City. The performance of the Department throughout the pandemic is a testament to the leadership and commitment of its members, however, it is not a sustainable path forward for responding to changing economic conditions and responsiveness to implementing best practices identified in comparable communities. This Comment suggests that ARPA funding be utilized to retain professional personnel consultant to conduct an assessment of all the Board of Health's obligations under state and local law relative to existing staffing and professional development resources.

### **Economic Development**

#### Recommendation 3A: Ensure adequate personnel resources to respond to downtown business concerns around quality of life improvements.

The Massachusetts Local Rapid Recovery Planning Program conducted a needs assessment of downtown businesses to determine the impact of COVID-19 on business viability. ARPA funds should align to addressing the needs identified therein. In particular, downtown business owners cite deferred public maintenance as a major visual deterrent for pedestrian solicitation of downtown businesses. ARPA funding should be leveraged to address the prevalence of downtown trash accumulation due to insufficient trash receptacles and poorly maintained sidewalks in key pedestrian areas. The Holyoke City Council and Mayor should determine whether Department of Public Works staffing for downtown street sweeping and trash receptacle placement and maintenance is sufficient to meet quality of life needs.

Good afternoon,

My very brief comments after looking through the proposals are that I am in strong support of HG&E's request for funding for fiber infrastructure. This will help our city once again become a leader in information technology infrastructure. I hope OneHolyoke finishes existing projects before starting new ones. I am also inclined to support the requests from Providence Ministries and Enlace.

I hope there are additional opportunities for the public to learn about these proposals and provide feedback.

Re: Suggested Considerations for use of ARPA Funds

Holyoke Taxpayers Association is a 501 (c) 4 organization in Holyoke that has been in existence since 1932. One of the main issues we address annually is how the City of Holyoke uses it's collected tax revenues, staying within means, and not allowing increased tax rate settings "just because we can". Regretfully, right now Holyoke has the highest tax rates in the Commonwealth...both Commercial and Residential. Of the 351 cities and towns we come in first. That is absolutely NOTHING to be happy about. At the same time, we are in this position because of basic needs within the city combined with a total void of forward thinking. Decisions have been made that have taken property off the tax rolls at the same time expenses have sky rocketed for our businesses. This way of running the City for the last few years combined with deteriorating infrastructure, with a significant portion of the community not working, while Holyoke is one of the most generous communities in the Commonwealth for aide to residents, has placed the city in a precarious position when it comes to needed, infrastructure funds.

It is the recommendation of Holyoke Taxpayers Association to use the funds coming in from ARPA to shore up the infrastructure with "permanent" updates and repairs without having the city go out for bonding. There are more immediate needs than there are funds, but our list includes the city's water system; the combined sewer overflow repairs mandated by the Federal Government; repair of any leaking gas lines; repair of roads, bridges, sidewalks, intersections and traffic lights. We also would suggest that preparing city owned property to the point of being "shovel ready" so it can easily be converted to use with a restriction that it be taxable property, whether for business or housing.

We suggest that the funds be used for these mentioned essential services. We do not suggest the use of any of the funds for the "feel good" issues that once initiated would need to be maintained with future funding dependent off of the tax revenue collections.

This would be an opportunity to build up the fleet of the Department of Public Works, so we would not have weeks of uncollected trash due to broken vehicles. This would be an opportunity to building up the fleet of the Holyoke Police Department, so there would not be so many vehicles off the road due to age and repairs. This would be an opportunity to order one of the forward scheduled fire department vehicles, so we do not have to go to bonding.

It is our collective opinion that ALL of the funds expended within the City of Holyoke through the ARPA monies should be "onetime expenses" .....or for infrastructure repairs and/or items of significance that would not be easily part of the regular funding expenses that would come through the City Council.

The Holyoke Redevelopment Authority (HRA) is writing to express our strongest possible support for the Holyoke Housing Authority's ARPA application for the South Holyoke Homes Phase 2. The HRA is a partner of the HHA in this important undertaking to transform the neighborhood with an emphasis on affordable home ownership. The project has seen more than a decade of planning and was a primary focal point in the HRA's creation and implementation of the Commonwealth's largest Urban Renewal Plan and the revitalization efforts in South Holyoke. The HRA and HHA have worked in concert with the City of Holyoke to support the development through site control and infrastructure improvements. It is important to note that this project has received an overwhelmingly positive response from residents and community organizations.

I am a Holyoke resident who recently started adaptive rowing with Holyoke Rows, writing to support the joint application of Holyoke Rows and the Connecticut River Conservancy for funds to improve the Jones Ferry River Access facility. The pandemic has inspired many more people to come to Jones Ferry to enjoy the river and use the boats and programs that Holyoke Rows offers. That is a great opportunity to support public health outcomes from outdoor recreation and provide free and low cost programming to Holyoke families. But the increase in use has meant there is a critical need for better docks, buoys, signs, and safer ways to use the river.

I have been an athlete my whole life (primarily dance, biking, and rugby - for the latter, my college team was nationally ranked). I got really sick this past year, and ended up in a wheelchair. I really wanted to find a way to be active, for a combination of exercise, enjoyment, stress relief, and (perhaps most important in the present) to feel present in and appreciative of my body.

Holyoke Rows gave me a space to find myself, again. You see, in a lot of my life, I'm the guy in the wheelchair, the guy that (people assume) needs help.... out on the water, I'm just me. I can be present with myself, present with the water and other nature around me, and present with the moment. I can do something that not everyone can/does, disabled or able-bodied, and my body is no longer wrong or incompatible with the way society is set up, because water doesn't know the difference. It's really something special. Not only have I gotten much stronger physically, but also mentally -- rowing has been vital in my processing and self-acceptance as someone who has recently become significantly physically/visibly disabled by reclaiming the identity of "athlete", providing me a calm space to escape from an often hectic world, and remembering that *I'm still me*.

I remember sitting in my hospital bed at an inpatient medical rehab unit, googling "accessible sports in Western Mass." At that point, I'd spent many weeks admitted to acute and physical rehab hospitals, and just wanted to be outside and do something active and fun, again. In my research, Holyoke Rows popped up. Once I got up the nerve, I called Stephanie, the executive director/coach, and the first thing she said to me was, "I can put anyone, of any ability, out on the water, safely, who wants to go out." And that's exactly what she does at Jones Ferry, every day -- it doesn't matter if someone has a disability, what their age is, what their socioeconomic status is, what shade their skin is: everyone is welcome. Holyoke Rows is committed to reaching beyond the traditional rowing population to make passive river recreation accessible to the entire community by eliminating the physical, financial and social barriers to participating in our programs. This funding would allow Holyoke Rows to continue to make a difference in our community, and share the amazing opportunity of rowing with even more people.

From my first call to today, where I went out training for my first regatta, Holyoke Rows has given me hope, in a way that nothing else has during the pandemic and during my recovery/adaptation to a new way of navigating the world. Thanks for the opportunity to voice my support for important improvements at Jones Ferry that will be a real help in addressing the challenges and opportunities of the pandemic.

And people set up their chairs and fish off the dock. Smiling, laughing, talking with kayakers and rowers. But the dock space is small. I am now 66 years old and I broke my foot. Will Holyoke Rows have the ability to get the equipment my foot will need to enable me to row? Will the dock be long enough to allow me the extra time it will take to get into the boat? Rowing has been a lifetime healthy pursuit. Does it have to end because Holyoke Rows doesn't have the ability to meet the needs of the diverse people who use their resources? Holyoke Rows uses their money wisely. I trust them. They would enrich many peoples' lives if they receive the grant. Sincerely, Martha Kegeles



Murphy,

Rowing at Holyoke Rows since last fall has kept me sane and healthy during the pandemic. I had been rowing in Northampton with a team for 2 years when the pandemic ended our ability to use big boats and required us all to use single boats. Northampton had a very limited supply of boats, and required us to only go in groups of 6 with a coach. Costs were high, access low, and the season short: July-October.

I had been to Holyoke Rows for a

couple Regattas/races, and Coach Stephanie Moore would sometimes substitute for us in Northampton.

When Northampton's season ended in October, Stephanie reached out to me and offered use of the boathouse if I wanted to keep rowing, at a very reasonable drop in fee, important as I was unemployed during that time.

We rowed into December thanks to the warm weather, and celebrated Thanksgiving at the boathouse! There are many boats there that Stephanie works hard to keep in good repair to allow more people access.

In March, I got the word that Holyoke Rows would be on the water. I couldn't believe it- Northampton wouldn't have its docks in for months-end of May- and we were able to get on the water in singles in March! I had been training on the Erg rowing machine all winter and I couldn't wait to get on the water.

I was nervous about the early season rowing, but Stephanie was right there, in the launch, coaching us on using the pontoons and life jackets and wider boats. And as the season moved on, so did my

skills and confidence until I can take out the best boat in the boathouse with confidence, and even carry it all by myself.

Holyoke Rows is a unique community.

I have rowed with a blind rower in her 70's who tired me out despite my training. I was inspired to carry my own boat for the first time by a woman in her 80's-if she could do it, so could I!

We have rowers who are tethered to wheelchairs on land, but glide free on the water. It is amazing to watch them and see their confidence.

There are youth rowers and summer camps. Just today, the water was filled with campers in a kaleidoscope of boats, singles and kayaks and the motorboat.

I helped Stephanie carry back one of the boats with the heavy adaptive seat, and chatted with our 2 rowers in wheelchairs-one in is 60's and the other in his 20's.

On the water, a younger camper being towed in her kayak by her counselor noticed "The water is gentle today." Fast flowing, but gentle-she was right!

Every morning I row, I see eagles,  
herons, fish leaping from the  
water. I can row upstream to  
Holyoke, or downstream to  
Springfield. I wave to the  
fishermen who camp on the  
shores.

Tonight, we had a team potluck. I  
drove all the way from Deerfield to  
attend.

Saturday mornings there is yoga  
on the porch.

And there is a sense of  
community, and chores to help  
with around the boathouse.

When I hit a log and broke the  
skeg (rudder) off my boat,  
Stephanie didn't get upset; she  
just helped me find and caulk a  
new one on!

Fishermen use the docks and  
locals use the ramps for boats and  
jet skis. Everyone gets along and  
shares the limited space. Boat  
wakes /waves can swamp or  
overturn our smaller boats, so  
communication is important!

Holyoke Rows is an amazing and  
welcoming community. It aims to  
offer more services to more  
people.

The water levels have been so variable-especially high and fast this year. Giant logs hit our dock at the beginning of the season. We have to pull the docks in and out with daily changes in the water level.

With better docks and well-maintained equipment, we can introduce even more people to the joys of the river, healthy movement, and give them a chance to join an amazing community of people.

I became disabled, due to MS, about 11 years ago. Before that, I worked as an archaeologist and regularly spent time outdoors enjoying the many natural areas in western Massachusetts. One of the most difficult aspects of transitioning to life as a person who uses a wheelchair was the loss of opportunity to enjoy the many Nature areas in western Massachusetts as they change through the seasons.

The first few years of adjusting were difficult because I thought I had lost the ability to be in the natural world. I was very fortunate to work with an occupational therapist who told me about the adaptive rowing program at Holyoke Rows. I can't tell you what a joy it is to be out on the river, by myself, save for various water birds or the occasional eagle. As I became stronger, I began to row longer distances. In 2019, my cumulative distance for the rowing season was almost 200K! Holyoke Rows has given me both the opportunity to regularly spend time on an amazing river, and to set new goals for myself.

I am submitting this letter to express my support of the joint application of Holyoke Rows and the Connecticut River Conservancy for funds to improve the Jones Ferry River Access facility. The programs and facility at Holyoke Rows offered an important opportunity to exercise safely during the pandemic, something that continues to be important for people, like myself, who are immune-compromised and must continue to be careful about potential covid exposure. On the River, I can exercise as much as I want without worry.

As an individual on SSI, my financial resources are very limited. I feel enormously fortunate that the adaptive rowing program at Holyoke Rows is offered free of charge. I know there are many other adaptive rowers who are able to enjoy this program because it is free. There are ways this program could be made even more inclusive by upgrading the dock and using buoys and signs to make boat traffic safer for the range of ways people enjoy the river.

Please accept my letter of support on behalf of the proposal by Holyoke Rows and the Connecticut River Conservancy to make improvements at the Jones Ferry facility that will improve and expand programming available to the public as we find healthy ways to recover from the pandemic.





To start, I would like to disclose that I am the President of the Board of Trustees for Holyoke Rows, so I cannot claim to be fully objective in this matter. However, I am writing to you as a former Holyoke citizen and an avid participant in all manner of river activities. I am writing to support the joint application of Holyoke Rows and the Connecticut River Conservancy for funds to improve the Jones Ferry River Access facility.

At the start of the pandemic, when we had to suspend all programming out of the Jones Ferry boathouse, we had been gearing up to start our spring rowing season. As someone who rows regularly 3x per week, this was an incredibly difficult decision, but one that needed to be made. We quickly implemented new protocols, switched to only single sculling programs, and slowly invited folks back.

I had never sculled before the pandemic. But a few weeks into April, I was sculling at least four times a week and loving it. It got me through those early months of confusion, uncertainty, and fear. And I discovered that I wasn't alone.

The pandemic inspired many more people to come to Jones Ferry to enjoy the river and use the boats and programs that Holyoke Rows offers. We saw a huge uptick in kayaking memberships, sculling members, and camp signups. There were also significantly more people hanging out on the docks, jet skiing, boating, and using the outdoor areas at Jones Ferry to socialize. It was incredible to see the community using the river and our boathouse as a resource. It has been a great opportunity to support public health outcomes from outdoor recreation and provide free and low cost programming to Holyoke families. But the increase in use has meant there is a critical need for better docks, buoys, signs, and safer ways to use the river. This is clear to everyone who uses the Jones Ferry facilities currently.

The goals of Holyoke Rows include increasing river recreation accessibility to everyone in Holyoke. However, in order to expand, we need support.

I understand that Holyoke Rows, with the support of the Connecticut /River Conservancy, has applied for ARPA funding.

As you know, from my prior involvement both as a Conservation Commissioner and a Holyoke Rows supporter as well as a former chairman of the Board of the Connecticut River Watershed Association, I am in solid support of the Connecticut River access which the Holyoke Rows programs provide for the City of Holyoke.

Despite having been founded because of the River, Holyoke residents have long been divided from the River by the railroads whose tracks follow the River's course. This meant, for over a hundred years, that Holyoke citizens were denied to use of the River for recreational activities. This has been a particular hardship for those living closest to the river in the lower wards of the city. These people, many of whom live at poverty and low income levels, are unable to take advantage of the great natural resource which could - if properly accessed - allow them the advantages of both passive and active recreation at Riverside. There, they could fish, hike, go boating and enjoy the scenery of this beautiful river and its surroundings.



In addition to this service, the Club conducted amazing work serving food to hundreds of kids a day, closing the digital divide for students by issuing WIFI hotspots and computer devices, establish learning pods for youth so that they could continue their education remotely.

Through Federal funds allocated to the City of Holyoke, the City has the opportunity to make an investment in Holyoke's youth for many years to come. Through the Boys & Girls Club's strategic plan, this first round of ARPA monies can be used to increase the capacity of the Club by 40%, increasing their ability to serve more than 215 youth from their current constrained capacity of 150 youth. Long waitlists at the Club have existed for over the last two decades and there is no question that the Holyoke community has a need and demand for proven youth services like the Boys & Girls Club.

By reimagining the Club's current space, the Boys & Girls Club looks to create a 2,500 square foot childcare space. As our Commonwealth continues on the path of economic recovery, the shortage of available and affordable childcare has prevented many families, including those in Holyoke, from entering back into the workforce. Through this funding the City of Holyoke has the opportunity to make a once in a lifetime investment not only in our youth, but in Holyoke's many working families as well.

I am writing to provide the highest level of recommendation as well as express the urgent need to support Boys & Girls Club of Greater Holyoke American Rescue Plan Act (ARPA) funding applications. Across the commonwealth, COVID-19 pandemic changed life as we know it. At that time, the organization that stepped up fill vital needs was the Boys & Girls Club.

The pandemic exposed many gaps within our social service infrastructure. Unfortunately, the reality is that we face a childcare crisis and there are limited youth service organizations in Holyoke. When the vast majority of agencies were forced to close, reduce capacity, or pivot to virtual services due to COVID-19, our community relied heavily on Boys & Girls Club of Greater Holyoke.

Since March 2020, Boys & Girls Club of Greater Holyoke was on the frontlines providing essential youth services.
