MEMORANDUM OF AGREEMENT

This Memorandum of Agreement is entered into by and between the City of Holyoke ("City"), Professional Supervisors Union ("PSA"), and Maureen Tisdell ("Employee") employed as an Assistant Director in the Parks and Recreation Department.

WHEREAS, the City and the PSA are parties to a collective bargaining agreement, effective July 1, 2021 to June 30, 2022 ("Contract");

WHEREAS, Maureen Tisdell is an employee of the City of Holyoke by the Contract;

WHEREAS, the Mayor has appointed Maureen Tisdell as Temporary Acting Director of Parks and Recreation, effective January 18, 2022 and continuing for a period of sixty (60) days; and Maureen Tisdell has accepted said temporary appointment;

NOW THEREFORE, the parties agree as follows:

- 1. Maureen Tisdell agrees to take a leave of absence from her position of Assistant Director for the duration of her temporary appointment.
- 2. The parties agree that during the temporary appointment, the position of Assistant Director shall not be considered vacant. Maureen Tisdell may return to her position of Assistant Director at any time, but no later than the end of her temporary appointment, the revocation of her temporary appointment, or the appointment of a permanent Director of Parks and Recreation, whichever is sooner.
- 3. During her temporary appointment, the parties agree that Maureen Tisdell shall continue to pay union dues and shall retain all benefits under the Contract, but shall not be entitled to overtime compensation, call-in pay, or stand-by pay for the duration of her temporary appointment.
- 4. During her temporary appointment, the parties agree that Maureen Tisdell shall be paid a total annual salary of Sixty Five Thousand Three Hundred Fifty One Dollars and Forty Cents (\$65,351.40).
- 5. The parties acknowledge that the term of the temporary appointment may be extended in writing by the Mayor, and in such case, the provisions of this Memorandum of Agreement shall remain in effect.
