

## Periodic Inspections Required for Occupancy

### 780 CMR 1001.3.2

Below is a list of all design professionals (Architects or Engineers) who have provided affidavits in compliance with 780 CMR 1001.3.2 to the City of Holyoke Building Department in the last 12 months\*. Section 1001.3.2 states that the testing and certification of all exterior bridges, steel or wooden stairways, fire escapes and egress balconies shall be examined and/or tested, and certified for structural adequacy and safety every five years, by a registered design professional, or others qualified and acceptable to the building official. The list was updated 3/15/2021, and will be updated every Jan 1st.
