REGULAR MEETING OF THE CITY COUNCIL April 5,2022

The meeting was called to order by President McGee at 07:08 PM.

The Clerk called the roll. Absent members: 0 Present Members 13 (Anderson-Burgos, Bartley, Givner, Jourdain, Maldonado Velez, McGee, McGiverin, Murphy-Romboletti, Puello, I. Rivera, J. Rivera, Tallman, Vacon).

The Pledge of Allegiance was recited..

The name of Councilor Tallman was drawn to head the roll call voting.

LAID ON THE TABLE

Motion was made and seconded to suspend the necessary rules to remove item 1 from the table. The Committee on Charter and Rules to whom was referred an order that the City Council Administrative Assistant appointment be a two year appoint that coincides with the City Council terms Recommended that the order be adopted.

---> Report of committee was received and adopted on a call of the roll of the yeas and nays 13--Yeas --0 Nays.

Motion was made and seconded to suspend the necessary rules to remove item 2 from the table.

The Committee on Ordinance to whom was referred an order The City amend its zoning ordinances to allow for front yard pools by special permit of the City Council and to make any other necessary changes to the Swimming Pool ordinance. Refer to Ordinance Committee and copy to Building commissioner said special permit would be reviewed as part of a public hearing process. The current zoning for Swimming Pools (sec 4.5.2) as currently written, states:

The wall of a swimming pool shall not be located less than eight (8) feet to any dwelling or accessory structure, six (6) feet from any rear or side lot line, and ten (10) feet from the street line. A pool shall not encroach into any front or side yard of a parcel. In the case of corner lots, pools shall not be constructed within the front yards of the lot. Recommended that the order be adopted.

Councilor Anderson-Burgos stated that following the vote at the previous meeting, he had since understood the situation better and was changing his position to support the change.

The Ordinance passed its second reading.

The Ordinance was passed to be enrolled.

The Committee has considered the same and find that it is truly and properly enrolled.

PUBLIC COMMENT

(5:15)

Debra Vega, 17 Linden Street, expressed her support of using CPA funds to support restoration of the former O'Connell property that was then owned by Girls, Inc of the Valley. She then stated that while she was a longtime board member of Girls, Inc, she intended to speak from the perspective of historic preservation. She noted that as a resident of a historic neighborhood abutting the property, she had an interest in maintaining the historic integrity of the neighborhood for the benefit of the neighborhood as well as the girls that would be using the building into the future. She also expressed her belief that most taxpayers would support use of the funds to support preserving the building.

Aviannah-Leigh Salters, 77 Lyman Street, stated she had been a member of Girls, Inc since 2017. As a rising senior, she stated that she would not have been as prepared to attend college if not for Girls, Inc. She noted she had the opportunities to intern for the state representative and state senator as a result of

her involvement with Girls, Inc. She then stated that the funding for the Girls, Inc building would be awesome and suggested that Holyoke taxpayers agreed.

Crystal Briggs-Salters, 77 Lyman Street, stated that as a mother of a Girls, Inc mother, she was in support of the funds going to the building. She stated that her daughter and many other girls had benefited greatly from the Girls, Inc program. She then stated that depriving the girls of use of the building would be detrimental to generations of girls in the city.

Jazlene Serrano, 17 Beacon Avenue, stated that she was loved Girls, Inc because they accept her for who she is, and that it is her happy place where she can express herself. She added that she looked forward to being in a bigger building to be with Girls, Inc.

Shannon Bliven, 35 Martin Street, stated she was the Chair of the Holyoke Bike/Ped Committee as well as marketing and community outreach for Valley BikeShare. She stated she was in support of the Girls, Inc building repairs. She expressed her support for orders that would result in a reduction of speeding issues, noting that thee had been more than on fatal pedestrian accident in the current year.

Jeff Trask, 28 Central Park Drive, stated his intent to address an order related to the job description of his role as Emergency Management Director. He stated that the reason for the look at the job description was to professionalize the job and codify the duties of the position. He noted it had started off as a part time position. He then stated that it had become the role of the Fire Chief, adding that it had not been the best decision as the Fire Chief would have their own responsibilities during an emergency situation. He then emphasized the intent was to make sure the duties and responsibilities were clear, particularly when someone else eventually took over the role.

John Rivera, 125 Cabot Street, expressed his support of use of CPA funds for restoration of the Girls, Inc building. He then expressed support for items 68, 59, and 61. He emphasized the value of supporting a Fair Share Amendment, adding that it would support the city in many ways and expressed hope that the city could work to implement it.

President McGee stated that there were issues with the interpreters and that if any live interpretation was missed, there would be interpretation available in the video recorded to be posted online later.

He then emphasized that the Planning Board only recommends, adding that it would need to be received before the committee could make a decision.

PRESIDENT'S REPORT

(21:50)

President McGee stated that badges for city councilors was being worked on by the police chief. He also stated that he attended an event for the opening Woodstone Restaurant on Hampden Street, adding that Councilor Tallman, Councilor I. Rivera, Councilor Givner, as well as the mayor were in attendance. He wished them well on their new business.

He then stated that the Chamber event for the following day would be moved to sometime in June.

REPORTS OF COMMITTEES

(23:05)

President McGee stated that items 26B, 26C, and 26D would not be taken up due to not having signed legal form available.

The Committee on Ordinance to whom was referred an order Petition of Hybrid House LLC for a Marijuana Manufacturing Establishment at 55 Jackson St

have considered the same and Recommended that the order be adopted with the following conditions:

- 1. That the owner of the building always pay the commercial property tax rate to the extent allowed by federal, state, and local laws for the duration of the Special Permit.
- 2. That the business retains a minimum 30% Holyoke residents for non-security jobs.
- 3. That the hiring preference be given to security personnel that are retired Holyoke police or are a retired member of another police department that now lives in the city of Holyoke.
- 4. There shall be no marijuana consumption allowed on site.
- 5. That the hours of operation be set according to City ordinances.
- 6. That the applicant must abide by Massachusetts General Laws and guidance's from the Cannabis Control Commission.
- 7. That the petitioner/applicant shall conform with city and state health laws, rules, and regulations, including odor nuisance controls, for the duration of the permit.

UNDER DISCUSSION:

Councilor Vacon stated that the applicant responded to all open questions from the Planning Board. She also noted that there were seven standard conditions for marijuana establishment special permits, adding that the seventh included odor nuisance controls.

Councilor Murphy-Romboletti stated that she was advised by the State Ethics Commission to abstain from special permits related to cannabis due to her employment. She then stated that some cannabis companies ask her to put her EForAll program into their social impact plans. She then asked if she was handling the situation correctly.

President McGee clarified that anytime conflicts arise, councilors state their conflict and can then leave the room or just abstain when the vote comes up.

Councilor Bartley noted that there had been a news article as well as a letter from the Chair of the Planning Board criticizing the City Council about ordinances related to marijuana. He then emphasized that the city had bee more welcoming to the industry than any other city in the Commonwealth. He then stated that the ordinance issue had been an innocent error. He then stated that he found such criticism unfair and offensive. He recalled that councilors had spend countless hours working on the original marijuana ordinance. He then asked that the Council receive some credit for allowing many industry businesses to come into the city.

---> Report of Committee received and Adopted on a call of the roll of the yeas and nays --Yeas 12--Nays 0--Absent 0. Councilor Murphy-Romboletti did not vote or participate in discussion on this item. Referred to the Ordinance Committee.

Motion was made and seconded to lay items 26B, 26C, and 26D on the table.

The Committee on Ordinance to whom was referred an order that the City Council amend Holyoke Zoning Ordinances Section 7.10.5.3(a) by deleting "other

use as listed in Table 4.3 of Principle uses" and inserting the following language in its place: "any pre-existing public or private school providing education in pre-kindergarten, kindergarten, or any grades 1 through 12" or other such legal form sufficient to resolve any uncertainty over the interpretation of the existing ordinance as compliant with state law.

UNDER DISCUSSION:

Councilor McGiverin deferred to Vice Chairman Jourdain for the committee reports, noting he had not been in attendance for most of the meeting due to another commitment.

Councilor Jourdain stated that the CPA Committee chair presented on two proposals: \$350,000 for Miracle League to take care of park renovations at Kennedy Field for a project called Playground for All. He added that it would be playground intended to be accessible for children of all abilities, specifically for those with physical and cognitive disabilities to play safely. He then stated that the other proposal was for Girls, Inc under the category of historic preservation. He also stated they would like to take care of preservation work at their newly purchased building at 480 Hampden Street, formerly the O'Connell office as well as a law office. He stated they would be doing masonry work, façade work, and reconstruction of the slate roof. Noting a majority of the committee opposed the project, he stated that the original spirit of the CPA law was to pay for public projects that there may not otherwise be public resources for rather than to private organizations. He also noted that the purchase of the building by Girls, Inc also took the building off of the tax rolls, adding that it was a loss of \$35,000 in tax funds to the city. He also expressed concern about establishing a precedent if they started opening CPA funding to private organizations, suggested that many other organizations may begin making requests. He also emphasized that many city buildings such as City Hall, the City Hall Annex, the Wistariahurst Museum, and Scotts Tower. He also noted that the Holyoke Taxpayers Association had expressed opposition to funding the project. He also suggested that the work on the building could be defined as maintenance which would be forbidden under the state CPA law.

Councilor I. Rivera stated that as a member of the state's steering committee for the CPA, he asked about eligibility of the project. He then stated that he was encouraged to identify a public benefit to funding the project. He also stated that he had many family members that had benefited from the program. He then emphasized that the project request was about the historical benefit of fixing the building, a benefit that would remain after Girls, Inc was to eventually leave the building. He then expressed concern that the Holyoke Taxpayers Association would contact councilors to pressure them to vote a certain way. He also emphasized there was a civic engagement value of having several members of the organization at the

meeting to advocate.

Councilor Givner reiterated that Girls, Inc had a public benefit, suggesting that the benefit to the city was more than \$35,000 in lost tax revenue. She then noted that the organization was producing young leaders, adding that investment in children through a stimulating environment, the city experiences a great benefit. She also suggested that the investment would encourage then young ladies to return to Holyoke after taking time to see more of the world. She also emphasized that the young women of the organization enjoy the benefits without having to pay any cost.

Councilor Murphy-Romboletti emphasized that this would not be the first time the CPA had funded a non-profit organization for something that is not necessarily a public project. She noted that funding had been approved for Valley Opportunity Council to rehab properties to turn into housing, for affordable residential properties on Jackson Street, as well playground repairs for property owned by the Boys and Girls Club. She then reiterated that this project would provide a public benefit.

Councilor Bartley suggested that the Law Department offer clarification to advise on whether or not funding the project would be contrary to state law, adding that the matter could be tabled if they needed more time.

Motion was made and seconded to suspend the necessary rules to allow the Law Department to address the Council.

Atty Bissonnette stated that as he was unfamiliar with the referenced state law section, he would need more time to research the question.

Councilor Jourdain clarified that his question specifically was to ask if the proposal would constitute maintenance of the building. He then reiterated that if true, it would be one of the prohibited uses of the funds.

Councilor Bartley commended the previous speakers for making great points, as well as the members of Girls, Inc for their tremendous poise. He then suggested that the matter be tabled for the next meeting.

President McGee suggested that the motion be withheld until other councilors seeking to speak had an opportunity, noting that a motion and second to table would end the debate.

Councilor Vacon noted that she had a late file order seeking a legal opinion relative to the question. She then commended the advocacy of the members of Girls, Inc. adding that her goal was to assure that the finding would be within the guidelines of the CPA law.

Motion was made and seconded to suspend the necessary rules to take up Late File B out of order.

VACON -- that our City Solicitor provide a legal opinion re: is the use of CPA funds for a roof project for property owned by a private corporation an allowed use of CPA tax dollars?
---> Received and referred to the Law Department.

Councilor Puello stated that his main concern for voting against it in committee was the stated historical aspect of the building. He then thanked the organization for giving him a tour of the building and explaining the history in more detail. He then expressed an interest in hearing a legal opinion before taking a vote.

Councilor McGiverin stated that the historic component of community preservation was about saving any historic building that could be saved, adding that he believed CPA had done a good job vetting the project. He noted that the building had been the headquarters for the O'Connell corporation, a developer that stretches from Maine to New York. He then suggested that hearing from the Law Department would be a reasonable step. He then asked that the votes for Miracle League and Girls, Inc be separated to allow the first project to proceed without needing to wait for a vote on the second.

Councilor I. Rivera asked for clarification if the issue with funding maintenance was due to Girls, Inc being a non-profit and not city-owned. He noted that maintenance projects for city-owned projects such as painting and rooftops work at Wistariahurst had been funded through the CPA.

Councilor Jourdain clarified that the law barred any maintenance project. He then stated that the rule not being followed in the past was not a valid reason to continue not following it. He noted he had not been on the Council for the last four years, adding the CPA law had been adopted just prior to him leaving the

Council before. He then stated that while the city does not handle affordable housing, such projects could be additional leeway. He recalled that the arguments in favor of a vote to approve the CPA tax centered around supporting projects that the city may not be able to fund. He then expressed his willingness to support an expanded definition of projects to improve and repair city property were addressed first. He also suggested that deed restrictions should be considered if organizations later sell their property after using the CPA funds to improve their property.

Councilor Murphy-Romboletti expressed frustration that she had been receiving mixed messages, being expected to follow what had been done in the past with some issues and not for other issues. She then stated that the CPA Committee should be trusted, noting they had done the work and likely had an understanding what they could use the funds for.

Councilor Givner emphasized that the CPA Committee existed to do the work of researching the requests and understanding the laws so that the City Council did not need to do it. She stated she would support the project because the CPA Committee had recommended it.

Councilor Maldonado Velez echoed the sentiments of the previous two speakers, suggesting that the motivations sometimes seemed centered around destruction.

He then made a motion to approve both projects. Councilor Givner seconded the motion.

Councilor Anderson-Burgos emphasized that the CPA Committee members had been entrusted to do their work. He also suggested that while the CPA funds were not meant for maintenance, the slate roof of the building was a matter of preservation, adding that it was a part of the history of the building. He also noted that only two of the committee members voted against recommendation as two members had not been able to attend. He also commended the members of Girls, Inc for their advocacy and fighting for what they believe in/.

Councilor McGiverin expressed that while he was convinced the project was about preservation on a historic building, he respected the need to get a legal opinion on the question of maintenance. He then made a motion to separate the vote for the two projects. Councilor Vacon seconded the motion. Motion passed on a voice vote.

Councilor Bartley made a motion to approve the \$350,000 allocation for Miracle League. Councilor Vacon seconded the motion.

President McGee expressed that the volunteers of the Miracle League were a phenomenal group engaged in an amazing achievement.

---> Miracle League of Western MA-Report of Committee received and Adopted on a call of the roll of the yeas and nays --Yeas 13--Nays 0 --Absent 0

Councilor Bartley made a motion to lay the Girls, Inc allocation on the table. Councilor Vacon seconded the motion. Motion failed on a show of hands vote.

Councilor Bartley expressed that volunteer boards were made up of wonderful people but questioned the implication that they were made up of experts. He also emphasized that the boards they did not have legal representation. He further emphasized that the City Council makes the final decisions after accepting or rejecting the recommendations of the boards. He then stated his intent to table was to address a legal question that had come up, noting a reasonable delay of a few weeks would not make a difference.

Councilor Vacon stated that it would not be obstructive to get a legal opinion when there had been practices that had not been subjected to legal questioning. She also emphasized that it was the job of the elected city councilors to make a decision and the Council should discover if mistakes had been made in the past that should not be continued.

Councilor Jourdain conceded that he expected to be in the minority on the Council on most votes, noting he had a different perspective and philosophy than many others on the Council. He then suggested that the Council should be considering how to protect taxpayers by assuring all details are addressed. He then suggested that too many decisions are made based on what people are passionate about. He then stated he had a duty to raise issues when they come up, adding that people should make sure they know the law before deciding they don't need a legal opinion. He also emphasized that saying yes to one project was inherently saying no to another, adding that it was a matter of prioritizing things. He then questioned why more projects for public buildings were not being submitted. He also emphasized that there were

additional open questions on whether the city council could authorize use of funds that wasn't allowed, if the funds could be retracted if granted and then found not to be allowed, or the city's potential liability if accidents happen on a city-funded project.

Councilor I. Rivera stated that all projects are run through the state coalition. He also stated that deeds come with a 30 year restriction which would require the funds to be returned if the property is sold within that time. He also stated that the Law Department does attend CPA Committee meetings. He also stated that he contacted to Chair of the state's CPA Committee to assure the project would be eligible. He then questioned the weight being placed on the position of the Taxpayer's Association over that of other people and organizations. He added that the project had been approved by the Mass Historical Commission.

Councilor Murphy-Romboletti made a motion to condition approval of the fund disbursement on a legal review of the project. Councilor Anderson-Burgos seconded the motion.

President McGee asked for councilors to avoid calling each other and other organizations out directly. He then recalled attending the groundbreaking of a new hospital and hearing that working with Council and various committees had been a privilege, further emphasizing that opinions from various positions should be respected. He then asked that the members of Girls, Inc not see anyone's opposition to funding the project as opposition to mission of the organization itself.

Councilor Tallman reiterated that the project was not about Girls, Inc but about historic preservation of a building, and of the history of Holyoke. He then emphasized that the CPA Committee vetted the project. He then stated that he had to miss the committee meeting due to celebrating his anniversary, he would have supported the project.

Councilor Maldonado Velez asked to clarify if the implication of the motion made by Councilor Murphy-Romboletti was that the Council would need to wait for the Law Department to respond.

President McGee clarified that the motion would allow the Council to vote and that the disbursement of the funds would be pending a legal opinion.

Councilor McGiverin stated that they had not been able to reach Mr. Maldonado had been able to be reached for the 385 Main Street petition and that when Mr. Solorzano was contacted for the Vendor License application, he did not know anything about the petition. He then stated that the petitions had to be disposed of without prejudice in case the applications were resubmitted.

Councilor Jourdain emphasized that the funds were coming from within the department's budget. He then stated that the department had many unfilled positions, adding that the overtime funds were needed to assure appropriate staffing levels. He then stated that even with this transfer, it would end up being the lowest amount of overtime used in a fiscal year in recent history.

Councilor McGiverin added that the Police Chief had been challenged to lower overtime costs when he had taken the job the previous year and had done a good job of it. He noted that the previous average of around \$38,000 of overtime per pay period had been lowered to below \$35,000.

Councilor I. Rivera asked if the overtime account would be better funded for their expected needed in the coming fiscal year's budget.

President McGee stated that part of the issue was budgeting for 93 patrol officers and having only 83 officers in the department, forcing people to work overtime.

Councilor I. Rivera suggested another system should be in place, expressing concern that a lot was being spent on overtime. He suggested comparing overtime spending in other communities. He suggested that auxiliary police should be used more to fill in for overtime.

Councilor McGiverin emphasized that the city had not chosen to shrink use of auxiliary but had been forced to due to a recent police reform law. He then stated that overtime requests should come before the City Council periodically to allow the departments to explain the need. He suggested that this had led to reduction of overtime spending.

Councilor Tallman stated that the overtime is often discussed during budget hearings and funding is set to allow for them to come back to explain their needs.

Councilor Jourdain suggested that if done the right way, a consultant would perform a cross review of all departments to compare how overtime is used and approved among several communities. He added that they should also compare benchmarks and standards.

Councilor Givner expressed her understanding that the need for departments to get Council approval for overtime transfers had been implemented for more transparency because there had been abuses in the past.

President McGee stated it was for a better understanding of how overtime is tracked.

Councilor I. Rivera asked if patrolmen and supervisors had different line items. He noted that someone higher on the scale working overtime would be at a greater cost. He added that while there was a process for determining who works overtime, there should be a mechanism to make it more beneficial for the city as a whole.

Councilor Tallman noted the difficulty in getting newer officers to work overtime, adding that older officers were often forced to due to staffing needs.

Councilor Murphy-Romboletti stated that the committee reviewed the block grant proposals as well as the recommendations from Community Development, the Citizens Advisory Committee (CAC), and the mayor. She then stated that there had not been major changes from the recommendations, other than allocating \$100,000 for sidewalks. She noted that funding had been moved from a micro-enterprise and small businesses grants proposal, adding that they had advocated for funding that proposal if additional funds become available following HUD's final allocation. She then stated that there had been questions about the cost for the Sparky the Dog fire training safety suit requested from the Fire Department. She added that the costs had been due to high quality of the suit, noting it had last been purchased 17 years ago. She also stated that a question came up about the first time home buyers program, adding that the program was free for Holyoke residents and the majority of the people who take the class are Holyoke residents.

Councilor McGiverin observed that the presentations of CDBD proposals by Alicia Zoeller makes the job of the committee a lot easier. He then noted that the Council makes recommendations while the mayor has the final say on the allocations. He then expressed hope that the mayor would give deference to the Council recommendations, specifically noting the value of the youth softball league and the need to help more families participate who may not be able to afford it. He then made a motion to adopt the resolution to accept the funds with the recommendations. He then expressed concern that funds from federal revenue sharing had decreased greatly in recent decades. Councilor Bartley seconded the motion.

Councilor Puello echoed Councilor McGiverin's sentiments about Ms. Zoeller. He then noted that he had questions at the committee meeting. He then stated that he had been concerned about a detail in the first time homebuyers proposal that appeared to show a \$100 fee for participants, adding that it had been an error. He also expressed that his concern remained about the \$3,500 quote for the Sparky the Dog suit, adding that he could find the same costume on Amazon for much less money. He then suggested that the cost may be that suit was coming from a national fire safety supplier.

Councilor Jourdain stated that the many great programs were being supported, specifically emphasizing the value of the school playgrounds as well as \$40,000 going to Margaret's Pantry. He noted he had heard

from many families struggling to stretch budgets, adding that Margaret's Pantry had long served a mission of providing food programs to the most needy in the community.

Councilor Bartley noted that the recommendations of the CAC had been taken seriously. He then suggested that a councilor needed to be appointed to serve on the CAC. He then stated that there had been some unique and unusual projects among the proposals. He specifically emphasized the unanimous agreement to add additional funds to the youth softball league allocation. He then recalled that the process had been a transparent one while former mayor, Terry Murphy, had served, adding that he had confidence that Mayor Garcia would continue to have an open process going forward.

Councilor I. Rivera echoed the sentiments of his colleagues relative to the value of Margaret's Pantry as well as the youth softball league, adding that they were both a benefit to the community. He then expressed concern with the way the Scott's Tower project was being presented. He emphasized that CDBG funds were supposed to be spend in specific areas in the community, specifically in low income areas. He suggested that using Scott's Tower's proximity to Beaudoin Village to make it eligible might be a stretch.

Councilor J. Rivera noted that in an email explaining Sparky the Dog, the suit the department uses comes installed with a dual fan cooling system to keep the operator cool. She then suggested that in a school with many children surrounding the person, it could get very hot.

Councilor Givner noted that as someone who had worked in costuming, she could attest to the differences in the quality of costumes between Amazon and the Robotico company the department was getting it from. She added that companies will often steal the images of quality costumes and use them for their listing but that the actual costume wouldn't hold up beyond one wear. She suggested that the previous one lasted for 17 years because they spend the money on a quality costume.

Councilor Tallman noted that he had intended to attend the meeting after another commitment, but the meeting had finished before he arrived. He then expressed his appreciation for the funding of sidewalk repair as well as funding for the warming center. He then stated that while he agreed with concerns about cost for Sparky the Dog, he understood that the previous one had held up a long time and its value would be earned in saving even one life.

Councilor Maldonado Velez asked to clarify what the process would be to ensuring that the funds would be spend for the specified purposes.

UNDER DISCUSSION:

Councilor Murphy-Romboletti stated that 3 responses to the RFP had been submitted for this property, adding that they were all for the same amount. She then stated that the proposal would be for an existing business, currently located on Dwight Street. She stated they would renovate the space and turn it into commercial space on the first floor and residential space on the second floor.

Councilor Puello expressed his intent to oppose the project. He then suggested that the deals the city was entering into with these properties could be better. He recognized that while the business planned to invest a lot into the building, there were open questions on if they would actually spend that money as well as what rights the city would have when the project was done. He also expressed concern that they would rehab the building and rent out apartments at market rate. He then suggested that the apartments be offered at 75% poverty level for a specified period of time. He clarified that he was not against the business but believed the proposal was too good and details needed to be changed.

Councilor McGiverin noted that the property had been condemned at one time. He then stated that the goal of the city in taking over properties is to return them to the tax rolls as soon as possible. He then emphasized that the sale price takes into account what the new owner planned to invest into the property. He then reiterated that the building was about to be torn down. He then suggested that downtown needed more market rate housing so that the return matched the investment put into the property. He also emphasized that the city has the right to execute the reverter clause put into all sale contracts if the purchasers fail to do what they said they would with the properties.

Councilor Anderson-Burgos stated that investment would be good for Holyoke. He added that High Street was on its way to helping boost the economy of the city. He then stated that any investment in a building that was near being demolished was a god thing.

Councilor Bartley expressed appreciation that there would be private investment in the downtown area. He noted that the purchased had an investor as well as backup investment, if necessary. He then emphasized that what was an eyesore was going to be become commercial and residential space. He then commended Councilor Puello for bringing up concerns with the sale price, noting a situation with a building that had come before the Council, had been rejected, and later was sold for 10 times the original offer resulting in much greater investment. He then stated that while he would vote for this proposal, he recognized the validity of the concerns being expressed and hoped that they would spark better conversation about consideration for more appropriate sale prices.

Councilor Jourdain recalled a questionable deal in the past when the city sold the old Dean lot and allowed CVS to place a clause in a proposal precluding any retail development on any adjacent parcel, leading to an adjacent parcel's value dropping and being sold for much less than it could have been. He then stated he would support this project, adding that he recognized there would be difficulty getting a traditional loan for the project. He also stated that there should be assurances that a reverter clause was in place. He recalled one property went through 4 different reverter extensions before the owner eventually gave the property back to the city.

Councilor Maldonado Velez noted that he and Councilor Puello filed an order to assure that the process for RFP's was more transparent.

Councilor I. Rivera asked to clarify that the reverter clause could lead to the city taking the property back and having to take it down if the purchaser didn't follow through with their plan.

He recalled several buildings the city acquired and become major safety issues for the surrounding sidewalks, streets, and adjacent properties.

Councilor Maldonado Velez expressed his understanding the reverter clauses have benchmarks built into them to assure purchasers are meeting specific timelines for development of the properties.

Councilor Puello reiterated that the property had multiple offers, adding that the prior owner had acquired it through RFP, emphasizing that interest in the property put the city in a position to put conditions on the sales and be selective on who they are sold to.

Councilor Jourdain made a motion to add a two year reverter clause to the sale. Councilor Puello seconded the motion.

Councilor McGiverin stated that while he had no issue with the motion, he questioned if the City Council had the authority. He emphasized that the mayor negotiates the sale and the City Council approves it.

Councilor Bartley recalled that reverter clauses were already standard language in the sales.

President McGee suggested that while he was sure that was accurate, he believed the intent of the motion was to assure that it was there.

Councilor Jourdain stated that his intent was to avoid leaving nothing to chance.

Councilor Anderson-Burgos suggested that the Law Department attended meetings to address these kinds of questions.

Motion was made and seconded to suspend the necessary rules to allow Atty Bissonnette to address the Council.

BARTLEY, Puello Ordered, that The Mayor develop a schedule of projects/programming to the CC's DGR committee to be funded via marijuana stabilization funds. If possible, please send said schedule on a quarterly or semi-annual basis in order to promote consistent and efficient project development. Copy to Mayor and City Auditor.

BARTLEY, Givner, Puello, Rivera_J Ordered, that Ordered that the Holyoke City Council review and amend Section 5.4 of the Zoning Ordinance to allow for Accessory Dwelling Units (AUDs) in the DR zone, in addition to amending Section 2 Definitions, and any other sections that may apply to allow this use in the DR zone.

Accessory dwelling unit (ADU) is a smaller, independent residential dwelling unit located on the same lot as a stand-alone (i.e., detached) single-family home. (planning.org)

GIVNER Ordered, that That a handicap sign be placed at 204 Oak St. for Josephine Rivera, Placard #P59864114.

---> Received and referred to the Ordinance Committee.

GIVNER Ordered, that With community support: That the city post a snow parking restriction on its website at least twelve hours before towing begins. In other words, towing will not begin until the parking restriction has been up on the website for at least twelve hours.

---> Received and referred to the Ordinance Committee. Copy to Public Safety.

GIVNER Ordered, that With community support: That the city paint new crosswalks and stop lines on the t-bar of Brown and Laurel. People run the 3 stop signs constantly. If you're a driver who doesn't know the area, it can be confusing as to where to stop and when. These were not repainted last year and are now completely faded. This intersection has become extremely dangerous for drivers and pedestrians alike. There have been both serious accidents and many near misses.

---> Received and adopted. Referred to the DPW. Copy to Mayor Garcia.

GIVNER Ordered, that With community support: That the Holyoke City Council adopt, and create a method of enforcement for, a wage theft ordinance for all contractors doing projects for the city or receiving special tax incentives by the city similar to Easthampton and Springfield with the following purposes: prevent misclassification of employees as independent contractors; assure that employers are paying all payroll taxes and workers compensation premiums; comply with state laws governing the payment of prevailing wages; assure that contractors provide opportunities for Holyoke residents, veterans, people of color and women.

---> Received and referred to the Ordinance Committee.

GIVNER Ordered, that With community support: Create single lane out of two laned one way roads in ward 4 to include:

- -Beach between Hampshire and Hampden Streets
- -Linden between Hamden and Sargeant Streets
- -Hampden between Lincoln and Pearl Streets
- -Dwight between Nonotuck and Linden Streets

If we are serious about wanting safer streets for our residents we must create deterrents to speeding. By eliminating these lanes and turning them into marked turning lanes, added parking, and additional bike lanes, we will discourage speeding while creating traffic safety through clarity, and additional parking. This would also encourage biking and make our neighborhood streets safer for all who use them.

---> Received and referred to the Ordinance Committee.

GIVNER Ordered, that With community support: That the city revisit existing traffic light projects and consider rotaries in their place. Traffic circles require no lights and therefore no maintenance cost. They are also less expensive to build than traffic light intersections. They are proven to deter speeding as they

require reduced speed upon approach, during use, and returning to travel lanes. They force driver attention adding to overall safety. Other U.S. research has shown that roundabouts lead to 37% less collisions and 90% less fatalities than traffic lights. Conversion to roundabouts also lead to quicker traffic flow, with a reduction in delays of anywhere between 20% and 89%. Our neighboring communities have studies reflecting a wide range of benefits to traffic circles and roundabouts including the following: "A 2001 Institute study of 23 intersections in the United States reported that converting intersections from traffic signals or stop signs to roundabouts reduced injury crashes by 80 percent and all crashes by 40 percent. Similar results were reported by Eisenman et al.: a 75 percent decrease in injury crashes and a 37 percent decrease in total crashes at 35 intersections that were converted from traffic signals to roundabouts. Studies of intersections in Europe and Australia that were converted to roundabouts have reported 41-61 percent reductions in injury crashes and 45-75 percent reductions in severe injury crashes.

Because roundabouts improve the efficiency of traffic flow, they also reduce vehicle emissions and fuel consumption. In one study, replacing a signalized intersection with a roundabout reduced carbon monoxide emissions by 29 percent and nitrous oxide emissions by 21 percent In another study, replacing traffic signals and stop signs with roundabouts reduced carbon monoxide emissions by 32 percent, nitrous oxide emissions by 34 percent, carbon dioxide emissions by 37 percent, and hydrocarbon emissions by 42 percent.10 Constructing roundabouts in place of traffic signals can reduce fuel consumption by about 30 percent.9,11 At 10 intersections studied in Virginia, this amounted to more than 200,000 gallons of fuel per year.8 And roundabouts can enhance aesthetics by providing landscaping opportunities." https://www.northamptonma.gov/FAQ.aspx?QID=151

JOURDAIN, Bartley, Rivera_I, Vacon Ordered, that That the Mayor be requested to provide the City Council and CPA Committee a list of historic preservation related repairs needed on city buildings such as City Hall, Wistariahurst, City Hall Annex and other city owned buildings. Apparently, the CPA Committee has no city owned projects to support and is making requests to us for non-city owned projects.

Councilor I. Rivera asked to be added to the order.

Councilor Bartley asked to be added to the order. He then noted that the walls in City Hall chambers were in disrepair and suggested that CPA funds be sought for the repairs.

President McGee stated that CPA funds were not being used for the walls, adding that ARPA funds were

planned for that project. He noted there was a long list of items being requested.

Councilor I. Rivera asked for suggestions for other uses of CPA funds at city buildings.

---> Received and adopted. Referred to the Mayor and CPA.

JOURDAIN, Bartley, Puello Ordered, that That the Mayor and Parks and Recreation department please fund the Spanish Festival with \$5,000 for their staging and sound equipment. This money was allocated for them in the FY 22 budget but was transferred apparently. This has been a very important program the city has supported for many years and we need to continue it now that the pandemic is over with and the event has returned. If there are insufficient funds for some reason in the Recreation dept (originally funded with \$33,000 in staging and events lines) budget then please make a transfer request from another other area up to and including stabilization if need be. The organizers were counting on these funds. This is a small amount of money for an event that brings so much joy to so many thousands of people. Thank you in advance for your support.

MALDONADO-VELEZ Ordered, that That all city council committees take up and act on any order in their jackets/tabled that are dated before February 15th, 2022. Rule 61 of the City Council rules states that "all orders sent to any subcommittee be acted upon (take up, not disposed of) within 45 days".

MALDONADO-VELEZ Ordered, that That we add a city council rule which requires a unanimous vote to continue meetings past 10pm.

MALDONADO-VELEZ, Rivera_I Ordered, that Order that we add a Grant Manager position to oversee, streamline, and expand our grant applications and money for our city.

---> Received and referred to the Ordinance Committee.

MALDONADO-VELEZ Ordered, that Order that we allow for overnight parking on city parking lots for people to sleep in their cars. This would be an added measure in the work already being done to provide a safe, temporary place for our unhoused population until a more long term solution is created.

MALDONADO-VELEZ, Rivera_I Ordered, that Order that we work on expanding the Community Responder Model (see communication) that the Holyoke Police Department is already participating in with local organizations.
