Historic Gravestones Services preserves head stones and stabilizes obelisks. This service was provided to 4 gravestones and 1 obelisk in the cemetery. Olivia provided pictures of the completed work and submitted a bill from Historic Gravestones. Commissioner Jose Bayron made a motion to approve paying the bill and Commissioner Helene Busby seconded the motion.
- 4. Diosdado Lopez Hispanic Family Festival, Springdale Field, July 2022
 Diosdado Lopez requested use of Springdale Field from July 20, 2022 –
 July 26, 2022 for the Hispanic Family Festival. He provided a layout as to how the festival will be set up. He also discussed that local businesses and vendors will be participating in the festival. He will be working with other city departments to obtain the necessary permits.
