President McGee offered a wish of a Happy Anniversary to Admin Asst Jeffery Anderson-Burgos and Councilor Juan Anderson-Burgos, adding that he would be filling the role of the assistant monitoring the Zoom screen.

Councilor Bartley asked for a moment of silence for Gina Letellier, a 7 term city councilor from Agawam who has just passed due to cancer.

President McGee started that Councilor Jourdain was expected to arrive a little late and had made a request to leave the tabled items until he arrived.

Councilor Maldonado Velez asked if it would be the appropriate time to discuss a legal matter that had come up with one of the councilors. He suggested that the public was owed a discourse within the body regarding what happened with Councilor Puello.

President McGee stated that nothing was before the Council to discuss. He then stated that law officials should handle what they have to do, adding that the Council should faith in what they will do to investigate and provide information at a later time. He also expressed agreement with a statement from Mayor Garcia suggested that the authorities should deal with the situation before the city deals with it.

Motion was made and seconded to suspend the necessary rules to take up items 19D and 19E as a package.

UNDER DISCUSSION:

Councilor Vacon stated that the committee recommended installing the signs, adding that they would not require ordinances changes since they were not under state jurisdiction in terms of their status.

President McGee thanked the committee for recommending the sign on Michelle Lane, noting that 18 wheeler trucks had been running through the street impacting trees. He then suggested that mapping software had been one cause of the issue. He noted there wasn't much more that could be done other putting up signs to deter trucks from driving there.

Councilor Bartley noted there had been a similar issue in Ward 3. He then stated that signs had been posted in several areas of that neighborhood, reducing the number of calls he had received.

Councilor Givner asked for clarification of the type of sign being installed.

President McGee stated they were no large truck signs.

Councilor Bartley added that they were to deter no box trucks and 18 wheelers.

Councilor Givner suggested signs discouraging truck drivers from following their GPS instructions, noting that an no exit should have been enough to deter them.

President McGee clarified that it had been the recommendation of the City Engineer.

Councilor Givner asked what the difference was between a no exit sign and a no trucks sign.

President McGee suggested that if a GPS directs drivers onto a street, a no truck sign may be a better deterrent.

Councilor I. Rivera stated he did not understand the purpose of duplicating a service. He expressed that he understood the GPS issue but did not expect that a driver passing a no exit sign would follow a no trucks sign. He also asked what the penalty process would be.

Councilor McGiverin suggested that the purpose was not to be punitive but to address issues with a neighborhood under siege. He then suggested that the direction of Route 202, along with confusion caused by GPS, had been a cause of large trucks passing through neighborhoods. He also emphasized that it was not just about a nuisance, but a real safety issue.

President McGee noted that Michelle Lane had a small cul-de-sac that was being damaged by the trucks.

Councilor Vacon suggested that while too many signs can sometimes be an issue, a couple extra may be

enough to prevent issues from happening. She then referenced a situation in Northampton when GPS caused a truck to drive onto a bike path.

Councilor Maldonado Velez stated that he would oppose the order, noting that the Engineer's report stated that while they could post a sign, MassDOT would not approve a truck restriction that could be enforceable. He also expressed concern that a resident seeing a sign would have an expectation of something that could not be enforced.

Councilor Givner asked what would happen if people had a furniture delivery.

President McGee stated that those deliveries can still happen. He added that the sign would not be designed to stop deliveries.

Councilor Givner suggested that a creative way to address the issue should be considered telling truck drivers that they will not be able to get out of the street.

Councilor Jourdain recalled when the street was built out, the homeowners invested a great deal on their homes, paid their taxes to the city, and deserved to not have trucks damaging their properties. He questioned the need to spend time debating the placement of a simple sign telling truck drivers not to drive there. He stated that they were not looking to give out tickets but to have the city working in a common sense manner to help residents asking for assistance.

Councilor McGiverin noted that many informational signs are posted that are not tied to enforcement measures but would be posted as recommendations to drivers. He also stated that he was in favor of supporting requests sought by ward councilors of a neighborhood.

Councilor I. Rivera noted that the issue was not that he did not want to provide a service. He suggested that there were more important matters that the government should be taking on with a more aggressive approach. He stated that he was not in favor of supporting changes that benefitted a special group but changes that helped all groups whether or not they are taxpayers or anyone who can vote. He suggested that real life issues were being avoided.

Councilor Vacon reiterated that ward councilors are often deferred to when they're representing the interests of the people of their wards.

Councilor Jourdain emphasized that a group of residents came forward and asked for a sign, adding that this is the kind of work that city government does every day. He also emphasized that many special groups come to City Council all the time asking for help, adding that this is the job of representing them. He also suggested that the City Council should be able to handle the big things and little things at the same time. He suggested there was no reasoned argument not to support the people of Michelle Lane.

Councilor Murphy-Romboletti called the question. Councilor Vacon seconded the motion.

Councilor Givner asked to clarify that the sign would be an informational sign.

Councilor Vacon stated that it would be an informational sign.

BARTLEY Ordered, that The City Engineer present a plan to the City council public safety committee to improve lower Whiting Farms Rd for the following conditions: motorists regularly ignore the "no left turn" into the former K-Mart Plaza thus cutting across traffic and motorists do so by angling around the cement barrier which causes potential hazardous driving conditions. Moreover, if motorists do abide by the "no left turn" they often make an illegal U-turn in front of the bay doors at HFD Station 5 that may further negatively impact public safety. Please advise on a best course of action bearing in mind that K-Mart is no longer an ongoing concern today but will be once again. Refer to Mayor, City Engineer and Public Safety.

UNDER DISCUSSION:

Councilor Bartley stated his intent would be to refer item 19I back to Ordinance and have the new order discussed in the Public Safety Committee. He noted that he has received calls for many years to address the issue

Councilor Vacon stated the issue of safety was raised in the Ordinance Committee, adding that the current issue was also of safety. She agreed to take the previous order back into the Ordinance Committee to await any recommendations that may come out of the discussion in the Public Safety Committee.

UNDER DISCUSSION:

Councilor Vacon stated that after a review from the Engineer, he found that a three way stop would not be warranted for the intersection.

Councilor I. Rivera stated that while he was in support of the three way stop, he did not want to go against the Engineer's recommendation.

Councilor J. Rivera stated that driving in the area had been horrible for many years.

President McGee asked if there were any other recommendations other than stop signs.

Councilor Vacon stated that the Engineer's report listed criteria which listed a requirement of 5 or more crashes within a 12 month year period. She added that the report indicated that there had been 2 crashes in a 5 year period. She also noted the report indicated that the standard for traffic volumes had not been met.

President McGee suggested that a coordinated order should be filed to have a broader discussion of addressing these areas where there are traffic safety issues that would not fall within the guidelines to add new signs.

Councilor J. Rivera noted several additional areas in her ward that she had received calls about. President McGee stated there should be another way to address the problem.

Councilor Vacon noted that one of the main issues discussed was lack of enforcement. She also noted that the Police Department used to have a division dedicated specifically to traffic enforcement.

The Committee on Ordinance to whom was referred an order With community support: Create single lane out of two laned one way roads in ward 4 to include:

- -Beach between Hampshire and Hampden Streets

If we are serious about wanting safer streets for our residents we must create deterrents to speeding. By eliminating these lanes and turning them into marked turning lanes, added parking, and additional bike lanes, we will discourage speeding while creating traffic safety through clarity, and additional parking. This would also encourage biking and make our neighborhood streets safer for all who use them have considered the same and Recommended that the order has been complied with.

Councilor Vacon stated that Capt. Moriarty provided feedback stating that police vehicles may used if there is a permitted parade, and a detail is needed for safety. She also stated that under no circumstance can any city vehicle be used for a political purpose under both city ordinance and state law.

Councilor Bartley stated that the order had been filed following a circumstance the previous year. He then stated that he sought a communication from the Law Department to be sent to the City Council and all department heads clarifying the law in order to prevent police vehicles and uniformed officers from driving in a political caravan other than for safety reasons.

Councilor I. Rivera asked to clarify that police detail can still be paid for if there is a parade permit. Councilor Vacon stated that was correct.

Councilor Maldonado Velez noted that local ordinances did not specify political uses and asked for clarification of the relevant state laws.

President McGee stated that the Law Department would be providing a communication clarifying the details.
