- 4) Reports on progress with organization of archives (storage drive), and staff
 - a. More documents continue to be added to the drive. It is disorganized. Meeting scheduled with the mayor and staff from OPED to discuss. Commissioner Aubrey suggests having an intern to assist with organizing.
- 5) Approval of letters of support for MA Historic Rehabilitation Tax Credits
 - a. Farr Alpaca Mill MHC# HLY. 75. Reviewed new addendum to the project and new construction. Chair shared Historic Preservation Certification application.

One (of only two) example(s) of Brutalist, post WWII architecture in Holyoke. Chair wants to write letter to head of OPED expressing support of project.

shows MassWest Services Inc. Sent letter to Holyoke Medical Center requesting information. Chair will follow up on status. Property currently boarded up. Tracking down people involved. Project never happened. No ruling ever made on property during prior historical commission meetings. Awaiting response to letter sent to HMC.

Mas DOT project #609385 – projects brought up by contractual firms. No response equals agreement with the project. Chair wants to review all letters signed and sent by prior chair for Mass DOT projects. Chair drafted response to letter received stating agreement with anticipated project.
