Review & discussion of scope of work was shared on screen. Commissioner Aubrey expressed concerns that a large portion of additional work needed was not addressed in the current proposal. Chair pointed out the allowance of certain changes while maintaining historical significance compliance. Commissioner Salazar questioned the commission's role in determining historical significance compliance. While report was ambiguous, still has questions about how the commission should move forward. Chair explains the process of creating preservation restrictions. Will the renovations proposed, produce a building that is accurately historically significant? Need to confirm that the proposed changes will not negatively impact the historical significance. CPA money makes sure things are done historically accurate. The Commission will forward to CPA, but the questions need to be answered before approving. Can they include several requests of changes to maintain historical integrity per CPA and HHC's request.

11) Discussion on requesting to hire a preservation specialist for the City of Holyoke -

Chair has written to the Mayor explaining the importance of having a preservation specialist for the City. Attorney Degnan has explained to the Chair that the commission will probably be writing their own preservation restrictions for the building. They will not be sent to MHC but for CPA, HHC will be writing them. Chair will continue to push for a preservation specialist to be hired.

- 12) New Business Peter Palombella speaks suggesting the commission create subcommittees. Subcommittee to follow up on preservation restrictions. To be placed on agenda for the December meeting. Chair would like an architect and a lawyer to join the Commission for the December meeting. Chair will create a budget to submit to OPED and maybe go in front of the city council. It's not a good reflection in the City in terms of how valuable the Historic Commission is. Chair reads an email she just rec'd from Meg MCGrath, CPA Chair. explaining that Ed Owen (120 Front St, BBC Steeple) didn't submit an application for approval as the process was confusing. He was ready to present but didn't submit out of frustration & would the HHC be open to him presenting to an upcoming meeting. Chair acknowledges that Mr. Owen emailed her expressing his frustration. Mr. Owen never responded. Chair shares conversation with owner of 120 Front St. Would need additional funds for another hour of time for Tyler Caine to review the project. The Commission will write to the CPA Chair and explain that they no longer have the consultant, and it is past the deadline. They are not willing to review the other projects.
- 13) Old Business Commissioner Gauthier asks who the CLG liaison is. Chair introduced Jennifer Keitt. The Commission feels that someone from the Commission should be the liaison to the MHC for the CLG. The liaison receives all the correspondence from MHC and can send information and communicate with the commission. A Commissioner can have the right and distribute all MHC correspondence directly to the Commissioners.
