 - a. Review of scope of work for 106-120 High Street for future preservation restriction agreement -

Bill Womeldorf screenshared updates since the last meeting and discussion topics included: In-Fill of existing rear openings, removal of existing incinerator chimney; existing parge on rear facade; and construction of rear balcony.

b. Discussion on late applications -

Chair suggests an online platform for submission of applications with a finite deadline.

c. Discussion on requiring applicants to have a professional consultant for grants over \$50,000. -

Due to the specific recommendations and amount of documentation to apply, grants over \$50k should have a professional consultant assisting them in the application process. The Commission might consider offering workshops to educate people about the CPA process. Speaking with the Holyoke Taxpayers Association (HTA) to explain CPA process and historic grants was suggested.

3) Vote on historical significance for 348 Chestnut-48-52 Franklin Street MHC# HLY 1102 -

Building was never determined to be historically significant prior to applying for CPA funding.

4) Discussion of New sidewalks for the Hadley Fall Company Housing National Historic District -

Peter Palombela of Hadley Falls Housing, spoke of City Councilor Rivera's introduction of an order (City Council Meeting November, 2022), to redo sidewalks in the flats. Sidewalks around the Hadley Fall Company Housing National Historic District are dangerous and not properly handicap accessible. DPW was unaware of the historical nature of brick sidewalks. Multiple organizations were involved in an email chain discussing the sidewalks and a community meeting was recently held at the Flats Community Center. The building in question has a preservation restriction and is a national historic district but the sidewalks belong to and are the responsibility of the city. The city should be held responsible to restore in a way that is historically mindful. Preservation restriction shared on screen. Suggestion made that the owners of the buildings should organize. Chair will write to the City Engineer and DPW explaining the delicacy of the situation and ask that work not be done on the sidewalks until the commission has had an opportunity to explore the proper way to do it and see if funding is available. Chair will discuss preservation restrictions with the Legal Dept. Peter Palombella represents the Friends of the Hadley Falls Company housing district (18 members). There are 34 property owners total. This is not the first time that these sidewalks have been targeted for overhaul. Many neighbors continue to be concerned.
