24-915	Transdev Services, Inc. ("Transdev") contracted with the City of Jackson for the provision of transportation services. The contract ended on December 31, 2023. Heading into the end of the contract, the parties engaged in informal negotiations regarding the settlement of contract close-out costs and the City continues to withhold from payment Transdev's final invoice for December Fixed Route Service. When the City refused to engage in good faith negotiations, Transdev initiated the formal dispute resolution process called for by the contract, but the City has refused to respond. As such, Transdev respectfully submits this request for public records. First, as a recipient of federal funding, the City is required to notify the Federal Transit Administration (FTA) of all disputes. Transdev requests any and all records in the possession of the City, its officers, agents and employees indicating the City has notified the FTA of Transdev's dispute as required by FTA Circular 42201.F. Second, Transdev disputes certain findings of the Fleet Turnover Audit Report conducted by Vehicle Technical Consultants, Inc. (VTC) on behalf of the City. Specifically, in several instances, VTC assumed the cost of parts rather than using actual values, and estimated excessive labor hours to complete repairs. Transdev communicated the errors in the audit report to the City's Deputy Director of Transportation on January 5, 2024, but Transdev did not receive a response. Transdev requests any and all records in possession of the City, its officers, agents and employees, to include, but not limited to work orders, invoices, and payment showing the amounts charged by and paid to the new contractor, MV Transportation. Transdev requests the records show all the actual repairs made and the actual costs for parts and labor associated with repairs as a result of the Fleet Turnover Audit.
