This request is made pursuant to the relevant state and federal public records laws, including the Freedom of Information Act (FOIA) or other laws applicable in the state of Mississippi. The wording and issuance of this warrant is based on false information, lacking credible evidence, and is a direct violation of my Fourth Amendment rights against unreasonable searches and seizures. Furthermore, despite my attempt to resolve this matter Sgt. Jordan who knows I have not been questioned about this auto theft and without probable cause still issued it. This warrant has also led to the constant improper use of my name and likeness in advertisements listing him as the City of Jackson's Most Wanted. These defamatory advertisements have been featured on social media and local news media, severely damaging my reputation and character. I am challenging the validity of this warrant and holding Sgt. Jordan accountable for knowingly acting improperly in this matter. Her actions have not only been legally unjustified but also demonstrate a clear abuse of power that has resulted in significant harm to me, my parents and grandmothers. I am demanding that these defamatory advertisements be immediately ceased until this matter is fully resolved. Continuing to feature me in such advertisements while the legality of the warrant is in question is both unjust and a further violation of his rights and hurts the people I love. To support the legal challenge to this warrant, I am requesting the following documents: The affidavit submitted by Sgt. Jordan to obtain the warrant. Any communications, internal memos, or notes related to the investigation. All evidence or lack thereof that was used to support the warrant application. All evidence or statements that have been publicly disclosed or are legally accessible to the public. Records of any internal reviews or discussions concerning the issuance of this warrant. Documentation of any judicial review or approval process for the warrant. Any communications related to the decision to list me as the City of Jackson's Most Wanted. Please provide these records promptly, as I intend to use them to pursue all available legal remedies against those responsible for this egregious misuse of power. If there are any fees associated with this request, please inform me before processing via email. Additionally, please be advised that I will be forwarding a copy of this letter to the Internal Affairs Division to launch an investigation into Sgt. Jordan's actions. Her decision to proceed with the warrant despite my previous cooperation and the lack of evidence raises serious concerns about her conduct and the integrity of this investigation and others she may handle.
