CALL STATS

Since October 1, 2023 Jackson Fire Department responded to 10,492 fire and emergency medical alarms.

- Medical 5,200
- Fire 4,800
- Other 500



NOTABLES

- JFD partnered with the City Attorney Office to implement a Cost Recovery Program aimed to generate approximately \$500,000 annually.
- JFD Office of Fire Marshal completed 2,400 fire inspections resulting in the collection of fees to total \$117,945
- Jackson Fire Department seeks to raise salaries of all fire personnel to be comparable with other local Public Safety entities

BUDGET

The department's current budgeting level is \$24,250,475 of which 93% is for personal services and 7% is for operational needs.

Overtime still proposes a challenge but we are working to curtail it by:

- Enhancing job recruitment through job fairs and different hiring platforms (FB, IG, Posters, TV, etc.)
- Conducting on the job training to new FFI trainees before allowing them to attend the MSFA (MS State Fire Academy)
- The department is continuing to promote in the ranks of District Chiefs, Captains, Relief Driver Operators and Firefighter II's



EXTERNAL FUNDING

- Jackson Fire Department's budget is supplemented by the Fire Rebate Fund commonly referred to as Fund 10-Fire Protection and is primarily used to fund the department's master lease program for the purchase of new fire engines. The amount is received from the Mississippi Insurance Department and is based on the insurance rate. The department is estimated to receive \$993,021 in late August 2024.
- JFD collaborated with the City of Jackson Planning Department to secure funds to purchase equipment and supplies with the Community Development Block Grant funding commonly know as CDBG. The cost of this project is \$887,420.

CAPITAL IMPROVEMENT PROJECTS

Completion of Fire Station 20

This project equaled to \$3,080,000 funding sources were as follows:

- Community Development Block Grant -\$2,320,000
- MS Insurance Rebate Fund (Fund 10)- \$760,000



CAPITAL IMPROVEMENT PROJECTS CONTINUED

The department is slated to progressively rehab Fire Station 7 and Fire Station 23 with Community Development Block Grant (CDBG) funding.





JFD BUDGET REQUESTS

In order to utilize our funding in the most effective and efficient method we propose additional funding to the following lines:

- Motor Vehicle Repair
- Travel
- Uniforms
- Supplies
- Matching Grant Funds

JFD BUDGET REQUESTS PURPOSE

- Motor Vehicle Repair need added funding to cover surge in pricing for vehicle repairs and maintenance
- Travel will require extra funding for entry level personnel to travel for mandatory training courses
- Uniforms need extra funding to cover costs to purchase uniforms for all fire personnel to comply with uniform standards
- Supplies will require additional funding to keep up with rising cost of inflation
- Matching Grant Funds will be applying for grant funding that may require a match

JFD BUDGET REQUEST FUNDING

The following JFD budget requests will be funded from Other
