This accident occurred at the intersection of Greenway Drive and Highway 18 and was investigated by Officer Larry M. Perry, Badge number 1351. Please see the attached Crash Report form given to our client at the accident scene. The crash report given to our client at the scene of the incident was very bare with specific information. Per our client, Kiara Evans, was traveling west on Hwy 18 in the outside lane and had a green light and while proceeding thru the intersection of Hwy 18 and Greenway Drive, the Defendant who was traveling in the opposite direction attempted to turn onto Greenway Drive and T-boned Kiara Evans, colliding into the driver's side of her vehicle, spinning her car around and into another vehicle that was stopped at the light on Greenway Drive. We have made numerous telephone calls to the Records Division, Precinct One, and Captain Hodges with the Traffic Division. We ultimately reached out to Chief Wade's office for assistance after no return calls or assistance was received from Captain Hodges, the Traffic Division, or Records Division. It is our understanding that one of the clerks in Chief Wade's office also sent follow up emails to the Traffic Division and Precinct One requesting assistance on our behalf.
