DISCUSSION: BRIEFING ON HOMICIDES AND THE JACKSON POLICE DEPARTMENT: President Priester recognized Dr. Robert Blaine, Chief Administrative Officer, who provided Council with an overview of the Administration's comprehensive efforts to reduce crime. Dr. Blaine stated external funding had been obtained to aid in the implementation of the three (3) component strategy to reduce crime citywide. The three (3) component strategy discussed includes the following:

- 1) Policing Programs
 - o Real-time Crime Center
 - o Body Cameras
 - o Community Policing
 - o Data-driven decisions
- 2) Conflict Resolution Programs
 - o Conflict Interruption
 - o Credible Messenger
- 3) Occupational Opportunity Programs
 - o Access Centers
 - o Community STEAM (Science, Technology, Engineering, Arts & Mathematics) Centers
 - o Universal Pre-K
 - o Jackson Meals Matter

President Priester recognized James Davis, Chief of Police, who provided a brief overview of Policing Programs. Chief Davis stated that certain crimes are difficult to police and JPD is implementing community policing. Chief Davis stated the following:

- Real time crime center will allow cameras to be installed throughout the city in efforts to monitor activities throughout the community.
- Operation Safe Street allows officers the ability to set up check points to engage with the community.
- Operation Safe Shop allows officers the ability to be visible for citizens during the holiday shopping season.
- Conflict resolution classes are offered for the communities.
- Violent Crime Task Force is currently in the communities.

Deputy Chief Tina Wallace of Administrative Support Services provided a brief overview of resources/programs offered to better serve communities. **Deputy Chief Wallace** stated the City currently has 350 sworn officers and a recruiting team has been developed in an effort to go to colleges and universities, inside and outside the Metro area to recruit more officers.

Deputy Chief Deric Hearn of Major Investigations stated that the City's C-Spire unit has researched over 2,000 guns and there are programs within the department that are working to address violent crimes. In 2018, ninety-two (92) cases were worked involving felony firearms.

President Priester recognized **Rukia Lumumba**, a representative of the People's Assembly, provided information regarding Conflict Interruption and Credible Messenger programs within the City of Jackson. **Ms. Lumumba** said that the program targets high crime areas and proposes solutions.
