**RESOLUTION OF THE CITY COUNCIL OF JACKSON, MISSISSIPPI
RECOGNIZING AUGUST 28, 2017 AS EMMETT LOUIS TILL DAY.**

WHEREAS, Emmett Louis Till became a monument of the Deep South’s oppression within the State of Mississippi when he was brutally beaten and murdered on August 28, 1955. Emmett Till’s face still rings out in our minds, as Ms. Mamie Till held an open casket public funeral to “show the world what they did to my baby”; and

WHEREAS, the brutal death of Emmett Till gave urgency to and served as a catalyst for the civil rights movement; and

WHEREAS, the story of Emmett Till has been told countless times. His unjust killing was only one of many during that era and it still holds relevancy to this day, with the latest unjustified and unpunished public murders of young black boys; and

WHEREAS, Emmett Till's story will continue to be a reminder of what one must overcome to progress as a nation as old rhetoric continues to die off. The City of Jackson, Mississippi would be remissed not to show support to the Till family as they continue to fight for justice, as they have been doing for the past 62 years; and

WHEREAS, August 28th has traditionally been a time when the Emmett Till Legacy Foundation, Mamie Till Mobley Memorial Foundation, relatives, and civil rights activists have gathered at the grave of Emmett Till at Burr Oak Cemetery in the suburbs of Chicago to commemorate his life and tragic death; and

WHEREAS, decades ago the City of Memphis Mayor Herenton proclaimed several days in August as Emmett Till Days; and

WHEREAS, various ceremonies and events are held throughout the United States in observance of the death of Emmett Till.

THEREFORE BE IT RESOLVED that the City Council of Jackson, Mississippi joins other governing authorities, agencies, and organizations around the country by recognizing August 28, 2017 as Emmett Louis Till Day.

SIX (6) CITIES WILL SHARE A TOTAL OF \$445,000 IN GRANT AWARDS. WHEREAS, United States Conference of Mayors (USCM), in partnership with the American Beverage Foundation for a Healthy America (ABFHA), has launched the 2018 Childhood Obesity Prevention Grants Program, to support both new and existing programs initiated by USCM member mayors, that addresses the childhood obesity epidemic city-wide; and

WHEREAS, to receive these funds the City of Jackson, Department of Parks and Recreation submitted the application for the USCM-ABFHA 2018 Childhood Obesity Prevention Awards Program on or before August 18, 2017. Six (6) cities will share a total of \$445,000 in grant awards; and


