DISCUSSION: LITIGATION MATTERS: Vice President Barrett-Simon recognized **Chris Pomeroy**, President of AquaLaw, PLC, who provided Council with a litigation update of City's appeal to the West Rankin Utility Authority's State issued permit to construct a new wastewater facility on the opposite side of the Pearl River. That permit being the key element of any departure of the wholesale customer from the existing regional treatment facility and regional arrangement at the Savannah Wastewater Treatment facility. **Mr. Pomeroy** stated that the Environmental Quality Permit Board conducted a two (2) day formal hearing on September 1-2, 2015 and the board voted 6 to 1 to affirm its earlier vote of 7-0 to move forward with issuing the permit to the West Rankin Utilities Authority 20 million gallon per day facility to be built in Rankin County. **Mr. Pomeroy** stated that further litigation strategies and possible settlement would have to be conducted in Executive Session.
