- 1. Parking meters should not be enforced from the hours of 11:00 a.m. 2:00 p.m., Monday Friday.
- 2. Downtown restaurants and retail merchants can validate parking garage tickets so that patrons can park for 90 minutes, free of charge between 11:00 a.m. 2:00 p.m. and 5:00 p.m. 9:00 p.m. The restaurants would bear the expense of making validation stamps.

3. Hourly working making less than \$15.00 per hour be given a substantially discounted parking rate of \$10.00 per month and be granted the right to park on the top floor only of JRA parking facilities. Employees would have to bear the cost of printing stickers that designate them as "Top Floor Only" parkers.

Council Member Priester asked if the City had a current contract. Kishia Powell, Director of Public Works, stated that the City does not have a current contract, the Department of Public Works handles meter maintenance and collection from the meters and Special Enforcement Division of the police department handles enforcement. Ms. Powell stated the current collection of fees is \$63,981.82 and the \$128, 671.44 was collected for the FY 2013-14.

ORDER AUTHORIZING THE MAYOR TO EXECUTE A MEMORANDUM OF UNDERSTANDING WITH THE MISSISSIPPI LEARNING INSTITUTE OF JACKSON STATE UNIVERSITY.

WHEREAS, the Mississippi Learning Institute of Jackson State University (hereinafter "MLI") is designed to revitalize the role of leaders, design university-based cultures of innovation and collaboration, and advance a new narrative for boys and young men of color by providing program assistance and capacity building in conjunction with various partners; and

WHEREAS, MLI and the City of Jackson (hereinafter "City") through its Early Childhood Development Program will work together to provide instructional services, support programs and professional development training for caregivers and parents working with young males of color in three (3) Early Childhood Centers, under the auspices of STARS "Sisters Teaching and Raising Sons" program; and

WHEREAS, these program of activities will provide interventions for students, parents, and caregivers to enhance learning experiences for academic, social, emotional, well-being of preschool students; and

WHEREAS, a memorandum of understanding (MOU) is needed to provide for the understanding and intentions of MLI and the City with respect to the provision of instructional services, support programs and professional development training for caregivers and parents working with young males of color in three (3) Early Childhood Centers, under the auspices of STARS "Sisters Teaching" and Raising Sons" program; and

WHEREAS, pursuant to this agreement between the City and MLI, neither is committed to spending or allocating any funds, making recommendations for funds allocation or spending, or requesting the allocation or disbursement of funds. All expenditures will conform to Mississippi law, including the requirements of any applicable procurement or employment procedures. Both Parties agree to keep records of this collaboration and agree to disclose to the other records directly related to the agreement at reasonable times based on upon the request of the other party; and

WHEREAS, this agreement shall be governed by Mississippi law, and it may be terminated by either party upon a 60 day written notice after delivery to the other party; and

WHEREAS, the best interest of the City would be served by authorizing the Mayor to execute an MOU with Jackson State University related to the City's participation with the MS Learning Institute (MLI).

WHEREAS, the cost of each session to be provided by Edelia Carthan, PhD is six hundred and forty dollars (\$640.00), with a total amount of three thousand two hundred dollars (\$3,200.00); for the provision of all five sessions.

IT IS HEREBY ORDERED that the proposal of Southern Insurance, LLC, to provide specific excess workers' compensation coverage for employees of the City of Jackson during the period April 1, 2015, to April 1, 2016, at a rate of 0.2920 per \$100 of payroll be accepted. The aforementioned rate computes to an annual premium of \$203,007.00.

The policy covers workers' compensation claim involving employees of the City of Jackson (City) as follows:

- Claims less than \$750,000: The City pays all benefits from its workers' compensation fund as a Self-Insurer. Note: this Self-Insurer Retention (SIR\_ amount applies to all City employees except firefighters and sworn police officers.
- Claims that exceed \$750,000: The insurer (Safety National Casualty Corporation) pays all workers compensation benefits up to the maximum allowed by the Mississippi Workers Compensation Law. Note: This applies to all City employees except firefighters and sworn police officers.
- Claims less than \$1,000,000: The City pays all benefits from its workers' compensation fund as a Self-Insurer. Note: This SIR amount applies to all firefighters and sworn police officers.
- Claims that exceed \$1,000,000: The insurer (Safety National Casualty Corporation) pays all workers' compensation benefits up to the maximum allowed by the Mississippi Workers Compensation Law. Note: This applies to all firefighters and sworn police officers.

IT IS FURTHER ORDERED that this coverage may be renewed for three additional years at the same cost, or lower, if it is mutually agreeable to both parties.

ORDINANCE OF THE CITY COUNCIL OF JACKSON, MISSISSIPPI AMENDING JACKSON CODE OF ORDINANCES CHAPTER 2, ARTICLE III, DIVISION I, SECTION 2-168. - CITY EMPLOYEE WAGE REQUIREMENTS.

WHEREAS, Section 21-19-9 of the Mississippi Code Annotated (1972, as amended) has empowered the Jackson, MS City Council to set the salary of compensation for every officer or employee of the City of Jackson, Mississippi (hereinafter "City"); and

WHEREAS, Chapter 2, Article III, Division I, Section 2-168 of the Jackson Code of Ordinances currently reads as follows:

#### Sec. 2-168. City employee wage requirements.

Unless contrary to federal, state or local law:

- (1) Effective October 1, 2014, minimum hourly wage for city employees shall be \$8.75.
- (2) An annual incremental hourly wage increase of \$0.95 shall be made for two consecutive years and shall be made effective at the beginning of each fiscal year as follows:
  - a. Beginning October 1, 2015, the minimum hourly wage for city employees shall be \$9.70.
  - b. Beginning October 1, 2016, the minimum hourly wage for city employees shall be \$10.65.
- (3) Each city employee shall certify to the city personnel department that the employee will be compensated at a rate of pay not less than the minimum hourly wage in effect, as set forth by this section.

WHEREAS, it is the desire of the Jackson City Council to amend said Ordinance to exclude from the requirements participants of the 2015 Mayor's Summer Youth Employment Program (hereinafter "MSYEP"); and

**WHEREAS**, the Mayor's Summer Youth Employment Program budgeted to hire three hundred (300) participants at the pay rate of \$7.25 per hour; and

WHEREAS, application of JCO Section 2-168 to the participants of the 2015 MSYEP will cause(1) a decrease in the number of participants from three hundred (300) participants to two hundred and thirty (230) participants and (2) result in unequal pay amongst participants performing the same or similar tasks for different approved wage amounts; and

WHEREAS, the source of funding for the MSYEP wages will be provided from two different sources: the general fund and grant awards; and

WHEREAS, those MSYEP wages expended from the general fund will be set at a rate of pay of \$8.75 per hour, however, the source of funding for those MSYEP wages provided from grant awards will be subject to the terms of the subject grant awards which are set at a rate of pay of \$7.25 per hour; and

WHEREAS, the result would be unequal pay amongst the 2015 MSYEP participants performing the same or similar tasks for different approved wage amounts; and

WHEREAS, the amendment will provide for an equal pay rate for all participants of the 2015 MSYEP set at the pay rate of \$7.25 per hour.

**THEREFORE, BE IT ORDAINDED** that the City Council of Jackson, Mississippi, hereby amends the Jackson Code of Ordinances, Chapter 2, Article III, Division I, Section 2-168, entitled City Employee Wage Requirements to exclude the participants of the 2015 Mayor's Summer Youth Employment Program, to read as follows:

### Sec. 2-168. City employee wage requirements.

Unless contrary to federal, state or local law:

- (1) Effective October 1, 2014, minimum hourly wage for city employees, excluding participants of the 2015 Mayor's Summer Youth Employment Program, shall be \$8.75.
- (2) An annual incremental hourly wage increase of \$0.95 shall be made for two consecutive years and shall be made effective at the beginning of each fiscal year as follows:
  - a. Beginning October 1, 2015, the minimum hourly wage for city employees shall be \$9.70.
  - b. Beginning October 1, 2016, the minimum hourly wage for city employees shall be \$10.65.
- (3) Each city employee shall certify to the city personnel department that the employee will be compensated at a rate of pay not less than the minimum hourly wage in effect, as set forth by this section.
