WHEREAS, Section 21-19-11 of the Mississippi Code as amended provides that a governing authority shall conduct a hearing to determine whether property or parcels of land located within a municipality is in such a state of uncleanliness as to be a menace to the public health, safety and welfare of the community; and

WHEREAS, Section 21-19-11 of the Mississippi Code as amended sets forth the procedure for mailing and posting notice of the hearing; and

WHEREAS, hearings were held on November 17, 2020; and

WHEREAS, the hearing officer determined that notice was provided in accordance with Section 21-19-11 prior to the hearings; and

WHEREAS, after hearing testimony and reviewing evidence, the hearing officer made findings and recommendations for adjudication concerning certain parcels as follows:

1) Case #2020-1263: Parcel #573-428 located at 1701 SHEFFIELD DRIVE: No appearance by owner or an interested party. Hearing officer recommends that the property be adjudicated as a menace to public health, safety and welfare with assessment of actual costs and a penalty of \$500.00. Ward 1

Scope of Work: Board-up and secure house and cut grass, weeds, bushes, saplings, fence line, and remove trash and debris, tires, tree parts and clean curbside.





This Golf Facility Use Agreement ("Agreement") is entered into on the _____ day of <u>December 2020</u> by and between <u>LEAP</u>, <u>Inc.</u>, a 501(c)(3) nonprofit corporation, doing business as <u>First Tee – Central</u> <u>Mississippi</u> ("Chapter") and the <u>City of Jackson</u>, a municipal corporation ("Owner") as owner of the golf facility described on <u>Exhibit A</u> attached hereto ("Golf Facility").

The term of this Agreement shall be effective from the date of execution of this Agreement and shall continue until <u>December 31, 2021</u>. Owner may terminate this Agreement upon three months written notice prior to the end of the initial term or any renewal term, in the event of the Chapter's default hereunder or in the event that the Golf Facility is sold or operations are transferred to another entity.

It is agreed that Owner will provide use and access to the Golf Facility to Chapter participants in accordance with the minimum access and program use requirements of PGA TOUR First Tee Foundation, specifically as follows:

- In cooperation with the Owner, the Chapter will provide and administer golf instruction and/or classroom instruction incorporating First Tee's Life Skills Experience curriculum
- Chapter and Owner will specify and agree upon any and all golf instructors employed by the Chapter.
- Chapter will be responsible for the screening, employment and training of all of the Chapter's employees, including the golf instructors.

- The Chapter and all Chapter golf instructors shall be responsible for the supervision of the participants and shall ensure the safe and respectful use of the Golf Facility by all persons accessing the same under this Agreement.
- Owner will also provide range balls at no charge and free use of the range and practice facility
- Owner will also provide up to sixteen (16) rounds of golf at no cost for each qualified Chapter participant wishing to obtain certification under First Tee's curriculum.
- Chapter and Owner will cooperate to host events in accordance with course availability.
- Green fees for non-certification rounds played by Chapter participants will be set at an appropriate discounted price as agreed by the parties. These fees will be paid by the participants before play or otherwise subsidized by the Chapter or a third party.

The parties expect that the foregoing minimum criteria will likely be exceeded as the parties work together to impact the lives of young people through the game of golf and its values.

- Chapter and Owner will specify and agree upon the hours of operation and use by the Chapter in which the above-described access and use criteria are to be satisfied, and cooperate on all other program and operating matters under this Agreement.
- In determining reasonable access and use, the parties will adhere to First Tee's access guidelines of fully integrating Chapter participants' use into the rhythm of play of the other patrons at the Golf Facility, which means balancing the need for Owner to exclude use by Chapter participants at time of high public use with reasonably convenient times for young people.

 Owner retains the final authority in the event of any dispute as to specific hours of operation or use of the Golf Facility by the Chapter hereunder.

Each party (the "Indemnifying Party") agrees to indemnify, defend and hold the other party and the other party's respective directors, officers, employees and agents (the "Indemnified Party") harmless from and against any and all expenses, damages, claims, suits, actions, judgments, and cost including reasonable attorney's fees, arising out of or in any way connected with the negligent, grossly negligent, reckless, or intentional acts or omissions of the Indemnifying Party, except for claims based upon the Indemnified Party's negligence or misconduct. The terms of this paragraph shall survive the termination of this Agreement.

Chapter shall, at Chapter's expense, obtain and keep in force during the term of this Agreement a policy of combined single limit, public liability, bodily injury and property damages insurance insuring Chapter against any liability arising out of the use of the Golf Facility by the Chapter and all Chapter participants, instructors, employees, officers, agents, contractors, representatives, and invitees. Such insurance shall be a combined single limit policy in an amount no less than One Million (\$1,000,000) Dollars, which insurance shall name Owner as an additional insured. The limits of said insurance shall not, however, limit the liability of Chapter hereunder. In addition to the foregoing, Chapter shall, at Chapter's sole expense, obtain and keep in force during the term of this Agreement a policy of workers compensation insurance covering all Chapter employees who shall work on the Golf Facility.

Neither party may assign its rights under the agreement without the express written consent of the other party. This Agreement shall be governed by <u>Mississippi</u> law and binding upon and inure to the benefit of the Chapter, Owner, and their duly authorized successors and assigns.

This Agreement shall not be modified or amended except by a writing signed by all parties. This Agreement constitutes the entire agreement of the parties and supercedes and all prior written and oral agreements and understandings related to the subject matter herein.



This Memorandum of Agreement establishes the terms under which Christians in Action, Inc. and Jackson Police Department will collaborate for The Children's Advocacy Center. Specifically, Jackson Police Department will provide referrals and participate in the Multidisciplinary Team meetings. Our goal with The Children's Advocacy Center is to provide a safe, child-friendly environment for children to tell what has happened to a trained forensic interviewer. It is the goal to create a multidisciplinary team that will include but not be limited to: law enforcement, victims and family advocates, medical and mental health, as well as Hinds County Youth Court to eliminate potential trauma as a team, with goals of justice, and helping children and families heal and gain closure of their trauma.

On Friday, November 13, 2020, Deputy Chief Deric Hearn was provided with a Memorandum of Agreement for the Jackson Police Department to enter into with the Christians in Action, Inc. for the purpose of establishing a mutual framework to collaborate comprehensive services to victims of abuse in our Children's Advocacy Center.

A signed agreement have been sent to all prior Multi-Disciplinary Teams and a Court Order from Judge Hicks authorizing the establishment of a Hinds County Multi-Disciplinary Team and agencies and individuals who are to comprise the Team is currently being processed to serve Hinds County.

Janice Wilder the Executive Director with Christians In Action, Inc. agency has been licensed by the MS Child Protection Services. The MS Child Protection Service has provided shelter for abused and neglected children since 1977. Located in the City of Jackson, the agency serves over 120 children each year and they will now bring a Children Advocacy Center that will be located in Hinds County. Through their program they will be conducting forensic interviews for children who have been sexually and physically abused.

The attached agreement is being requested to be signed so that the Jackson Police Department will be in partnership with Christians In Action, Inc. In this memorandum, I have provided you with the past responsibilities of both parties being the Parker Children's Center (180 Country Place Parkway, Pearl, Mississippi 39208 and the Jackson Police Department). I am requesting City Legal to inquire what our agency responsibility will be with this new agreement or will those agreements be provided later through Judge Hicks and the new Multi-Disciplinary Team.

The Children Advocacy Center goal is to provide a safe, child-friendly environment for children to tell what has happened to a trained forensic interviewer. Christians In Action, Inc. Children Advocacy Center will:

- Be the primary entity that will conduct forensic interviews of child victims and child witnesses utilizing a nationally recognized model for forensic interviewing;
- Provide the family with victim advocacy services;
- Ensure the non-offending caregiver has a victim's compensation packet and the victim bill of rights;
- Provide a team member to facilitate the Multidisciplinary Team (MDT) meetings;
- Make referrals for a forensic medical exam, if the referral has not already been made;
- Conduct assessments and provide referrals for services addressing the needs of the child and non-offending caregivers; and
- Make referrals for evidence based therapy services, if determined it is necessary and ensure appropriate services are provided no matter the family's ability to pay.

The Jackson Police Department primary goal on the Multidisciplinary Team (MDT) is to conduct criminal investigations of alleged crimes that impact the safety of the community and the well-being of any child who may have been victimized. This responsibility includes interviewing the family, offender, and other witnesses; gathering of evidence for the prosecution; recommending whether and when to arrest the offender; and providing protection during the intervention process. The Jackson Police Department will;

- Begin the investigative process be receiving a Law Enforcement referral from Department of Child Protection Services (DCPS) or by the victim and/or caregiver filing a report with the Jackson Police Department;
- Cross report to Department of Child Protection (DCPS) any child abuse cases reported initially to Law Enforcement
- Determine if the crime is within their jurisdiction and meets the statutes of a felonious case;
- Ensure the child receives a proper medical evaluation pursuant to the statewide medical protocol regarding when and where medicals should take place;
- Refer the child (if the abuse allegations are potentially felonious) for a forensic interview at Christians in Action.
- Attend forensic interviews of children whose crime occurred within their jurisdiction and participate in the pre-interview and post-interview meetings;
- Investigate all potentially felonious crimes against children;
- Complete their file and submit it to the District Attorney's office;
- Testify in court proceedings as needed; and
- Attend Multidisciplinary Team (MDT) meetings and discuss investigations.

A copy of the agreement that will require a signature is attached to this memorandum so that the Jackson Police Department will be in partnership with the Christians in Action as they move forward with this important service.

Who We Are

TEL Y

Our agency currently serves as a temporary placement for children in the custody of the Mississippi Child Protection Services. We have been located in Hinds County since 1977 and are licensed through the Mississippi Department of Child Protection Services. Children are referred to our shelter either through the MDCPS or Mississippi Youth Court. We are a forty-five-day shelter for children to be placed at while a more permanent option is sought out whether it be reunification with the parents, a foster home, facility, or another form of safe placement for the child. While the child is here, they receive dental exam, eye exam, TB skin test, physical, and psychological evaluation along with any other medical need they might have, and access to education while at our shelter. We also provide on-site therapy via our Licensed Clinical Social Worker who does one-on-one therapy and group therapy with the children. Through our work with abused and neglected children, we have recognized the importance and need of multidisciplinary teams and Children's Advocacy Centers which is why we have decided to approach application to become a Children's Advocacy Center.

Population

The existing CAC that is located in Rankin County no longer has an agreement with Hinds County. We are seeking to become a CAC that is not only located in Hinds County but also only serves the victims and families of Hinds County. According to the United States Census there are approximately 88,705 households currently claiming residency in Hinds County and nearly 24% of the entire population of Hinds County are minors under the age of 18. For this reason, we believe that it is reasonable and necessary to have one Child Advocacy Center solely dedicated to the victims and families of Hinds County. At our Children's Advocacy Center, our mission will be to meet the needs of child victims and their families by providing a safe, child friendly environment and a family centered approach to creating a multidisciplinary team aimed at helping the children and families from all perspectives of care in hopes to help victims and families find justice and healing.

Needs Assessment

Over that past three years, Christians In Action, Inc. has provided shelter for 351 abused and neglected children. Of just the 351 children that have come to our shelter, nearly 42% were in custody due to known physical or sexual abuse. This number does not even touch the children that have come through our shelter who have endured this type of abuse unbeknownst to us or their social workers. According to the Child Welfare League of America, Mississippi had 10,429 victims of abuse or neglect in 2017, of which nearly 1,170 children had been reported to be sexually abused and 1,543 had been physically abused. In the same year, Children's Advocacy Centers across the state of Mississippi served 3,473 children; in 2019, the number of children served by Mississippi Children's Advocacy Centers was 4,539. We believe that with the establishment of a Children's Advocacy Center in Hinds County that solely serves Hinds County, we will be able to help countless children and families find healing, justice, and hope.

Facilities

While Christians In Action, Inc. will be the sponsoring agency for this CAC, the shelter and CAC will remain separate entities; they will, however, be located on the same property but in separate facilities. Our new CAC, just as our Emergency Shelter, will be located right outside of the capital city of Mississippi and is near the center of Hinds County which makes it easily accessible to the families we intend to serve. We have planned to build a new building that will house our CAC and will be designed to fit the specific needs of a child advocacy center facility and provide a safe and child friendly environment that is also equipped for efficiency and cooperation with our multidisciplinary team. We intend to have child friendly interview rooms where the forensic interviews will actually take place; we will be equipping these rooms with recording devices so that each interview sthe child must go through and thereby reducing the risk of retraumatizing the victims. There will also be rooms set up large enough for our multidisciplinary team to meet and view the interview while it is in progress. This will ensure adequate discussion among team members is available so that we can ensure the best options of care and resources are discussed and made available to the victims and families. We will also have a separate room for non-offending family members to wait and discuss their options and resources with our Victim and Families Advocate while the forensic interview of the child is taking place. This will allow the families a private place to process what is being asked of them and their child and for them to be able to ask any questions they may have about the future process.

Services Provided

\$

As with our Emergency Shelter for Children, we intend to file for tax exempt status for our Children's Advocacy Center. At Christians In Action, Inc., we believe every child and family has the right to resources, healing, and justice, free of cost which is why families will not pay a penny for any services received at our CAC. We will be a nonprofit agency with funding coming mainly from grants and donations. At our CAC, our primary service will be our forensic interviewing of the child victim. We also know the struggles and uncertainty so it is our goal to also be able to provide court preparation for families and victims that will help them know what to expect from the court process and for when they actually enter the court room. We will also provide support for the family members and victims and provide them with referrals for off-site medical exams and therapy; however, we will have a Licensed Clinical Social Worker on hand to provide on-site therapy if the families so choose. To avoid potential conflicts of interest, we will be creating agreements with adjacent CACs in the state that we can refer families to if the victim has been, or is currently, a client at our emergency shelter. This ensures that the forensic interviewer, therapist, and other members of the multidisciplinary team begin each case with the child having no prior knowledge or biases of the case.

Staff and Training

As we begin the process of application and establishment of our Hinds County CAC, we plan to begin with one forensic interviewer that strictly works at the CAC. This individual will

also help the agency run smoothly by coordinating the multidisciplinary team and acting as the victim and family advocate. This individual will also be able to provide resources and referrals to victims and families for off-site therapy, in the event there is a conflict of interest with our onsite therapist, and any other needs and services we do not currently provide. The individual will also have assistance from two other employees that will also be trained and certified forensic interviewers. These two individuals will be our Case Aide and our Program Director of the emergency shelter part of our agency that will work with both services of the agency. All three forensic interviewers will be trained in a forty-hour training session that is sponsored by Children's Advocacy Centers of Mississippi. We will also have an on-site Licensed Clinical Social Worker that will be available to provide counseling and therapy to the children and families that come to our CAC. The first forensic interviewer will be the main person that works with our CAC; however, they will still report to the Program Director and all activities will still be overseen by the Executive Director of Christians In Action, Inc. Each member of our multidisciplinary team will also be required to be trained as a multidisciplinary team member for their specific profession and we will hold monthly meetings to discuss cases and techniques.

WHEREAS, on October 27, 2020, the Department of Planning and Development, through its Transit Division, issued Request for Proposals for equipment and voice over internet protocol (VoIP) and internet services for the transportation system; and

WHEREAS, Fuse.Cloud proposed to provide high quality technology service that does not require a sacrifice in personal relationships by installation, equipment, training, and voice and fiber internet telephone services; and

WHEREAS, based on the best value procurement policy, the Transit Division determined that Fuse.Cloud will provide the best value in equipment, installation, training, and voice and fiber internet telephone service, and determined Fuse.Cloud to be the most responsive proposer to the October 27, 2020, Request for Proposals; and

The attached agenda item authorizes the Mayor to enter into an Agreement with Fuse.Cloud for the provision of equipment and voice over internet protocol (VoIP) and internet services for the transportation system at JTRAN.

On October 27, 2020, the Department of Planning and Development, Office of City Planning, Transit Services Division, released a Request for Proposals (RFP) for a contractor for equipment and voice over internet protocol (VoIP) and internet service for the transportation system at JTRAN. The City determined that Fuse.Cloud was the most responsive provider.

ORDER AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH ONSITE LABORATORIES DOING BUSINESS AS LABLINQ FOR COVID-19 TESTING OF CITY OF JACKSON EMPLOYEES

WHEREAS, in March 2020, federal, state, and local emergencies were declared based on the COVID-19 pandemic; and

WHEREAS, the State of Mississippi is considered to be a *red zone* based on the rate of COVID 19 infection; and

WHEREAS, the City of Jackson is situated in Hinds County, Mississippi, which has the highest rate of infection among counties in Mississippi's; and

WHEREAS, the magnitude of the spread of the COVID-19 virus has severely limited the availability of beds within local hospitals; and

WHEREAS, aggressive measures, including but not limited to, mass testing is necessary because the virus can be spread by asymptomatic persons; and

WHEREAS, Section 33-15-17(c) of the Mississippi Code authorizes a municipality to appropriate and expend funds, make contracts, obtain and distribute equipment, materials, and supplies for emergency management purposes and provide for the health and safety of persons; and

WHEREAS, Onsite Laboratories was issued a Clinical Laboratory Improvement Amendments Certificate (CLIA) by the Centers for Medicare and Medicaid Services with an effective date of September 15, 2020; and

WHEREAS, Onsite Laboratories CLIA identification number is 34D2192795; and

WHEREAS, Onsite Laboratories' address is 839 Majestic Court, Ste. 3, Gastonia, North Carolina 28054; and

WHEREAS, the Certificate issued to Onsite Laboratories indicates that it is approved to accept human specimens for the purpose of performing laboratory examinations or procedures at its address and other approved locations; and

WHEREAS, Onsite Laboratories has a mobile testing lab known as LabLinq; and

WHEREAS, Onsite Laboratories represented to the City that its mobile testing lab is approved to conduct testing in all 50 states; and

WHEREAS, Onsite Laboratories and the Administration entered into negotiations regarding the feasibility of providing testing for all municipal employees and also citizens of the City of Jackson; and

WHEREAS, Onsite Laboratories has agreed to provide up to one million (1,000,000,) qpcr tests with the furnishing of same day results for municipal employees and the City of Jackson; and

Agenda Item 37 December 8, 2020 Blaine, Lumumba WHEREAS, Onsite Laboratories will bill the health insurance of employees and individuals given the test; and

WHEREAS, the City of Jackson has a *self-funded* health insurance plan in which a substantial majority of municipal employees are and have become participants because the City is paying 100% of the employees' premiums; and

WHEREAS, United Healthcare serves as the third party administrator of the City of Jackson's plan with claims being paid by the City; and

WHEREAS, the normal costs billed by Onsite Laboratories is \$185.00 per person for specimen collection and lab work; and

WHEREAS, Onsite Laboratories will bill the federal funding source for uninsured testing through the CARES Act for the specimen collection and lab work of COVID testing provided to City employees; and

WHEREAS, the federal government declared that uninsured will not be billed for COVID testing and has created a fund for testing facilities to bill; and

WHEREAS, the public health will be served by the testing of municipal employees, who interact with the public.

IT IS THEREFORE ORDERED that the Mayor shall be authorized to execute an agreement with Onsite Laboratories to provide COVID-19 testing for municipal employees at no costs to the City upon testing.

IT IS FURTHER ORDERED that Onsite will bill the federal government for uninsured testing through the CARES Act for the specimen collection and lab work of COVID-19 testing for municipal employees.
